1. Approval of last minutes

4. Ten's Anniversary

a. It is planned on Sunday, September 25th, 2022

- b. The fee was set for \$125 per person, but all agreed that Tankokai will pay \$25 out of \$125 so, the fee for a participant would be \$100. Possibly Tankokai might pay about \$2500 \$3000
- c. For those VIPs or members for the other association we invite, whether we should pay for the expenses for travel and tickets was discussed. When other organization have this type of anniversary, the invitation was sent out to all the Tankokai and the expenses are paid by the participants. One example was Kurashima Sensei from NY. Anniversary Committee will further discuss who those VIPs are.
- d. Ten's anniversary trip is postponed to March 2023 due to pandemic. Keijiroh is negotiating and will be updating. There are about 7-8 people interested in this trip.

5. Lessons at Shofuso

- a. Currently, no lesson is planned in June.
- b. According to Drew, there may not be any lesson at Shofuso from conversation with Morgan, and Frank. Shofuso is not willing to have us.
- c. According to Sachiko, Shofuso is willing to have us to do lessons.
- d. Frank is planning to speak with Yuka and Kazumi
- e. Keijiroh suggests that (1) it is important for us to continue teaching tea at Shofuso, (2) Drew and Morgan have been teaching at Shofuso for about 10 years and there are now four other qualified tea instructors, (3) all six qualified instructors should be given opportunities to teach. One teacher with an assistant can teach beginners for a series of 5 6 lessons. There may be 3 4 series of lessons, ie in total of 15 24 Saturday lessons per year.
- f. Keijiroh also states that currently two instructors have been working as independent contractors for Shofuso, without any involvement of Tankokai. Tonkokai and Shofuso should have Letter of Understanding, regarding all tea activities with Shofuso, including lessons, monthly demonstrations, First Thursday nights, etc.
