## 4. **Dogu Collection and Storage**: (concern from Annual Meeting)

A. Background: Both LaSalle and Taeko Sensei's donated dogu have been stored at King of Prussia house, which is owned by Sachiko Houck. Previously, the Board investigated other possible commercial storage sites. The main issues are: controlled climate, accessibility, site security and cost. Any commercial site would be expensive. The previous Board agreed to keep the dogu at KOP and pay \$100/month.

B. At the last annual Meeting a question was raised if this was a Conflict of Interest.

Sachiko explained that she is not looking to make money.

Shoko Kato offered to store the dogu at her home for free, but she lives in Camden.

C. Further discussion:

The current location is an active teaching site and the dogu is accessible for demonstrations.

Questions were asked about the frequency of loans to practitioners. Currently, not often.

Sachiko is at KOP at least 1x a week. With reasonable planning anyone can reserve items and pick up or have them transferred to a mutually agreed place.
