The subject learnings will be reinforced with specialised workshops focusing on topics which are relevant to delivering benefits at the student's workplace(s).

### **Practical Training and Assessment Requirements**

To gain the UoC students will be required to complete practical workplace evidence and be assessed to be competent. The student will return to their workplace and conduct practical blast designs tasks using the knowledge and skills from the course to demonstrate and provide evidence of competency. A portfolio of work is then submitted to Blast It Global for assessment.

On the successful completion of the theory and practical performance assessment the student will be issued with a Statement of Attainment (SOA), RIIBLA403 Design Blasts. **Non Australian residents will be issued with a Certificate of Completion (CoC).**

Prerequisites: All participants must have a minimum of 6 month's experience in practical blasting applications, such as drill and blast design, supervision of on-bench teams, experience working with explosives, or relevant geotechnical/ geology based roles. The course assumes prior knowledge of drilling and blasting practices.

Schedule: The Advanced Blast Designer course is conducted over a period of 2 days, with 8 hours of learning per day.
