On completion of the theory training, provided over the three days, combined with work place evidence, the student on completion of all the training requirements will be issued with a Statement of Attainment from Down to Earth Training & Assessing RTO 51199 (RTO Partner). The Statement of Attainment will enable the student to apply for the statutory Shotfirers licence in their relevant state or territory.

Pre-requisites: To qualify for the training, the student must be able to provide the following evidence:

- Over 18 years of age (Copy of drivers licence);
- Dangerous Goods Security Card (DGSC) or Security Sensitive Ammonium Nitrate (SSAN) clearance/ESC Card;
- 3 months prior experience working with explosives.

All communications, bookings and inquiries will be via Blast It Global, contact details on the last page.

The course may be attended by personnel employed in the underground metalliferous and construction industries, who are wishing to gain insight into drilling and blasting practices. Personnel not wishing to gain the qualifications of an Underground Shotfirers licence/permit, should select "Require training for Drill & Blast General Knowledge (No qualification)" box.

Course Contents: The Underground Shotfirers course will combine classroom learning with workshops to develop skills, along with open book tests to assess students' understanding of topics, covered during the course.
