(3) **CHILDREN:** If you have children, AND you and your spouse CANNOT agree on such issues as Custody, Visitation, or Support, you will make arrangements, either on your own or through an attorney, to settle and resolve such matters through the Domestic Relations Section (DRS) of the county where your children reside, either before, during, or after your divorce. By filling out this form and initialing you acknowledge that this divorce will not resolve nor affect any issues concerning children between you and your spouse. You may still obtain a no fault divorce without resolving these issues. You are not required by law to resolve these issues through your no fault divorce action. You can either resolve them independently of your divorce, resolve them after your divorce (or before), or determine that such issues will be resolved privately between you and the other parent of your children, without resorting to litigation through Domestic Relations and/or the county court system.

(4) **RESIDENCE:** One of you has resided in Pennsylvania for the past 6 months.

There are no extra or hidden costs; however, by signing below you also acknowledge that if it is found that your spouse in fact does NOT want to be divorced, or does not cooperate (by signing and mailing back papers in a timely manner when requested), then your fee will be wasted and we will not be able to help you any further in your attempt to obtain a divorce.*
