

Fun Vacations Travel LLC - Client Contract and Waiver of Liability

The following contains important travel information you will need, and also outlines the terms and conditions of Fun Vacations Travel, LLC. Please read carefully.

Fun Vacations Travel LLC acts only as agent for the client in acquiring transportation, hotel/resort accommodations, cruises, tours, sightseeing and other privileges, or services for the clients' benefit, and on the express condition that Fun Vacations Travel LLC shall be held harmless and not responsible for any loss, accident, injury, delay, defect, omission or irregularity which may occur or be occasioned, whether by reason of any act, negligence or default of any 3rd party company or person engaged in or responsible for carrying out any of the proposed travel arrangements, or otherwise in connection therewith.

The Proposed Travel Arrangements are made on the express condition that Fun Vacations Travel LLC, its employees and agents, shall not be responsible for, and shall be exempt from, all liability in respect of loss, damage, accident, injury, illness, harm, trauma, death, delay or inconvenience to any client (which shall be deemed to include the heirs, executors, administrators or assigns of the client), their luggage, or other property, wherever, whenever and however the same may occur.

Fun Vacations Travel LLC, its officers, employees, or agents shall not be liable for any injuries or any damages to any client or be subject to any claim, demand, injury, or damages, whatsoever, unless such claim is due to the gross negligence of Fun Vacations Travel LLC and is lodged in writing within 30 (thirty) days after the end of the booking. Such liability will be subject to limitation and under no circumstances will Fun Vacations Travel LLC be liable for any indirect or consequential loss or damage.

It is entirely the Client's responsibility to ensure that all passports and visas are current, valid, obtained on time, and will be valid for six months after return to their home country and that any vaccinations, inoculations, prophylactic (e.g. for malaria) and the like, where required, have been obtained. The client is strongly advised to verify the relevant travel requirements with the appropriate authority well in advance of traveling, thus allowing adequate time for processing & delivery of any required documentation. Upon request, Fun Vacations Travel LLC will endeavor to assist the client, however such assistance will be at the travel agent's discretion and the client acknowledges that in doing so, the travel agency is not assuming any obligation or liability and the client indemnifies and holds harmless Fun Vacations Travel LLC against any consequences of non-compliance. Additionally, it is the client's duty to familiarize him/herself with the inherent dangers of and mental and/or physical condition required for the proposed travel arrangements. The client acknowledges that Fun Vacations Travel LLC is not a wedding/event service and does not plan the such, but can refer the clients to third parties to assist with those plannings.

It is **strongly advised that all clients acquire adequate travel insurance** in order to cover financial loss from cancellations due to health/illnesses, transportation cancellations/delays, accident/injury, personal accident, weather related travel disruptions, and personal liability, loss of or damage to baggage/ luggage and contents of baggage/luggage. It shall not be obligatory upon Fun Vacations Travel LLC to effect insurance for the client except upon written instruction and all insurance effected pursuant to such instruction will be subject to such exceptions and conditions as may be imposed by the insurance company or underwriters accepting the risk. Should the insurers dispute their liability for any reason, the client will have recourse against the insurers only. Fun Vacations Travel LLC will not be responsible or liable for consequences resulting from the client's failure to acquire adequate insurance coverage.

Any excursion, transfer, ticketing, that is not directly affiliated with the respective cruise line / property, must be prepaid at booking and is considered non-cancelable and non-refundable. All excursions and transfers booked directly with the cruise line / resort / outside tour company source/ event ticket providers are subject to the terms and conditions of each respective company.

To process the client's travel arrangements, personal details like legal name, age, and date of birth will be necessary. Furthermore, credit card details and a written authorization from the client will also be needed. (Page 3) must be filled out and signed.

Travel documents, including vouchers and itineraries, are generated and provided via email delivery upon full payment. Your personal details are used solely for internal purposes as outlined in the privacy policy of Fun Vacations Travel LLC and will not be disclosed to any third-party entities.

Fun Vacations Travel LLC is not responsible for issuing separate terms and conditions to each traveler booked or listed within one reservation, and shall be held harmless and not responsible for any resulting disputes or actions taken by fellow travelers arising due to the signor agreeing to and signing this contract. Any disputes are between the signor and traveling companion(s). Passenger/ Traveler name change/cancellation fees or incurred non-refundable charges are solely the responsibility of the booking authorizing traveler.

DISCLAIMER: Fun Vacations Travel LLC & our agents are happy to assist with your travel planning, however we assume no liability for improper travel documents. It is the sole responsibility of the person traveling to identify and obtain all required travel documents for the entire trip and have them available when necessary. Travelers who do not possess the proper documentation may be prevented from boarding their flight or ship or from entering a country, and may be subject to fines. No Refunds will be given to individuals who fail to provide proper documentation for travel.

As of 5/1/2025, **NON-TRAVELING PARENT LAW** , Federal regulation requires all minor children under the age of 18, have a notarized document (if both birth parents on birth certificate) from non-traveling parent. Both parents must notarize a statement of travel authorization if minor child is traveling without parents. Airlines and Cruise line providers can deny boarding without the required written notarized documentation. It is the sole responsibility of parents to ensure these documents are obtained. Any group charges not charged by booking suppliers are in addition to fees and must be paid in full at time of booking payoff and are non-refundable if booking is cancelled.

By signing below, the signor further acknowledges that he/she is acting as a representative for him/herself and all travel companions, and has the legal authority to accept this agreement as such. Additionally, signor acknowledges and agrees that it is his/her responsibility to inform companion traveler(s) of these terms and conditions to which they shall be bound, and to provide a signed copy if required. This contract shall be governed by the laws of the State of Alabama. Any disputes will be heard by the appropriate federal and/or state courts located in St. Clair County, AL. If the court's decision falls in favor of Fun Vacations Travel LLC, all legal costs will be paid by disputer.
