INFORMATION AND INSTRUCTIONS FOR INDIVIDUALS AND GROUPS

Ages: Athletes must enter the NER Championships at the age they will be on Dec. 31, 2019.

Competition level: Athletes and groups will compete at their level of competition as of the NER deadline date, 4-17-19.

USTA Membership: All participants must hold some form of USTA membership. Go to www.ustwirling.com for membership application.

Deadline/Method of Payment: USPO postmark by midnight APRIL 17, 2019. No metered mail. No phone, hand delivered, or mail that requires signatures will be accepted. Money order/bank certified checks ONLY – payable to: North East Regional Council

Registration Fee (Individuals & Duet/Pair Mbr) - \$30 Mandatory for all individual/duet/pair participants (both duet/pair partners pay). This fee helps defray such costs as the use of the facility, surcharges, and awards, as well as judges' fees, airfare, food and lodging.

MUSIC: Music for Solo, 2-Baton, 3-Baton and Duet. Adv Solo/Duet will be performed to the WBTF IC Solo music. Nov/Beg/Int Solo, Beg/Int Duet, & all 2 & 3 Baton (Beg/Int/Adv) will be performed to the WBTF IC multiple baton music. **Music for Artistic Twirl & Artistic Pairs** All Artistic Twirl/Artistic Pairs will be performed to the WBTF Artistic Twirl. Music is available for free download on www.ustwirling.com.

Finals for Individual Events 2019 NER will be following the national format for finals.

NO PRIVATE LESSONS ARE ALLOWED ANYWHERE ON CAMPUS!

Parent/Guardian Responsibilities: Before signing the waivers at the bottom of individual and group entry forms, parents/guardians agree to read the Parent/Guardian Responsibilities contained in the current USTA rule book at www.ustwirling.com.

Team/Group Entry Form:

1. This form contains two pages. The group waiver must be signed.
2. All entries must be accompanied by an attached roster. Please type or print clearly.
3. To avoid personnel conflicts, all members of more than one team/corps/organization must be designated on a separate list and attached to the roster. List the name of the other groups; specify category, level and age division.
4. Fee columns include USTA surcharge. Registration is \$7 per athlete in lieu of admission fee. Organization fee \$45, pay once per organization. *Please do not staple checks to entry form.*

Ages: Team average age – Primary 9.99 & under; Juvenile 10-13.99; Junior 14-17.99; Senior 18 & over

Tiny Tots - all members must be 7 or under. Teams, Trios & Corps may only compete in one age category per event unless there is a 25% or more change in team personnel and one or more members is of the next age division. Trio teams (prim, juv, jr & sr only, no tiny tot trios) consist of 3 members. Small teams consist of 4-8 members. Large teams consist of 9+ members.

CLASSIFICATIONS FOR SHOW & PARADE CORPS: Jr (0-17.99) & Sr (18+), A Class & Open; average age of twirling members only. No age limit for auxiliary members. Since USTA no longer sanctions Novice Parade Corps, this event will be offered as a non-sanctioned event – Juv (0-13.99)

Group Time Limits: Twirling Teams - 3-4 min. with 10 sec. leeway; Dance Twirl Teams – 2-3 min. with 10 sec. leeway. Trio Teams 2-3 min. with 10 sec. leeway. Parade Corps – 2-3 min. with 10 sec. leeway, forward progression movement 1:30 min.; Show Corps – 4-6 min. with 10 sec. leeway. Pom teams: Tot & Pri. – max. 2 min.; Juv, Jr, Sr – max. 3 min. (no minimum time for pom teams). “Show Team”. 2-3 min. with 10 sec leeway.

ARTISTIC GROUP: 3-3 ½ min with 10 sec leeway. One level, 10+ members. Min age 12. Group may consist of members of both sexes if so desired: See rulebook on the USTA website for content restrictions and other pertinent information. www.ustwirling.com

Team Restriction: Twirl Teams and Dance Twirl Teams who choose to compete in both categories MUST adhere to the following regulations: a) must compete with different routines understanding that selected sections may be used in both routines (i.e. 2 baton/3 baton section, finger series, rolls, etc.); b) must utilize completely different song/music selections. (Check USTA for possible “Show Team” Restrictions)

Order of Performance for Team/Group Day: Events will be scheduled in the order that prevents as many personnel conflicts as possible. Awards after last set. Lineups will be sent to directors approximately 2 weeks prior to contest.

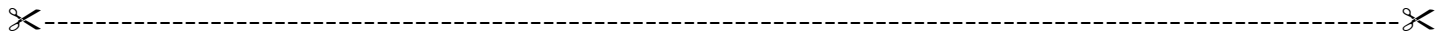

Directions to Kutztown University

The charming borough of Kutztown is nestled in the Pennsylvania Dutch countryside of Berks County in southeastern Pennsylvania. Kutztown is midway between Reading and Allentown on Route 222. The town is approximately 2 hours from New York City, 1.5 hours from Philadelphia and Harrisburg, and 3 hours from Baltimore/Washington.

From the North:

81 South to 476 (PA Turnpike N.E. Extension) to Exit 56 – 78 West to Exit 40 (formerly exit 12) and 737 South. Proceed into Kutztown to Main Street (Turkey Hill Mini Mart), turn right at light and continue up hill to campus

From the South:

81 North – 78 East to exit 40 (formerly exit 12) and 737 South. Proceed into Kutztown to Main Street (Turkey Hill Mini Mart), turn right at light and continue up hill to campus **OR** 83 North to 30 East – 222 North into Kutztown. Take the Kutztown exit and continue on road/Main Street to campus

From the East

78 West to exit 40 (formerly exit 12) and 737 South. Proceed into Kutztown to Main Street (Turkey Hill Mini Mart), turn right at light and continue up hill to campus **OR** 76 West to 476 (PA Turnpike N.E. extension) to exit 56 - 78 West to exit 40 (formerly exit 12) and 737 South. Proceed into Kutztown to Main Street (Turkey Hill Mini Mart), turn right at light and continue up hill to campus **OR** 76 West to 422 West to 222 North into Kutztown. From either South/North, Take the Kutztown exit and continue on road/Main Street to campus.

From the West

80 East to 476 (PA Turnpike N.E. extension) to exit 56 - 78 West to exit 40 (formerly exit 12) and 737 South. Proceed into Kutztown to Main Street (Turkey Hill Mini Mart), turn right at light and continue up hill to campus **OR** 76 East to 81 North - 78 East to exit 40 (formerly exit 12) and 737 South. Proceed into Kutztown to Main Street (Turkey Hill Mini Mart), turn right at light and continue up hill to campus.
