

We only keep your information where legally required and you will be informed of such times. Your information will not be used other than for the express purpose of preparing and completing sessions booked at the natures pathway. Natures Pathway is committed to ensuring that your privacy is protected. Should we ask you to provide certain information by which you can be identified when using our website, then you can be assured that it will only be used in accordance with this privacy statement.

Any individual can request access to information held on them by Natures Pathway at any time. An individual can request that information relating to themselves held by Natures Pathway is deleted at any time. No information is stored by Natures Pathway without prior consent of the owner of that information

If an individual requests information on another individual, the individual that the information is held on must give permission for the requester to access the information prior to the information being released. In accordance with GDPR we may retain some of your data for legitimate business reasons for up to 7 years, such as Photographic Disclaimer Forms or Accident Record Sheets. We will not pass or sell your data on to any third parties. We review our data every 12 months. By continuing to do business with the company you are agreeing to the terms in our privacy policy.

#### Security

Web forms are sent via HTTP, so are not encrypted much like email. For this reason, we do not require sensitive information to be sent on any forms.

Collected information is instantly emailed to info@naturespathway.co.uk meaning that it is only able to be accessed by us.
