# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to www.AandTBenefits.com, and A&T Benefits LLC, and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to A&T Benefits LLC include domains and sites owned now or in the future by A&T Benefits LLC (AT). AT's website is an educational and/or e-commerce site. By using the AT websites, you consent to the data practices described in this statement.

## **Collection of your Personal Information**

In order to better provide you with products and services offered, AT may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- Phone Number

If you purchase AT's products and services, we may collect billing and credit card information. This information is used to complete a purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. ### **Use of your Personal Information**

### **Sharing Information with Third Parties**

AT does not sell, rent, or lease its customer lists to third parties.

AT may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to AT, and they are required to maintain the confidentiality of your information.

### **Tracking User Behavior**

## **Automatically Collected Information**

AT may automatically collect information about your computer hardware and software. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain the quality of the service, and to provide general statistics regarding the use of the AT website.

### **Use of Cookies**

The AT website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. - Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

### **Children Under Thirteen**

AT does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website.
