**APPROVAL OF THE TREASURER REPORTS:** President Patsche asked whether the Board had reviewed the December 2024 Treasurer Report and if they found need for any changes, corrections, or amendments. President Patsche said hearing none, the December 2024 Treasurer Report stand approved as submitted.

**PUBLIC COMMENT:** President Patsche wanted to thank Trustee Eskew and Trustee Bourland for relieving the Public Works during the snow storm and continuing to plow the roads. President Patsche also thanked Trustee Eskew for ensuring the salt was down early before the snow started, it was a great job by Public Works. Our streets looked great!

POLICE DEPARTMENT REPORT: Chief Maki stated in December of 2024, there 230 service calls, 2 accidents, 40 citations, 39 written warnings, and there are 27 vacant homes. For the year, there was 3,224 service calls, 32 accidents, 552 citations, and 612 written warnings. All five Flock cameras are installed, and have assisted in 5 instances. Chief Maki thanked the police officers, Trustee Richbark, Trustee Eskew, Clerk Cave, Janie Stanley, Santa and all the residents and businesses that helped support the Christmas Toy Drive for families in the Village. Share had purchased several gifts for each family and Route 66 Mother Road provided the meals to the families. Big thank you to President Patsche on speaking with the Curve Inn and arranged a huge donation of \$1,866.92 for the purchase of a Ballistic Shield for the Police Department. This shield will allow protection to the entry officer when the Police Department gains entry to a residence or business. During the winter storms, Chief stated that there were zero traffic accidents and Chief stated that Public Works was managed well during this storm and wanted to thank Trustee Eskew for helping residents tow their vehicles out, that were stuck in the snow. Chief Maki stated he went above and beyond.

**PUBLIC WORKS REPORT:** Trustee Eskew stated that the leaves were all picked up before the snow storm and they have picked up the Christmas trees that were out. Big Red had some maintenance issues that needed resolved and has been inspected. Trustee Eskew stated he wanted to thank Public Works for their work during the storm and he is happy that residents noticed and were happy about it. President Patsche and Trustee Tavernor stated they did a great job.

**ENGINEERING REPORT:** Kevin Kuhn, Kuhn & Trello stated that the drainage grant is due by the end of the month. FEMA accepted the draft application and stated the application met their guidelines and the Village is able to submit the formal application. Trustee Eskew stated he will contact Springfield Metro Reclamation District to camera the area.

**ATTORNEY REPORT:** Attorney Craven stated that the Village was served ligation notice and they have been forwarded to IML legal counsel.
