Minutes of the Special Board Meeting of the Village of Southern View Board

NEW BUSINESS: President Patsche asked for discussion of Signage for the Route 66 Hotel & Conference Center. Rich from LED Craft of Maryland Heights addressed the Board on the LED sign that Route 66 Hotel was interested in purchasing and hanging above their canopy at the entrance of the hotel. The lighted sign being considered is 42 feet by 12.5 feet. The sign would be used for advertising purposes for any business. Snoop has reached out to IDOT to discuss the sign and gain their approval. Discussion took place on the hotel purchasing the sign and waiving the hotel/motel tax until the costs of the sign has been paid in full, roughly five years, similar to a tax incentive program. Snoop offered a 15% tax on any advertising sold that would come directly into the Village. Discussion of how the tax would be classified as possibly a marketing tax and if the Board could designate the funds for streets. The Board would want some assurances if the hotel was sold during that time that the hotel/motel tax would resume. Snoop also stated that there could be over 500 ads rotating throughout a 24 hour period. Following discussion, Snoop will work with IDOT to ensure they approve the sign and bring that back to the Board.

ADJOURNMENT: With no further business, President Patsche asked for a motion to close the meeting at 6:52 pm. Motion was made by Trustee Petrosky and 2nd by Trustee LaRussa.
