**APPROVAL OF THE TREASURER REPORTS:** President Patsche asked whether the Board had reviewed the March 2025 Treasurer Report and if they found need for any changes, corrections, or amendments. President Patsche said hearing none, the March 2025 Treasurer Report stand approved as submitted.

**PUBLIC COMMENT:** Andrew Steinbrecker, Manager of Share, shared the April 19, 2025 event went well and that they are committed to continuing giving back to the community. In December of 2024 they purchased individual presents for the Toy Drive sponsored by the Police Department. Share plans to sell to other dispensaries starting in July/August. Share is an organic grower. Discussion took place on if there is any tax on the wholesale grow sales. Andrew is going to read up on the statue and report back to the Village.

Dale LaRocca, resident of 1<sup>st</sup> Street, asked why residents are not following the burning rules, he stated it seems like residents are continuing to burn on non-burn days. Dale also stated that residents are not pulling their garbage cans from the front of the home, either leaving them by the street or by their front door. He stated it looks crappy. Dale also stated there is a pool in the 3100 block of 2<sup>nd</sup> Street that has not been taken care of, it is green and hasn't run for over a year. Dale also rents the municipal building around Christmas and this year the Village is scheduled to hold their meeting on the day that he would like to rent the hall on December 23, 2025. President Patsche stated he will add changing the December Board meeting to the next agenda.

Rick Allen thanked the Southern View Police Department for attending the Easter Egg Hunt. Rick stated that they had rented the whole park. Trustee Eskew stated the soccer players are there every Saturday from 7:15 am -9:00 am and the park is a public park and the only time the whole park was shut down was for the  $85^{th}$  Anniversary. Rick also asked when the Village is going to fix the potholes and during the rain it is hard to see them. Trustee Eskew stated that it is on the agenda.

Tim Fuhrman resident on Straight Street, stated the ditch at the ole Kleekamp property is backed up. Trustee Eskew stated he will come look at it this week.

**POLICE DEPARTMENT REPORT:** Chief Maki provided his report to the Board. Chief Maki stated there were 219 service calls for the month of March, 2 accidents, 49 traffic stops and 127 warnings written. There are 30 vacant properties within the Village. Effective March 1, the Police Department is able to have 100% coverage. Flock cameras have been used 3 times for stolen vehicles. Chief Maki stated that there have been no reports on any issues with the Little Flower parking lot, no news is good news.

PUBLIC WORKS REPORT: Trustee Eskew stated he has items under new business.

ENGINEERING REPORT: Kevin Kuhn, Kuhn & Trello stated he is also under new business.

ATTORNEY REPORT: Attorney Craven stated the Wood House has been placard until repairs can be made.

**OLD BUSINESS DISCUSSION**: President Patsche stated the IDOT Condemnation of Village Property is tabled. Trustee Eskew asked about a tree plan meeting? Trustee Briggs stated he forwarded the park tree plan to the State. Trustee Eskew asked without sharing it with the Board. Trustee Briggs stated it is a tentative plan and can be changed.

President Patsche stated the Approval of Land Acquisition for IDOT is also tabled.

**NEW BUSINESS:** President Patsche asked for discussion and approval of Speco Blue Systems from Third Wave for Camera Monitoring. The subscription costs is \$240.00 per year.
