CALL TO ORDER: The President and the Board of Trustees held A Committee Meeting

DISCUSSION: President Patsche stated that this is a Committee Meeting to discuss the Plan for the 85th Anniversary of the Village. Trustee Eskew stated he is getting prices confirmed on the tents for the band and the public to sit under.

Trustee LaRussa stated she would like to see a cakewalk or some more family-oriented events like Bingo, kickball etc. Trustee LaRussa also recommended reaching out to the Village residents that have the knowledge of the businesses of the past and possible photos of how the Village has changed through the years.

Trustee Eskew stated he has reached out to a vendor for alcohol to be sold at the celebration. Trustee LaRussa does not want to promote alcohol.

Trustee Tavernor stated he wants Jerry Thompsons proposal passed so no one would have to work the event and he can enjoy himself. Jerry can provide the entertainment and artwork for the platforms. Trustee Tavernor stated that it is a lot of work to put on an event.

Trustee LaRussa offered to produce a flyer to be distributed through Facebook and throughout businesses in the area.
