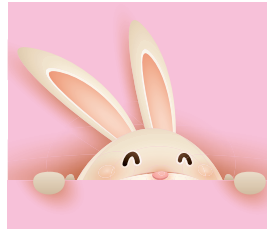

## New Legal Representative for the Village Southern View

When Attorney Grischow was selected to be a Judge for Sangamon County that prevented her from continuing to practice for our Municipality; therefore, President Petrosky then selected Don Craven as our Village Attorney.

Don has testified before committees of the Illinois General Assembly on media issues; is the author of the Illinois chapter of the Reporters Committee for Freedom of the Press publication, Open Government Guide. He co-authors the MLRC publication on media libel law and privacy issues.

Mr. Craven has served as counsel to firefighter unions, pension boards, and individual firefighters throughout Illinois; assisted unions in disciplinary matters, contract negotiations, legislative affairs, and has produced seminars for union conferences. Craven maintains a general litigation and appellate practice.

Mr. Craven joined his father, former Illinois Appellate Court Justice James C. Craven, in practice in Springfield, concentrating from 1986 to 1989 on media issues and voting rights litigation on behalf of black and Hispanic communities in Illinois and California.

He now concentrates on libel and First Amendment issues, access to government meetings and records, and the business issues of concern to newspapers. Mr. Craven has counseled executive directors and board members of the Illinois Press Association, Illinois Broadcasters Association, and Illinois News Broadcasters Association on association activities, both legal and legislative.

# COP'S CORNER by Southern View Police Chief Chris Yingling

## LET'S DO THIS!!!

### *f.y.i.* . . . a bit of information about driving in the left lane

This is the section from the Illinois Vehicle Code regarding driving in the left lane on a controlled access highway (interstate). Note the exceptions listed and that speed is not specified in this section.

(d) Upon an Interstate highway or fully access controlled freeway, a vehicle may not be driven in the left lane, except when overtaking or passing another vehicle.

(e) Subsection (d) of this Section does not apply:

(1) when no other vehicle is directly behind the vehicle in the left lane;

(2) when traffic conditions and congestion make it impractical to drive in the right lane;

(3) when snow and other inclement weather conditions make it necessary to drive in the left lane;

(4) when obstructions or hazards exist in the right lane;

(5) when a vehicle changes lanes to comply with Sections 11-907 and 11-908 of this Code [625 ILCS 5/11-907 and 625 ILCS 5/11-908]

(6) when because of highway design, a vehicle must be driven in the left lane when preparing to exit;

(7) on toll highways when necessary to use I-Pass, and one toll and other highways when driving in the left lane is required to comply with an official traffic control device; or

(8) to law enforcement vehicles, ambulances, and other emergency vehicles engaged in official duties and vehicles engaged in highway maintenance and construction operations

(Source: P.A. 77-1344; 93-447; §5.)

### WHEN TRAVELING, PLEASE DO YOUR PART TO KEEP EVERY ONE SAFE.



Especially as it relates to **HAZARD LIGHTS** ..... automatically you should know that is a warning sign to be cautious.

Be mindful of correct procedures when you see hazard lights that are flashing. No matter what type of vehicle, Yes, ANY vehicle...this includes emergency vehicles, state vehicles, tow trucks, even personal vehicles with hazard lights activated.

Remember that all motorist are required to:

1. **SLOW DOWN**
2. **CHANGE LANES, IF POSSIBLE**
3. **PROCEED WITH CAUTION**

Sounds simple, right? And it is simple, yet every day those whose jobs it is to assist others and requires them to be on the side of the road, just feet, sometimes inches from passing traffic, are facing injury or death, simply by doing their job.

Then, as if that is not bad enough, when tragedy strikes, first responders see those motorists videoing the scene while driving by. (Really!) Not only is this illegal, but disrespectful to the victims and their families.

Therefore, *please do your part .... keep every one safe with your kind consideration.*

## Spring...Summer...Fall...Winter.... Public Works Helps Southern View Residents Weather It All.

### LIMB PICK-UP PROGRAM

**Pick up for limbs begins the first Monday of every month, April through October.**

We ask that you **NOT** put limbs out at the curb until the weekend before pickup.

The Village Public Works Crew will pick up the following:

- a) Limbs or branches that have fallen from trees and bushes.
- b) Only limbs or branches that have been trimmed from trees and bushes as it pertains to normal tree maintenance, (see restrictions below).
- c) Limbs or branches less than 6' 4" in diameter and, cut into a manageable size.

**Note:** Items should be placed at the edge of your front yard, with nothing in the ditch.

**RESTRICTIONS** ---Limbs, branches, logs or excessive trimming resulting from tree removal. And, any limbs, branches or logs larger than 6' 4" in diameter.

Please contact your waste disposal company to arrange for the pick up of stumps, shrubs, flowers, vines, garden waste and grass clippings.



**A reminder to people who mow their yard and blow the grass out onto the street.**

Please clean it up . . . It could cause a motorcycle to loose traction which will cause a wreck and it's also against the law to blow it in to the roadway and stop up the storm drains.

## Burning of Yard Waste

- Burning is allowed on Wednesday and Thursday of each week and the first and third Saturday of each month... and, must be kept between the hours of 7 a.m. and 7 p.m. or dusk, which ever is first.
- The fire must be constantly attended until completely extinguished and must have extinguishing capability readily available (garden hose/fire extinguisher),
- Burning is not allowed if wind air speed is 20 mph... nor, during high winds (in excess of 20 mph)
- Burning in containers, such as burning barrels is prohibited.
- No person shall burn trash, rubbish, papers, garbage, general household waste, commercial waster, construction or demolition debris.
- Violations shall be punished by written warning and subsequent fines not less than \$250.00 or more than \$500.00.
- Regardless of any statement to the contrary, burning of landscape waste is prohibited on the following holidays of each year: New Years Day, July 4th, Veteran's Day, Halloween (October 31st), Thanksgiving Day and Christmas Day.

The Village of Southern View Parks & Recreation offers a number of outdoor spaces for you to reserve at your next family reunion, sports event, celebration, or meeting... including pavilions that provide covered picnic areas, baseball & softball fields – tennis courts, and a fishing pond.

Please telephone (217) 529-3352 to make reservations.

Activities are encouraged and we ask that you respect the park rules as follows:

**SOUTHERN VIEW COMMUNITY PARKS RULES ....**

- Reservations are required for rental of the pavilions and sports fields ... please telephone (217) 529-3352 to make reservations.
- Contact person listed on the reservation contract must be on site the duration of the reservation.
- All reservation contract holders agree to follow and enforce the Village of Southern View Ordinances, Park Regulations and Sports Field Rental Guidelines. The reservation contract holder will leave the pavilion clean and in good condition. Failure to comply with park regulations may forfeit the right to use Village facilities in the future and persons causing damage to equipment and/or facilities, prosecuted.
- Tables moved out of the picnic shelter, or rearranged within the picnic shelter must be returned to the original location.
- Staking is not permitted, nor is pop-up tents or umbrellas; No interactive inflatable apparatus/bounce houses or water amenities/games; No painting, striping, chalking, or coloring of the fields in any way.
- Vehicles may not be driven or parked on turf areas, sidewalks, service driveways, or emergency zones. Only parking lots may be used for loading and unloading.
- Fire permit application is required; and fires in the barbecue stands must be extinguished prior to leaving the picnic shelter.
- No alcohol permitted at any time; persons using foul language (sufficiently loud for others to hear) or who demonstrate disorderly conduct will be removed from the park; in addition, intoxicated persons will be escorted out of the park.
- No glass containers are allowed in the park.
- No amplified sound allowed.
- Swimming, wading or boating is not allowed in the pond.
- Rocks are not to be thrown into the pond.
- Dogs are not allowed in the pond.
- Dogs must be leashed at all times within the park and not allowed to run free.
- Dog feces (droppings) are the responsibility of the owner and must be picked up and disposed of in a proper trash container.
- Motorized vehicles are not allowed within the parks.
- Vehicles speed within the parking lots is 15 mph.
- Park hours: 5:00 a.m. to 10:00 p.m. daily.
