Grass Clippings Left On The Road or Street Should Be Removed...

IT IS LITTER!

415 ILCS 105/3)

(from Ch. 38, par. 86-3)



You've been mowing your lawn for a few months now this year, and you may have been doing it wrong. If you get caught doing it wrong, you could be fined because of how you mow your lawn...Really it just has to do with littering and what you do with your grass clippings.

Sec. 3. As used in this Act, unless the context otherwise requires: (a) "Litter" means any discarded, used or unconsumed substance or waste. "Litter" may include, but is not limited to, any garbage, trash, refuse, cigarettes, debris, rubbish, grass clippings or other lawn or garden waste, newspaper, magazines, glass, metal, plastic or paper containers or other packaging construction material.

Trapping Requires a License From IL Dept Of Natural Resources

A Trapping license and habitat stamp are required to trap in Illinois...

The trapping of wildlife, whether it be groundhogs or cats **REQUIRES** you to obtain a nuisance permit from the Dept of Natural Resources; or, you may hire it done from a licensed wildlife control operator.

Therefore, Landowners and tenants who want to remove wildlife themselves should contact an IDNR District Wildlife Biologist to see if they Qualify for a Nuisance Animal Removal Permit.

Comments from A Southern View Police Officer...

Officer Brent Sutton graduated from Chatham-Glenwood High School, Lincoln Land Community College and Western Illinois University with a degree in Law Enforcement and Political Science.

He enlisted in the US Air Force and was activated following 9/11; spent time in North Carolina and the Island of Cyprus in support of Operation Enduring Freedom and Operation Noble Eagle.

In 2008, Brent became a part time Southern View Police Officer in order to pursue a career in law enforcement in addition to having a full time analyst position with, the Illinois State Police. Brent enjoys being a police officer, says it is rewarding to give back to the community in some way, and feels that his contributions assist with bringing resolution to pending investigations as-well-as, help with providing a responsible presence of law enforcement for the Village of Southern View.

Update on Missing Female

Officer Brent Sutton advises that when a ten year old female went missing under unknown circumstances on July 1st the Southern View Police summoned help from area agencies as well as volunteers to canvass the neighborhood. Because she voluntarily left the residence and was not forcefully taken, this did **NOT** meet the criteria therefore nothing could be initiated and she was entered into **LEADS** as "Missing/Runaway". Attempt to Locate was sent to all working officers in Sangamon County.

Then, two days later...

With the help of the Sangamon County Sheriff's Department, Springfield Police Department, the Sangamon County Rescue Squad, and **ALL** members of the Southern View Police Department, she was located in Springfield, safe and was brought back to the Southern View Police Department.

We thank everyone who posted information on social media and assisted with this case. At this time, Southern View Police Department has nothing further on this investigation.

Then, the complimentary disposal of items not sold at your garage sale, picked up on that following Monday – October 8th, beginning at 7a.m.

And, **Please remember**, if you have a mattress and or box spring to be disposed of, you are required to

purchase a cover, and place the mattress and or box spring inside a sealed cover. **(Must purchase the cover and tape from the Village Clerk, @ 3410 S. 5th)**

Items to be picked up should be out by 7am on Monday morning – Oct. 8th, at the end of your front yard; however, **NOTHING** should be placed in the ditch please.

If for some reason your items are placed out after that one pick up has been completed and public works has to make an additional trip back to do your pick up, you will be sent an invoice for that service.

Even though you may think your street will not be picked up on a particular day, it is required that items be out and ready for pick up so as not to take the chance of missing your complimentary pick up.

Be thoughtful of those picking up your debris....

Place loose items in a box that will make it easier to handle; put a sign on anything with broken glass; and stack items so the pile of debris will not readily fall.

In addition, **NO** closed buckets of any type; paint cans; tires; toxic waste; needles; sewer pipes nor any animal waste will be ever be picked up; and, the Public Works crew appreciates your kind consideration.

LIMB PICK-UP PROGRAM

Pick up for limbs begins the first Monday of every month, April through October. We ask that you **NOT** put limbs out at the curb until the weekend before pickup.

The Village Public Works Crew will pick up the following:

- Limbs or branches that have fallen from trees and bushes.
- Only limbs or branches that have been trimmed from trees and bushes as it pertains to normal tree maintenance (see restrictions below).
- Limbs or branches less than 6' long and 4" in diameter, and cut into a manageable size.

Items should be placed at the edge of your front yard, with nothing in the ditch.

RESTRICTIONS -- Limbs, branches, logs, resulting from excessive trimming and/or tree removal, and any limbs, branches or logs larger than 6' long and 4" in diameter.

NOTE: The actual **PILE SIZE** is restricted to 6' x 4' x 4'

Please contact your waste disposal company to arrange for the pick up of stumps, shrubs, flowers, vines, garden waste, grass clippings, and landscape trimming with thorns.

COMPLIMENTARY LEAF PICK UP....

The Village of Southern View has a fall leaf collection program, which allows residents to get rid of leaves without paying the usual \$1.50-per-bag fee.

... Just rake your leaves to the end of your yard.

Again, the pile of leaves should be placed at the end of your yard, **NOT IN THE DITCH**, then the Public Works Crews, with the help of **BIG RED**, will pick up and dispose of your leaves for free.

The particular truck used for this process, (we call her **BIG RED**), has one huge hose to vacuum up the leaves. This hose is located on the right side of that vehicle, and its design only allows it to be used for one side of the street at a time.

When that one side is done and the truck is full, it must then be driven to the dump for disposal prior to any additional pickups. Then if by chance it is at the end of the day, or it begins to rain/snow, there may be a delay before the other side of the street can be picked up; yet be assured, big red will return to get more leaves.

Please help by raking any other debris, little twigs or limbs from your pile of leaves as only leaves can be vacuumed with this equipment. Again, these leaves should be placed at the end of your yard **NOT IN THE DITCH**, at the end of your yard.
