Minutes of the Regular Board Meeting of the Village of Southern View Board

CALL TO ORDER:

The President and the Board of Trustees held the regular scheduled meeting on Tuesday, May 23, 2023, at the Southern View Municipal Building, 3410 South Fifth Street, Southern View, Illinois. The meeting was called to order at 6:00 pm by President Patsche, followed by Roll call and the Pledge of Allegiance.

President Patsche introduced State Senator, Doris Turner to the Board. Senator Turner has accepted the honor of reciting the Oath of Office for the newly elected Trustees and the Village President. President Patsche thanked Senator Turner for her presence and expressed his honor of her officiating.

APPROVAL OF THE MINUTES: President Patsche asked whether the Board had reviewed the April 25, 2023, Regular Meeting Minutes and if they found need for any changes, corrections, or amendments. President Patsche stated after hearing none, the April 25, 2023, minutes stand approved as presented.

Motion to approve the April 25, 2023, Meeting Minutes as presented by: Trustee Bourland and 2nd by Trustee Eskew Upon roll call vote, all voted AYE; MOTION PASSES.

APPROVAL TO PAY BILLS: President Patsche asked whether the board had reviewed the May 23, 2023, Bills to be Paid, and whether there were any changes, corrections, or amendments. President Patsche asked for a motion to approve the bills as presented.

PUBLIC COMMENTS: No members of the public addressed the Board.

OLD BUSINESS DISCUSSION: President Patsche stated to table the IDOT Condemnation of Village Property. Attorney Craven stated that he is sending a letter regarding the concerns the Village has regarding the separation of the park and the road.

NEW BUSINESS DISCUSSION: President Patsche asked for discussion and approval of the Purchase and Installation of Flashing Lighting front and rear, Salt Spreader and Console for the F550 by Woody's in an amount not to exceed \$8,837.84. President Patsche stated that the salt spreader that was originally going to use for the new truck is rusted and in bad shape. President Patsche recommended to purchase a new salt spreader from Woody's. President Patsche stated that Woody's purchased a few salt spreaders last year and that this year the price of them have increased \$2,300.00. The Village is lucky that they have one from last year that will be able to fit the truck.

Motion to approve the Purchase and Installation of Flashing Lighting front and rear, Salt Spreader and Console for the F550 by Woody's in an amount not to exceed \$8,837.84 by Trustee Bourland and 2nd by Trustee Pierce Upon roll call vote, all voted AYE; MOTION PASSES.

President Patsche asked for discussion and approval of the Removal Dead Trees at 3104 S 3rd and 3229 Rita for an amount not to exceed \$4,500.00. Trustee LaRussa asked if these trees were on the right of way. President Patsche stated yes.

Motion to approve the Removal Dead Trees at 3104 S 3^{rd} and 3229 Rita for an amount not to exceed \$4,500.00 by Trustee LaRussa and 2^{nd} by Trustee Eskew Upon roll call vote, all voted AYE;

MOTION PASSES.

President Patsche asked for discussion and approval of the Appointment of Roy Maki as Acting Chief of Police for the Village of Southern View. Chief Wiese has resigned as the Chief and will be staying with the Department in the Lieutenant position to allow him time with his family and pursue other endeavors. President Patsche stated that Roy has the experience and education and with Chief Wiese's recommendation he feels Roy will be a great asset to the Village.

Motion to approve the Appointment of Roy Maki as Acting Chief of Police for the Village of Southern View by Trustee Eskew and 2nd by Trustee Briggs Upon roll call vote, all voted AYE;

MOTION PASSES.

President Patsche asked for discussion and approval of the Appointment of the Lieutenant. President Patsche stated that Rick Wiese will be appointed to the Lieutenant position and will work part time which will provide the Department with a chain of command.

Motion to approve the Appointment of Rick Wiese as a Lieutenant within the Police Department for the Village of Southern View by Trustee Eskew and 2nd by Trustee Briggs

Upon roll call vote, all voted AYE; except for Trustee Haines and Trustee Richbark voted NO

MOTION PASSES.

President Patsche asked for discussion and approval of the Hourly Rate for the Detective. Detective Townsley has been with the Village for over a year and a half and has done a great job with clearing the cars out of the lot. President Patsche would like to offer Detective Townsley an hourly rate of \$24.00 per hour, on a part time basis, if he would accept.

Motion to approve the Hourly Rate of the Detective position to \$24.00 per hour of the Village of Southern View Police Department by Trustee Eskew and 2nd by Trustee Briggs

Upon roll call vote, all voted AYE; except for Trustee Haines voted NO **MOTION PASSES.**

President Patsche asked for discussion and approval of the Purchase of Police Department Squad Equipment paid out of the DUI Fund. President Patsche stated that the cars are missing some critical equipment that is necessary for them to have. The items needed are first aid kits, cones, fire extinguishers, drug kits, and various other items. A detailed description was given to each Trustee.

Motion to approve the Purchase of Police Department Squad Equipment paid out of the DUI Fund not to exceed \$2,800.00 by Trustee Ritchbark and 2nd by Trustee LaRussa
