Minutes of the Regular Board Meeting of the Village of Southern View Board

CALL TO ORDER:

The President and the Board of Trustees held the regular scheduled meeting on Tuesday, May 28, 2024, at the Southern View Municipal Building, 3410 South Fifth Street, Southern View, Illinois. The meeting was called to order at 6:00 pm by President Patsche, followed by Roll call and the Pledge of

Allegiance.

APPOINTMENT & OATH OF OFFICE: President Patsche announced that Bill Haines resigned on May 1, 2024. President Patsche stated he would like to appoint Greg Bourland to the Board. Greg had been on the board from 2008 – 2023. President Patsche stated that Greg would finish out Bill Haine's term which ends in 2025.

POLICE DEPARTMENT REPORT: Chief Maki provided the Board with a summary of the Police Department Report for April of 2024. Chief Maki stated that the Police Department answered 375 service calls, 1 traffic accident, 75 traffic tickets, 76 warnings, and there are 16 vacant homes/for sale homes in the Village. Coffee with a Cop had 6 attendees with great conversations. The next Coffee with a Cop will be on June 8th, 2024, at the Village Hall. Chief stated that all officers are on track for the year on their training and he has provided to President Patsche all the calls for service for the Curve Inn from January 1, 2024, through April 24, 2024, for his review. Chief Maki had met with Treasurer Cave to discuss the budget for the upcoming fiscal year. June 15th, 2024, is Cops and Bobbers from 9 am to Noon at the Village Park.

Chief Maki also provided context of what the Ordinance 24-05-02 consists of. The ordinance will provide a chain of command within the Police Department and allow the Lieutenant's to supervise any full- or part-time officers and provide accountability with authority.

Trustee Bourland asked about Miller's health insurance, Treasurer Cave stated there are two Miller's now and it is the new officer's health insurance premium. Trustee LaRussa asked if the chipper truck took two batteries? Trustee Eskew stated yes. Trustee LaRussa also asked if the Toro mower was repaired and running? Trustee Eskew stated yes it was.

APPROVAL OF THE TREASURER REPORTS: President Patsche asked whether the Board had reviewed the April 2024 Treasurer Report and if they found need for any changes, corrections, or amendments. President Patsche said hearing none, the April 2024 Treasurer Report stand approved as submitted.

Motion to approve the April 2024 Treasurer Report as presented by: Trustee Eskew and 2nd by Trustee Tavernor Upon roll call vote, all voted AYE; except for Trustee Bourland voted present **MOTION PASSES.**

PUBLIC COMMENTS:

Dale LaRocca, resident from 3100 block of 1st Street stated that the ditches around his property need to be taken care of because it is always full of water and does not drain. Dale stated he has been patiently waiting and he would like it taken care of this summer. Dale also stated how much longer is the junk going to be out and not picked up? President Patsche stated they have been picking up and have taken several loads out already, but they did get behind with limb pickup and junk pickup the same day. Public Works anticipates that it will be picked up by the end of the month baring any issues with the trucks.

OLD BUSINESS DISCUSSION: President Patsche stated that a special meeting will be scheduled for the IDOT Condemnation of Village Property and the for the Land Acquisition from IDOT soon. The Village has not received their proposal. The Park Committee will meet again to discuss the trees in the park prior to the IDOT meeting.

President Patsche asked for discussion and approval of the Request for Expenditures of Tourism Dollars not to exceed for the 85th Anniversary Event July 19, 2024, through July 21, 2024. President Patsche stated the committee met several times and have agreed on the activities and what it will cost. Trustee LaRussa stated that it will be an all-ages event with something for everyone to enjoy. Trustee Tavernor wants to offer the Outlet to help with the event and possibly donate funds to their organization also.

NEW BUSINESS DISCUSSION: President Patsche asked for discussion and approval of Ordinance 25-05-01 An Ordinance Authorizing the Village Expenditures Pending Adoption of the Annual Appropriation Ordinance. Attorney Craven stated that the Village passes an ordinance that allows for the expenditures of the Village using last year's appropriations until the passage of the new appropriations for the fiscal year 2025.

President Patsche asked for discussion and approval of Ordinance 25-05-02 An Ordinance Amending Chapter 33 of the Southern View Code of Ordinances. President Patsche stated that this is the ordinance for the chain of command that the Chief had discussed earlier.

MOTION PASSES.

President Patsche asked for discussion of the Possible Road Projects. Kuhn & Trello sent over two estimates for the Linton from 6th street to 4th Street and Kern Street. Linton will cost an estimated \$362,380.00 to repair and place the new road and Kern Street is \$297,963.00. Kern Street is narrow, and this would allow us to make the street wider by removing the sidewalks. Trustee Richbark would like to see at least one sidewalk on one side of the road, people should be allowed to walk safely on a sidewalk and not in the roads. The estimate on Kern allows for the curb and gutter to allow drainage to flow. Linton Street has an ice rink at the corner of 4th and Linton, as there is no way for the water to drain everything is blocked further north. The funds would be used out of MFT. The Village has enough funds to do one road. Trustee LaRussa stated she agrees that Kern Street is in bad shape but has questions on why that road was selected when there are roads in the Village that is traveled more and is in need. President Patsche stated he and Engineer Kevin Kuhn had rated the roads and these were the worst ones. Trustee Tavernor stated the road is deteriorated and there are some spots that are just dirt. Trustee LaRussa stated she is aware as she used to live on that road she is trying to express if that is the best use of the funds to use on a street that isn't traveled. President Patsche asked the Board to look at the proposals and the streets and the Board will discuss in the future.

Todd Taylor, resident of the 3400 block of 1st Street, works for the Fire Department volunteered to visit more businesses in the Village to do inspections if the Village would like. If the board is unsure of the Fire Safety at a business the Springfield Fire Department can send inspectors out to the business and investigate. Todd stated that residents pay for the Fire Department on their property taxes, and they are here to serve us to.

ADJOURNMENT: With no further business, President Patsche asked for a motion to close the meeting at 7:00 pm. Motion was made by Trustee LaRussa and 2nd by Trustee Bourland.
