Minutes of the Committee Meeting of the Village of Southern View Board

**CALL TO ORDER:** The President and the Board of Trustees held A Committee Meeting

on Tuesday, May 7, 2024, at the Southern View Municipal Building, 3410 South Fifth Street, Southern View, Illinois. The meeting was called to order at

6:00 pm by President Patsche, followed by Roll call and the Pledge of

Allegiance.

**DISCUSSION:** President Patsche stated that this is a Committee Meeting to discuss the Plan for trees in the Village Park, on the East Side. With IDOT putting a road, all the trees will be removed that is currently there. It would be nice to have some sort of buffer. IDOT is not willing to place a berm, although some on the Committee feel that a berm is needed and can be placed after they are done with the road. President Patsche stated he will ask them to drop the dirt they pull out in the yard, and we can utilize it later to construct the berm. Tyler stated he recommends white pines, eastern red cedars, dawn redwoods and coral bark Japanese maples and possibly some sedum or stone crop to balance the area. Discussion also took place of adding boulders around to balance it out. The eastern red cedar is hearty, smells good, repel mosquitoes and they are a soft root system. He recommended permaculture planting. Tyler is going to produce a map of the area and add the various trees to the Board for discussion. The Board is planning a special meeting regarding IDOT in the near future.
