Park / Pavilion Regulations

*****The undersigned individual and organization hereby agree to indemnify and hold the Village of Southern View harmless for all other claims. Arising out of the use by the lessee of the above facility. This indemnity and hold harmless agreement shall include reasonable attorney's fees incurred by the Village.

I will be personally responsible for and will pay for any damage to Southern View Park property arising out of the use of said facility pursuant to this permit.

1. The contact person listed on the reservation contract must be on site for the duration of the reservation.
2. All reservation contract holders agree to follow and enforce the Village of Southern View Village Ordinances, Park Regulations and Sports Field Rental Guidelines.
3. Contract Holder will leave the field clean and in good condition. If it is necessary of the Village to provide cleaning the lessee will be charged an additional fee.
4. No interactive inflatable apparatus or water amenities/games.
5. No painting, striping, chalking, or coloring of the fields in any way.
6. Glass bottles are not permitted on ball diamonds or in picnic areas. (NOTE: use of ball diamonds requires a separate reservation).
7. All vehicles must be confined to the designated roadways, drives, and parking lot areas. No parking or driving on the grass.
8. Admission fees or charges may not be imposed, nor shall the vending of any merchandise or food be allowed without appropriate Southern View permits.
9. Weapons, firecrackers or similar devices shall not be brought onto Southern View Park property.
10. All signs must be removed from Southern View park property at the close of your event.
11. Please, No standing on tables or benches
12. When grills are used, please Do not leave charcoal unattended and once finished make certain all briskets are removed from the community park premises.
13. No Alcohol; No amplified music; No Water Games; or No Bounce Houses permitted.
14. Village personnel has the ability to close the fields due to the weather, maintenance, or if playability becomes compromised or dangerous.
15. Fire pit application and permit is required for use of the fire pit.
16. Should you find something to be out of order, please contact the Village Police @ 529-0255 to report the problem immediately-otherwise you will be held accountable.
17. ANY VIOLATION OF THIS AGREEMENT WILL FORFEIT YOUR DEPOSIT

Please Wash / Dry all Tables and return all to their original position. Wipe off Restroom sinks, flush toilets, and be sure toilets are not left running. Make sure all food that has been brought in is removed from the area of this Facility with, all trash properly disposed of. Permit fee is non-refundable.
