Minutes of the Regular Board Meeting of the Village of Southern View Board

CALL TO ORDER: The President and the Board of Trustees held the regular scheduled meeting

> on Tuesday, August 26, 2025, at the Southern View Municipal Building, 3410 South Fifth Street, Southern View, Illinois. The meeting was called to order at

6:00 pm by President Patsche, followed by Roll call and the Pledge of

Allegiance.

APPROVAL OF THE MINUTES:

Motion to approve the July 22, 2025, Regular Meeting Minutes as presented by Trustee Petrosky and 2nd by Trustee Tavernor Upon roll call vote, all voted AYE;

MOTION PASSES.

Motion to approve the July 30, 2025, Special Meeting Minutes as presented by Trustee Richbark and 2nd by Trustee Petrosky Upon roll call vote, all voted AYE;

MOTION PASSES.

APPROVAL TO PAY BILLS:

Motion to Approve the Bills to be Paid, for August 26, 2025, as presented by Trustee Petrosky and 2nd by Trustee Eskew Upon roll call vote, all voted AYE; except Trustee LaRussa voted no MOTION PASSES.

APPROVAL OF THE TREASURER REPORTS: President Patsche asked whether the Board had reviewed the July 2025 Treasurer Report and if they found need for any changes, corrections, or amendments. President Patsche stated, the July 2025 Treasurer Report stand approved as presented.

Motion to approve the July 2025 Treasurer Report as presented by Trustee Petrosky and 2nd by Trustee Richbark Upon roll call vote, all voted AYE; except Trustee LaRussa voted present **MOTION PASSES.**

PUBLIC COMMENT: Tim Fuhrmann, resident on Straight Street, stated he saw some Facebook comments and he stated that they were not made by him, he has no problem coming to the Board with any issues. Tim stated it looked like there is another dead tree on the property and asked when Public Works would be back over to mow the area and ensure that the drains are clear. Trustee Eskew stated that they would be over the next day.

Valerie Tuxhorn, resident on First Street, asked about the fence jumper and she is concerned about that for the Neighborhood Watch. President Patsche stated that they cannot discuss ongoing investigations but that the Police Department is handling that. Valerie asked if that was the same person that stole a motorcycle. President Patsche stated that was a different individual and that the motorcycle had been located and returned. Valerie asked if the Village still had the mosquito sprayer. President Patsche stated we do not have anyone licensed to operate the sprayer at this time, but the Village is proactive and places larvicide tablets to combat the spread of mosquitos and that residents need to check their properties for standing water that could breed them. Valerie also asked if the Village had contracts with Companies for repairs? President Patsche stated yes, we do. Valerie admitted that she has lived in the Village for over 20 years and she has recently discovered we had a pond. Valerie asked if the Village stocks the pond and if we treat the pond with proper chemicals. President Patsche stated that in the last few years, we have stocked the pond and that during Cops n Bobbers every one of the kids was catching fish and that they do treat the pond.

POLICE DEPARTMENT REPORT: Chief Maki provided his report to the Board in their packet. President Patsche read it out loud, Chief Maki stated there were 338 service calls for the month of July, 0 accidents, 127 traffic tickets and 197 warnings written. Flock cameras had not been used in July.

PUBLIC WORKS REPORT: Trustee Eskew stated he has items to be discussed in new business.

ENGINEERING REPORT: Kevin Kuhn, Kuhn & Trello stated he has not heard back from IDOT.

ATTORNEY REPORT: Attorney Craven stated he had nothing to report.

OLD BUSINESS DISCUSSION: President Patsche stated the IDOT Condemnation of Village Property is tabled.

President Patsche stated the Approval of Land Acquisition for IDOT is also tabled.

President Patsche stated that the Approval of Playground Rules for Park Signage should be a special meeting and asked for that to be tabled.

President Patsche asked for discussion and approval of the Purchase and Installation of Gutters on East and West Pavilions. Trustee Eskew stated he was still waiting on a quote and had received one by text for \$2,700.00. Gutters would be 6 inch gutters with 4" downspouts. Following discussion, Trustee Eskew asked to table until the official bids are received.

NEW BUSINESS: President Patsche asked for discussion and approve Unity Church Zoning Variance. Unity Church had provided a letter to the Board and asked for the Board to reconsider the variance for 3157 S 5th Street. Kevin Kuhn, Village Engineer stated that in order to go back to the Zoning board there needs to be a substantial change in the request for the variance and if there is none, the Church would have to wait 18 months before they can request a new variance. The request from the Church would allow them 20 feet past the garage but that the Church would retain the rights to the property to use it for parking. No Trustee made a motion that there was a substantial change to send it back to the Zoning Board and therefore the Church will need to wait for 18 months to resubmit for a variance on the property.

President Patsche asked for discussion and approval of the OSLAD grant application. Kevin Kuhn, Engineer stated that the cost would be \$5,000 to apply for the OSLAD grant for FY 2026. Discussion took place on the park path, tennis courts, dog park, disc golf, and pickleball courts.

Currently there are no cameras that face and can pick up the playground area and there are other areas that need monitored.
