There were concerns raised after the last General meeting about the accuracy of the arrears list that is shown at the meeting. I checked into it on Thursday morning and we found the issue and fixed it. Things can happen and payments may not get to us all the time. Dues are processed on a daily basis. If you pay by credit card, the Hall receives an email and those dues are processed the same morning they are received. If you pay by check, those dues are processed as the mail is delivered. We process approximately 6,500 dues receipts every year, so there will be times when a check is not delivered, an email doesn't show up or the transaction doesn't clear. If you pay your dues by mail or online, you should receive your receipt within 2-5 days, depending on where you live. If you don't receive your receipt in that time frame, please call us so we can make sure it was received and processed or if it hasn't been, we can look to see what happened. The arrears and delinguency lists are generated based on these daily transactions and that is what we publish. With that being said, I want to also call attention to the matter of 2020 dues. Beginning January 1, 2020, dues go up \$1.00 per month. Make sure you factor this into your payments when you pay by check or credit card. Dues for 2020 are available online now. Currently, dues for one month are \$39.00 and a guarter is \$117.00. In January, they will be \$40.00 per month, \$120.00 per guarter, \$240.00 per six months and \$480.00 for the entire year (January through December). If you have any questions about the dues increase or how to make a payment online, please call the Hall at (319) 396-8241.

#### **Positive Self-Talk and Mantras**

We all have a set of messages that play over and over in our head. It can be questions, replaying a conversation in our head, preparing for something pepping yourself up or talking yourself down.

Negative self-talk can unknowingly increase your stress levels and it can stop you from searching for solutions. Shifting your mindset from negative to positive can reduce stress and anxiety. Try writing down the messages that pop into your head. Now try to come up with more positive phrases to override those negative ones. For example, shift from "You can't do anything right" to "learning from mistakes helps me become a better person", or Override "I can't handle this" with "how can I handle this?"

Research shows that silently repeating a positive word or phrase produces powerful psychological changes. Mantras create and strengthen new positive neural pathways rather, than toxic. People utilize mantras to relax, or in times of stress or chaos. Some are simply one word such as "Breathe," "Relax" or "Smile". Others are phrases such as, "I am blessed" "You got this", or "Everything will be alright."

Mantras can be life-changing. The more we repeat them, the happier and calmer we feel.
