BUSINESS MANAGER REPORT

Brothers and Sisters,

Over the past few months, there has been a lot of discussion regarding the DAEC Solar project that is slated to be built over the next couple of years. Recently, Linn County Supervisor Louis Zumbach attempted to place an eighteen-month moratorium on all solar projects in Linn County. Why would he do this? It is no surprise that in just under eighteen months the other two supervisors, both friends of labor, are up for re-election. This was an obvious attempt at political delay tactics, in order to push off any decision-making until after the next election, with the hope that the result of that election is favorable to the opposition. NextEra reached out to Local Building Trades and asked us to help stop this. We all pulled together and showed up in force, spoke against the moratorium and effectively stopped it from happening. Less than a week later, NextEra reached out to us, committing to use Union Labor on this project. This would have been impossible without our involvement in politics on the local, state and national levels. We must support, help and vote for the political leaders that have Labor's back; they fight for the jobs that allow us to provide for our families.

On the political front things have been starting to heat up. This fall there is an election for the Mayor of Cedar Rapids. Those that have announced their bid for that seat are current Mayor, Brad Hart; Tiffany O'Donnell, CEO of nonprofit Women Lead Change and former KGAN anchor; and Amara Andrews, area Businesswoman and community leader. Our friend, Abby Finkenauer, has announced her plans to challenge Chuck Grassley for his US Senate seat in 2022. Breanna Oxley and Liz Bennett have both announced they will each run for Robb Hogg's State Senate seat which will be decided next year. As things start to unfold, we will keep you informed on each of the candidate's platforms, highlighting where they stan on Union/Labor issues so you can make informed decisions on who the best candidates are for our jobs and our future.

Remember to check dues receipts on the job. It is expected that everyone pays their dues on time every month. The process to pay dues has been simplified to alleviate any issues.

Contract Topic of the month

Cedar Rapids & Iowa City Inside and Residential Agreements

<u>Section 3.03.</u> No work shall be performed on Labor Day except in case of emergency, and then only after permission is granted by the Business Manager of the Union.

VDV Agreement

<u>Section 3.04.</u> No work shall be performed on Labor Day except in case of emergency, and then only after permission is granted by the Business Manager where work is being performed.

IBEW Constitution Article XXVI: Jurisdiction Inside Electrical Workers:

Sec. 5. These shall include: wiremen; technicians; fixture men; crane men; crane repair men; load dispatchers; trouble men; switchboard operators and erectors; operators of electrical apparatus when generating, supplying or furnishing electricity for other than distributing companies; inside cable splicers; and picture machine operators when the machines are used for educational or advertisement purpose other than theatrical.

Inspectors, shop men, bridge operators, crane operators, meter testers and installers, inside battery men, fire and burglar alarm installers and repair men, marine electrical workers, glass tube benders and pumpers.

They shall have jurisdiction over the following:

All electrical signs; all street electrical decorations when no messenger or guy wire is necessary for support; installation, construction, inspection, operation, maintenance, and repair of all electrical work in isolation plants and within property lines of any given property, and beginning at the secondary side of the transformer, except line work consisting of poles and towers, including wires or cables and other apparatus supported therefrom and except all outdoor substations as defined in Section 4 hereof.

When aerial wires of cables are used to provide electric current for buildings or structures within the property lines of any given property, the inside men's jurisdiction shall start immediately after the first point of such aerial wires or cables to such building or structures.




All members are welcome to join us at Creek Sportsman's Club on Saturday, Sept. 25th @10AM!
