BUSINESS MANAGER REPORT

Brothers and Sisters

Over the past couple months, the work picture has slowed to its typical winter slump, in part because of the weather, but supply chain issues seem to be the biggest factor that we are hearing about. We don't anticipate that this will be the case in the months to follow. The Coggon Solar Project is scheduled to begin sometime in late March but there are delays in precuring the equipment. At this time, it is not anticipated that the delays will amount to much. We are still waiting for the schedule to come out for the Linn County public hearings for the Palo Solar Project. As soon as we get any information, we will pass it on to the membership through the website and social media.

It has been reported at Building Trades that Iowa Workforce Development has been reaching out to the different trades Union halls to verify the unemployment status of their members that are collecting unemployment benefits. That verification is the out-of-work list and paid-up union dues. We have been fielding a lot of calls about members being asked to furlough or that may be furloughing. When you file for unemployment benefits you are required to be on our out-of-work list and in good standing. If you are not on the list, you could lose the unemployment benefits and/or have to pay back what you have received. Unfilled calls could potentially disqualify you for unemployment benefits. Workforce Development Chapter 24, Claims and Benefits Section 871-24.2(1) b. (3) reads as follows:

Group "5" claimants are individuals who are members of unions, trades, or professionals having their own placement facilities. Claimants assigned to this group will be registered for work. A paid-up membership must be maintained. Contact must be made weekly to check for available work. Loss of membership shall result in an assignment to group "6."

We have scheduled a Stewards Training Class with the IBEW Education Department in April. If you are interested in becoming a job/shop steward, contact the hall to sign up for training. If you have already had the training, we encourage you to take it again as a refresher. If you are unsure and have questions, give us a call.

Built by Pros will once again be doing "Lunchbox Hero's". Beginning sometime in April and going through the summer, Rock 108 will do weekly, live air broadcasts and provide lunch at construction sites in our jurisdiction during the lunch hour. This is similar to what was done in the past with Z102.9.

Remember to check dues receipts on the job, every month, at the beginning of the month. It is expected that everyone pays their dues on time, and it has never been easier to do.

LEGISLATIVE WIRE

There are many Bills working their way through the Iowa Legislature that affect every facet of our lives. While we believe that it is every citizens responsibility to be informed about what is going on with our elected officials, we understand it can be difficult or stressful on top of your day-to-day responsibilities. Therefore, we have put together this list of Bills that only pertain to what affects us as electrical workers. There are plenty of socially divisive issues being pushed in the State House at this time, but we feel our responsibility is to keep you informed of what directly affects us as electrical workers.

<u>SSB 2275 Unemployment</u>- This is the Governors Bill that makes changes to unemployment benefits that we all go to work and earn.

- Creates a one week waiting period
- Cuts benefit weeks from 26-weeks down to 16-weeks
- Cuts the total weeks you can collect if your employer goes out of business from 39-weeks down to 26weeks
- Forces you to take a lesser paying job or lose unemployment benefits

SSB 3096 Unemployment – This is another unemployment Bill designed to cut benefits as well.

• Creates a one week waiting period

- Cuts benefit weeks to 12-16 depending on state unemployment rate
- Increases the amount of work searches per week
- Cuts weekly benefit amount for those with 3 or more dependents
- Makes workers do 20-hours of community service to obtain benefits past 16-weeks, if the Governor declares a statewide disaster emergency

<u>SF 2127 Commercially Owned Solar Panel Field Installation on Agricultural Land</u>- This Bill was introduced by our very own Dan Zumbach (R) of current Senate District 48, which consists of parts of rural Linn, Buchanan, Delaware, and Jones counties. This Bill puts the following restrictions on commercially owned solar.

- The agricultural land must have a Corn Suitability Rating (CSR) of 65 or lower
- There cannot be another field within a half mile
- The solar field must be 1,250 feet away from the nearest neighboring landowner

This Bill would effectively kill utility scale solar in the state of Iowa while also infringing on landowner rights. Now your neighbor can tell you what to do with your land.

This is in no way meant to be a comprehensive list of all the Bills that affect us as electrical workers. If there is something of concern to you that you feel we need to dedicate time and attention to, please do not hesitate to contact us.

ANNULMENT / SUBCONTRACTING:
Cedar Rapids Inside Section 2.25
Iowa City Inside Section 2.24.
Residential Section 2.20

VDV Section 2.11

The Local Union is a part of the International Brotherhood of Electrical Workers and any violation or annulment by an individual Employer of the approved Agreement of this or any other Local Union of the IBEW, other than violations of Paragraph 2.0 fthis Section, will be sufficient cause for the cancellation of this Agreement by the Local Union after a finding has been made by the International President of the Union that such a violation or annulment has occurred.

The subletting, assigning, or transfer by an individual Employer of any work in connection with electrical work to any person, firm, or corporation not recognizing the IBEW or one of its Local Unions as the collective bargaining representative of his employees on any electrical work in the jurisdiction of this or any other Local Union to be performed at the site of the construction, alteration, painting, or repair of a building, structure or other work, will be deemed a material breach of this Agreement.

All charges of violations of Paragraph 2 of this Section shall be considered as a dispute and shall be processed in accordance with the provision of this Agreement covering the procedure for the handling of grievances and the final and binding resolution of disputes.

Are you still installing HIKVISION or Dahua products? If so, you will want to talk to your project manager as these companies are flagged through the FCC as a US national security threat. These companies were put on notice last March as well as their subsidiaries for posing an unacceptable risk for their telecommunication and video surveillance services. The FCC Commissioner stated, "US businesses still dealing in Hikua products should be warned, indicating that anyone buying and selling in Dahua and HIKIVISION products now are not doing so in good faith." The FCC has revoked authorizations for these companies in addition to a one year ban on Hikua products. The full article can be accessed at ipvm.com.
