RESOLUTION OF TOWN BOARD OF THE TOWN OF BETHEL TO ENACT LOCAL LAW #1 OF 2023

WHEREAS, the Town Board of the Town of Bethel has determined that attracting and retaining quality firefighters and ambulance workers is a key component in providing for the safety and welfare of Town residents, but also presents a significant challenge throughout the Town and neighboring Towns; and

The Town Board has also determined "that real property tax exemptions are an appropriate way to recognize the sacrifice and dedication of volunteer firefighters and ambulance workers and are an appropriate tool to help recruit and retain these volunteers; and

WHEREAS, the New York State Legislature has provided for partial real property tax exemptions for volunteer firefighters and ambulance workers pursuant to Section 466-a of the Real Property Tax Law; and

WHEREAS, on September 27, 2023, the Town Board resolved to adopt Proposed Local Law #2-2023 pursuant to Real Property Tax Law Section 466-a and set a public hearing date; and

WHEREAS, a public hearing was held on October 11, 2023 at 7:45 PM at which time public comments on the Local Law where heard; and

WHEREAS, the Town Board received and reviewed all comments that were submitted.

NOW THEREFORE BE IT RESOLVED, that the Town Board hereby adopts Local Law #1 of 2023; and

BE IT FURTHER RESOLVED, that a copy of the Local Law as enacted shall be filed with the Department of State; and

BE IT FURTHER RESOLVED, that Local Law #1 of 2023 shall become effective upon filing with the Department of State.
