# **Committee & Project Updates**

**Dredging (Frank Bright)** – No report.

# Weed Harvesting (Bob Michalski)

- DEC permit application submitted and in process.
- Funding request denied by Wyoming County (not a current priority).
- Exploring smaller pilot project and alternative funding sources.
- Local lead on used harvester in private garage (Daryl Heiby). **Action:** Bob to follow up with Daryl Heiby and develop pilot-project budget for December meeting.

# **Ultrasonic Buoys (Nate)**

- Site visit completed with vendor. One unit covers ~40 acres; requires 4-day continuous operation.
- Full-lake deployment (15 units down centerline) estimated at \$1.5M over 5 years. Proposed test site at north end of the lake near drinking water intakes and area of the outlet with the most HABs.
- Canandaigua Lake running 10-unit pilot.
- Opportunity to integrate water-quality monitoring with Todd Shusky.
- DEC does not have much data on this option and provided link for other HAB treatment options:

- Action: Nate to obtain firm quote for 1-year single-unit pilot (north end near intake).
- Action: Frank to engage Drinking Water Committee for co-funding interest.

**LWRP Phase 2 (Kelly)** - October meeting attended by Frank, Heidi, and Kelly at Charcoal Corral.

• Phase 2 submission in progress; Castile will withdraw if not approved. 43 policies reviewed for any projects; no funding expected for ≥5 years.

**NYSFOLA Annual Meeting** – Rob and Lee. Zebra mussels and HABS – they do clean lake but do not like HABs, so having zebra mussels increases chance of having HABS. They also stir up phosphates as they seek deep living at base of lake.

Talked with CSLAP administrator, (**Alene Onion**, Research Scientist). Arlene provided a table of in-water strategies that can be considered to prevent future blooms or reduce or eliminate an ongoing bloom which can be found at:

Microbial Source Tracking. Evidence-based research on how we can improve lake water – can determine source - cows vs. human. Expanding riparian buffer zones to filter run off and reestablishing hedge rows is beneficial.

Agricultural and Human Nutrients program. \$25 million dollars available for projects that remove farm runoff and improve sewage systems.

Lake Stewards – Canandaigua has engagement people contact the lake stewards and help where needed. **Action**: CLEAN to advertise lake steward position and help recruit for 2026.
