The Wyoming County SWCD works with many stakeholders to secure cost share funding to complete Best Management Practices on farms, implement water quality improvement projects, and stream channel restorations.



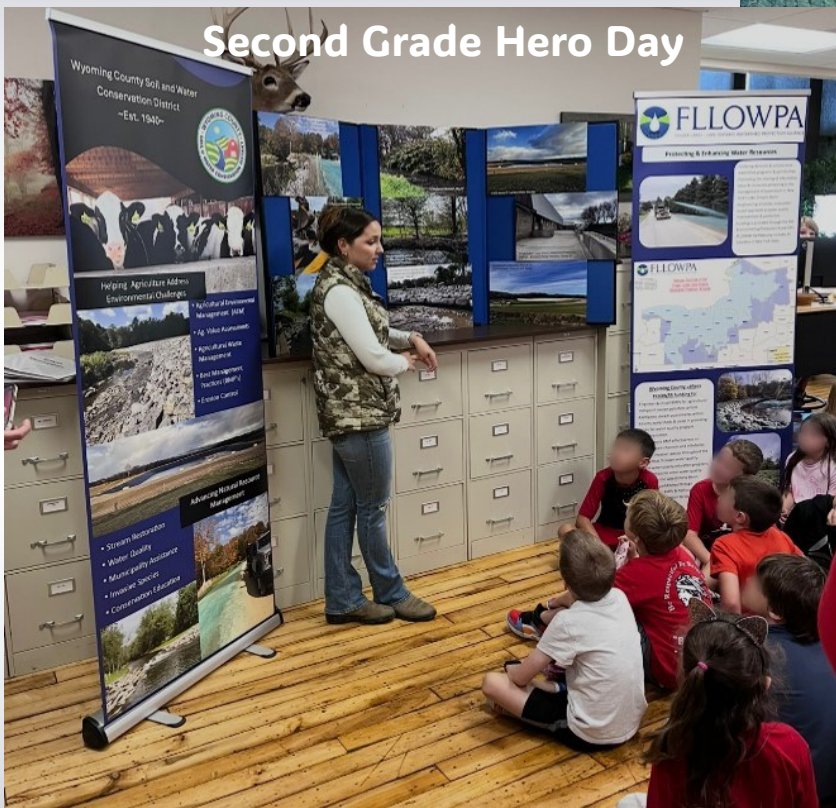

83 Feet of Erosion Control:

This project utilized an erosion control material called Flexamat. This is a mesh erosion fabric with small concrete prisms.

The channel was reshaped and field stone was removed. After rolling out the Flexamat in the reshaped channel, the District hydroseeded the channel and staked erosion socks in the grass swale to prevent runoff into the lake.

Utilized FL-LOWPA funds - Total Project Cost: \$12,674.44

Invasive Species Management

The District utilized FL-LOWPA funds to support the treatment of invasive Japanese Knotweed on the Wiscoy and East Koy Creeks.

Costs in 2025 included contracting A-Tip Control Inc. for herbicide application and the purchase of a new Brush Cutter.

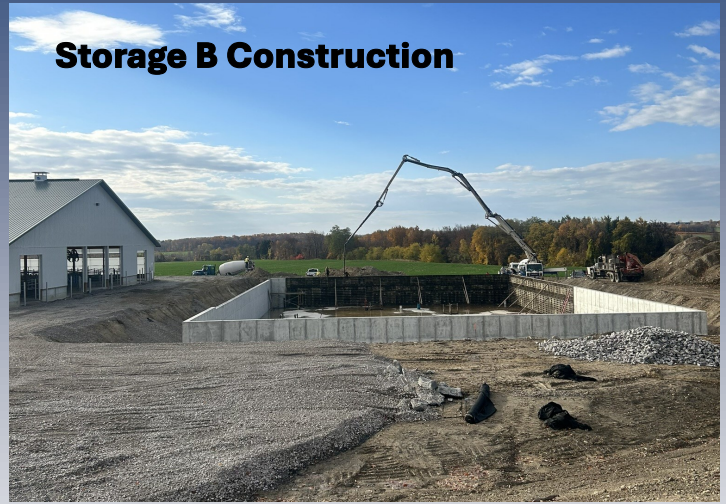


Armson Farms Waste Storage and Transfer System

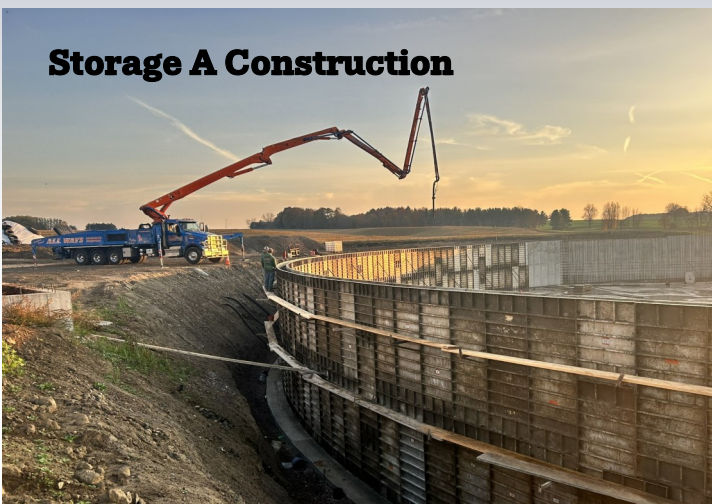

Armson Farms completed a multi-component project in order to improve the water quality in the Genesee River Watershed. The farm's existing earthen manure storage was undersized and had exceeded its lifespan.

Therefore, the project included the closure of the existing earthen storage, and the installation of two new concrete manure storage structures with respective transfer systems that would provide the farm with a total of 5.4 – million – gallons of waste storage. This project also included the establishment of a 0.5 acre riparian buffer.

Camp Samwood – Wiscoy Creek

- 120 feet of streambank stabilization and aquatic habitat restoration
- Engineered log jams were embedded and anchored in the bank for aquatic habitat
- The engineered log jams were comprised of five 20 foot logs cabled together
- The logs were acquired through a timber harvest taking place in the county forest and the County Highway Dept delivered the logs to the project site
- Willow live stakes were installed after all bank work was complete
- The District came in once the site was dry to hydroseed all disturbed ground
- DEC came back late fall to do a tree planting
- Funding was provided by Wyoming County SWCD, US Fish & Wildlife and DEC Fisheries
- Total Project Cost: \$54,182.12



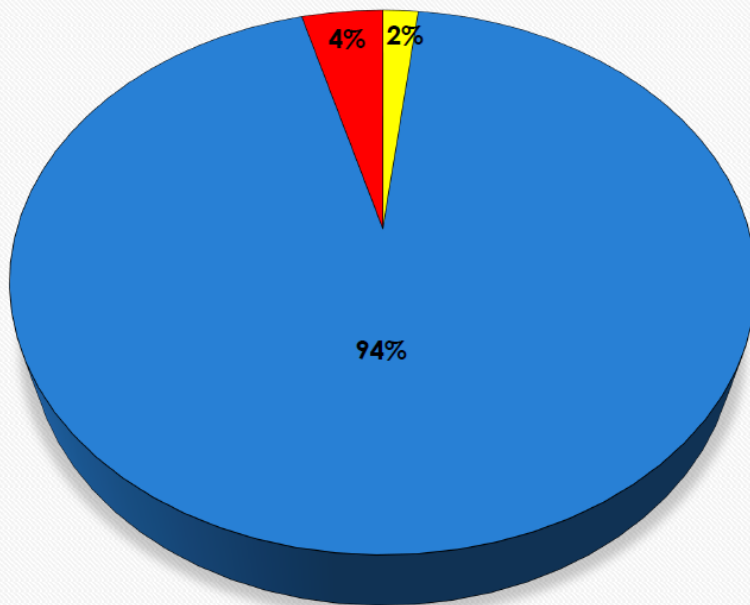
Broughton Farm Operation – Satellite Waste Storage Project

During 2025, Wyoming County Soil & Water Conservation District leveraged \$11,740,147.00 for the \$204,125 investment from the County.

This represents a \$57.51 return for each dollar in County Appropriation Funds to complete conservation initiatives for Wyoming County.

Pingrey Farm 2, LLC currently operates 775 acres, 360 milking cows and 240 replacement heifers. The operation produces silage, haylage, and corn, while striving to improve herd health, land stewardship and efficiency.
