# FOREWORD BY, PRESIDENT, RUGBY FOOTBALL UNION 2023 - 2024

It is a great pleasure to be able to contribute to the Somerset Rugby Handbook and wish you all well for the season. I know that there are many challenges in the game today and I am very aware that many volunteers in your clubs and Constituent Body are working hard to overcome these difficulties.



The impact of Covid and the many months without contact rugby added to the challenges already apparent in the community game. These include societal changes which have brought about the players wanting to play less frequently, fear of injury, rugby participation in schools, difficult economic conditions, the transition from age grade to adult rugby and reducing numbers playing rugby in schools. #### Nominations for Officers of the Union

Members and Honorary Secretaries are reminded that under the Bye-Laws of the RUGBY FOOTBALL UNION nominations for the Representative of the Somerset Clubs must be sent to the Honorary Secretary of the County before 1st March and that under the Rules of the Somerset County RFU Ltd nominations for Officers must be received by 30th April.

RFU Rule 18 – Election of Constituent Body Representatives to the RFU Council RFU Council representative term of office is three years from date of appointment. The current term runs from August 2023 to 31st July 2025. The position is up for election / re-election in March 2026.

The election of representatives to the Council shall be made before 1st April each year. All candidates for election or re-election must be proposed by one and seconded by another club comprising the relevant Constituent Body including itself. Every nomination must be in writing and must be received by the Secretary of the Constituent Body by no later than 1st March.

# ROLES & RESPONSIBILITIES OF SUB-COMMITTEES

#### Finance & Governance

Produce a 3-year rolling County Strategic Plan consistent with the RFU's Plan and review it on an annual basis

Establish and maintain an infrastructure for the organisation and management of SCRFU member clubs under the RFU Rules and Regulations.

Assist the RFU in the delivery of the Game and the RFU's policies. Support the collective and strategic aims of the RFU.

Support the organisation and administration of the Game including providing such expertise to the RFU Council, its Committees and Working Parties as may be required from time to time.

As far as possible, maintain and extend the number of clubs and individual members in membership of SCRFU.

Provide support and all necessary representation to the RFU and other appropriate bodies and groups.

Provide adequate level of medical facilities at all SCRFU representative matches and maintain a duty of care to all those who have been seriously injured.

Promote the Game at all levels by actively marketing the SCRFU's activities, seeking out sponsorship and funding opportunities for SCRFU and its member clubs.

Provide information and advice to SCRFU member clubs and individual members on matters of mutual interest.

Provide seminars and forums to facilitate opportunities for all SCRFU member clubs on matters affecting them.

Act as a communication channel between clubs, districts and the RFU particularly through the Council Member.

Develop links through the media.

Facilitate and encourage links with other recreation and leisure bodies. Draw up annual budgets and establish budgetary control procedures. Finance activities in compliance with RFU Regulations.



#### Competitions

Organise and manage, where appropriate, competitions including cups, leagues and merit tables for SCRFU member clubs.

#### Discipline

The Disciplinary Panel deals with all disciplinary matters on behalf of the Management Committee under powers delegated by the RFU Support and liaise with SCRFU Referees Society and clubs where appropriate.

Club Secretaries and Match Officials are requested to familiarise themselves with the disciplinary procedures in the RFU Handbook and to follow the regulations shown.

All clubs are required to appoint their own Club Discipline Panel.

The Disciplinary Panel will meet as and when required to discharge its duties. The administration charge for the current season in respect of cases arising is £50 and is payable before a case is heard. The Disciplinary Panel is empowered to levy discretionary fines for any breach or non-conformance with RFU Disciplinary procedures in addition to the administration charge.

It is required that all clubs should report the details of any sending-off, in line with the requirements of the RFU Disciplinary procedures, within 48 hours of the end of a match, to the County Disciplinary Secretary.

Match Officials are also required to submit their clear formal reports to the County Disciplinary Secretary within 48 hours after the end of a match.

Both these requirements apply to all matches, including youth and junior games. For information relating to 'Citings' refer to the RFU Handbook.

# SOUTH-WESTERN DIVISION RUGBY FOOTBALL MUTUAL BENEFIT FUND

The fund, founded by the late Tom Lean of Plymouth in 1920, is administered by official representatives of Cornwall, Devon, Gloucestershire and Somerset, to provide financial assistance to players, officials and referees, or, in the case of death where there is hardship, to relatives of the same.

The assistance given over the years has been considerable, but owing to the development of the game on a more physical basis the number of injuries is not only increasing, but becoming more serious, and the question of insurance is a matter which should be looked into. There are still a number of clubs in the South West who have apparently overlooked the important factor of making sure their players are adequately covered against any injury and the attention of every club is therefore drawn to the advantages to be obtained from taking up Membership of the South Western Mutual Benefit Fund.

- 1. The insurance taken up with the Fund for loss of earnings Benefit will now cover up to £50 PER DAY. (All claims are based on a 6-day week.)
- This year the RFU will pay for the Compulsory and Public/Employers Liability direct.The fund has therefore reduced the Premiums to show this.
- Maximum period of Benefit is 156 days, although this can be increased in special circumstances at the Committee's discretion.
- In addition to LOSS OF EARNINGS BENEFIT, cover also includes PHYSIOTHERAPY and DENTAL TREATMENT not available under the DHSS.
- 5. You will see the Fund was founded in 1920 under the aegis of the South West Constituent Bodies for rugby people.

#### WARNING

An upsurge in the number of casual games such as Pub XVs has been reported. Club officials would be well advised to inform their players that they are unlikely to be covered for any form of insurance when playing in games not on a club's normal fixture list.

#### IMPORTANT NOTICES

Death from Heart Failure or Collapse does not come within the cover afforded by the Rules of the Fund.

Death by Natural Causes cover can be obtained from the RFU.

If claims are not notified in accordance with the rules, and the correct information given, then a claim may be rejected.



#### NOTES FOR THE GUIDANCE OF CLUBS RE PRACTICE MATCHES

Your attention is drawn to the following:

#### **RULE 8, CLAUSE C**

Claims for compensation shall be paid only for accidents to players occurring on the field of play during the progress of a bona fide match or practice game.

#### Note:

Either Bona fide matches and practice games must appear on the Club fixture list or official notification must have been sent to the Honorary Secretary of the Fund. Ordinary club 'kickabouts' or practice sessions which do not comply with these conditions are NOT covered.

#### CLAIMS PROCEDURE

- Immediately a player is injured in the field of play, his Club Secretary must be informed.
  The Honorary Secretary of the Fund should receive the Claim Form with all relevant
  documents requested within TWENTY-ONE DAYS of the injury or the claim will be
  REJECTED.
- Nett Weekly Wage is the actual amount received by the player after all statutory deductions such as NHS, Tax, etc., have been deducted and it is essential copies or proof of wages are sent.
- As soon as the player has been declared fit to resume his occupation, the final medical certificate should be sent to the Honorary Secretary of the Fund, when benefit due will be paid, providing everything is in order.
- It is primarily the responsibility of the player and his Captain to ensure the Official dealing with insurance is notified without undue delay of any injury to a player.

# THE SOMERSET CUP & VASE REGULATIONS 2023-24

#### **DEFINITIONS:**

CLUB/TEAM means club or team entitled to take part in the competition.

Committee means Competitions Sub-Committee of the County Union.

**Competitions Organiser** means the person to whom the Committee delegate the administration of the Competitions.

County Union means the Somerset County Rugby Football Union Limited

Home Clubs defined by Regulation 4.2 & 4.3

RFU means the Rugby Football Union

Society means the Somerset County Rugby Football Union Referee's Society Limited.

**Weather Conditions** shall be deemed to include but not be limited to bad or inadequate light as decided by the match Referee.

**World Rugby** means the world governing body of the game of which at the date of the adoption of these Rules is the International Rugby Board of which the Union is a member.

**World Rugby Regulations** means the Resolutions and Regulations relating to the game promulgated by World Rugby from time to time.

#### DESCRIPTION AND FORM

- 1.1 the Competitions shall be called "The Somerset RFU Cup, The Somerset RFU Vase and, if required, The Somerset RFU Bowl" (The Competitions). These Rules apply to all of these Competitions.
- 1.2 All matches in the Competitions shall be played under the World Rugby Laws of the Game and the Regulations of World Rugby and the RFU current at the commencement of the Competitions in so far as the same are not varied by or inconsistent with the Regulations. Where there is any conflict between the World Rugby and/or the RFU Regulations and these Regulations, then these Regulations shall prevail.

#### ORGANISING COMMITTEE

- 2.1 The Competitions shall be organised and administered by the Committee.
- 2.2 The Committee shall have the power to delegate any of its duties, powers or obligations under these regulations to a Competitions Organiser.
- 2.3 Subject to the provisions of Regulation 13, decisions of the Committee shall be final and binding on any matter not provided for in and on the interpretation of these Regulations.



#### **ELIGIBILITY OF CLUBS/TEAMS AND PLAYERS**

- 3.1 The Cup Competition will be open to member clubs of the County Union that play at Counties 1 (Level 7) or above. The remaining teams are eligible for the County Vase competition. However, with regard to a University or College that does not take part in The English Clubs Rugby Union Championship, then the Committee may in its absolute discretion place that team in the Competitions after giving due consideration to its playing strength. Only one team from each club will be eligible to enter one or other competition.
- 3.2 Any Club wishing to participate must signify its wish to do so to the Competitions Organiser by the date set by them. In the interests of promoting participation in the competition, there will be no requirement to lodge a Bond.
- 3.3 The Competitions will proceed with the number of clubs that have signified that they wish to enter.
- 3.4 In the event of a club or team unjustifiably failing to fulfil a fixture, the Committee may exclude it from the Competition.
- 3.5 A club shall play or select as replacements only players who on the date of the match are bona fide members of that club. In the case of a club that is a University or College, they shall only play Eligible Participants as defined by the British Universities & Colleges Sport Regulations.
- 3.6 A club shall not be represented in the front row of a scrummage by any player under 18 years of age, whether the scrummage is contested or uncontested.
- 3.7 A club shall not be represented by a player who has either played in or been selected as a replacement for any other club in either Competition. Any player who has played or been selected for any club in any team or squad which plays at Level 4 (National 2) or above five times shall become ineligible to play in either competition.
- 3.8 A club may select up to seven replacements/substitutes. If the match squad contains twenty-two players, then it must contain five players capable of playing in the front row. (Rolling substitutions are allowable to a maximum of twelve interchanges.)
- 3.9 In the interest of safety, each team playing in each match in the Competitions must have at least five players in their nominated match squad, all at least 18 years old, who are suitably trained and experienced to be capable of playing in the front row to ensure that on the first or second occasions (whether owing to injury or consequent to a player(s) being temporarily suspended or ordered off) that a front row player is required to be replaced, the team can continue to play safely with contested scrums.



- 3.10 If in any match on the first or second occasion any front row player requires to be replaced and his team cannot provide a suitably trained and experienced replacement player at least 18 years old to play in such position in the front row of the scrum to enable the teams to continue to play safely with contested scrums (the referee having made enquiry of and confirmed this fact with the captain of the team or such other person nominated by the Club as the manager or other person responsible for the team), the match will continue with uncontested scrums and the offending team will be prevented from replacing the injured player(s). Subject to Regulation 3.13 below, the final result will stand.
- 3.11 Subject only to the proviso contained in Regulation 3.12 below, if in any match in the Competitions on the third or subsequent occasion any front row player requires to be replaced and his team cannot provide a suitably trained and experienced replacement player to enable the teams to continue to play safely with contested scrums (the referee having made enquiry of and confirmed this fact with the team captain or other person nominated by the Club as manager or other person responsible for the team), the match will continue with uncontested scrums. Subject to Regulation 3.13 below, the final score will stand.
- 3.12 Where a player or players is/are temporarily suspended from the field of play (which includes a blood injury), which creates a third or subsequent occasion that a front row player needs to be replaced and his team cannot provide a replacement or other player aged 18 years of age or older suitably trained and experienced to enable the team to play safely with contested scrums the referee having made enquiry of the team captain (or other person nominated by the Club as manager or responsible for the team) of the side affected, the match shall continue with uncontested scrums (but such uncontested scrums shall continue only for the duration of the temporary suspension). The match result will not be deemed to be invalidated by reason of part of it being played with uncontested scrums.
- 3.13 The Committee will review the circumstances in every case where a match in the Competitions is completed with uncontested scrums. The Committee will be entitled to take any such action as it deems appropriate (such action may include reversal of the match result, a fine and/or payment of compensation, and/or disqualification from the Competitions in the Season and/or the following season, the inclusion of the non-offending team in the next round of the Competitions and/or requiring that the match be replayed) where the Committee finds that there has been a breach of any Regulation governing the Competitions or that a Club in a match in the Competitions acting other than in good faith has taken advantage of the provisions of this Regulation 3.5 and in particular 3.10 and 3.11.

**Note:** The intention of Regulations 3.9 to 3.13 (inclusive) is to penalise Clubs who try improperly to take advantage of a situation to ensure a match is played (or finished) with uncontested scrums.



#### THE COMPETITIONS FORMAT AND DRAWS

- 4.1 The Competitions shall comprise the number of rounds appropriate to the number of clubs participating, including semi-finals and a final.
- 4.2 The first named club to be drawn in a match prior to the semi-finals shall be the home club, and, unless otherwise agreed, the venue for that match shall be the ground of that home club.
- 4.3 The home club in the semi-finals and final shall be determined by the Competitions Committee
- 4.4 The semi-finals and finals shall be played at neutral venues as determined by the Committee unless otherwise agreed by the clubs and the Competitions Committee as and when appropriate.
- 4.5 Draws shall be arranged by the Competitions Committee as and when appropriate.
- 4.6 All Matches shall be played on fixed dates determined by the Competitions Committee unless some other date is specified by the Competitions Committee or the Clubs concerned mutually agree to rearrange the date and such rearrangement has been approved by the Competitions Committee. Matches in the Competitions take precedence over all other fixtures save for those in the English Clubs Rugby Union Championship or any other RFU arranged competitions.
- 4.7 A match may be played on a date in advance of the fixed date or at a different venue if both clubs agree in writing to that effect at least forty-eight hours before the match is due to take place and such rearrangement(s) has/have been approved by the Competitions Committee.

**Note:** Clubs must bear in mind the effect of any rearrangement(s) on (i) the following rounds of the Competitions to ensure they are not necessarily delayed and (ii) the availability of Match Officials.

#### DRAWN MATCHES

- 5.1 In all matches up to and including quarter-finals, if after forty minutes of play each way the scores are level, there shall be a five-minute break. After this break, the teams will change ends and there shall be a period of extra time between the teams of ten minutes each way, with a one-minute interval. If the scores are then still equal, the team that has scored the most tries goes forward into the next round. If this does not produce a result, the team that has scored the most goals from tries shall go forward into the next round. If the scores, number of tries and goals from tries are still equal, the visiting team shall go forward into the next round.
- 5.2 in the semifinals and final, if after forty minutes of play each way the scores are level, there shall be a five-minute break.



After this break, the teams will change ends and there shall be a period of extra time between the teams of ten minutes each way, with a one-minute interval. If the scores are then still equal, the team that has scored the most tries shall be the winner. If this does not produce a result, the team that has scored most goals from tries shall be the winner. If no result is then achieved, the result shall be decided in the following manner.

Each team shall nominate one player from its number on the field of play at the final whistle to participate on its behalf in a "sudden death" place kicking competition.

Each kicker in turn shall attempt a place kick from pre-determined positions until such time as after an equal number of attempts one kicker has kicked more goals than the other.

These attempts will be made towards the goal posts (determined by the Referee) and the first kick shall be taken by the team that kicked off at the commencement of the match. The attempts will be taken in the following positions (in turn) repeating the sequence until a decision is reached: -

- a. The centre of the 22m line.
- b. Intersection of the 22m line and 15m line to the left of the posts facing.
- c. Intersection of the 22m line and 5m line to the left of the posts facing.
- d. Intersection of the 22m line and 15m line to the right of the posts facing.
- e. Intersection of the 22m line and 5m line to the right of the posts facing.

#### POSTPONED AND ABANDONED MATCHES

- 6.1 If weather conditions prevent a match being played or a match is abandoned because of such conditions with less than sixty minutes having been played, it shall be played or replayed before the date of the next round on a day and at a time agreed by the two clubs concerned and by the Committee. If there is no agreement within 4 days of the date of the match which was not played or was abandoned or if the date and time agreed between the two Clubs are not acceptable to the Committee, the date and kick-off time will be as directed by the Committee upon the application of either Club.
- 6.2 If a match is abandoned because of weather conditions when sixty or more minutes have been played, then the score at the moment of abandonment shall stand and be deemed the final score in the match. The Referee's decision as to the necessity for abandonment and the number of minutes played at the moment of abandonment shall be final.
- 6.3 If the Referee finds it necessary to abandon a match for any reason other than weather conditions, then, irrespective of the number of minutes played, the result of that match will be determined by the Committee. The Committee may order the match to be replayed, in which event the match will take place on a date and venue directed by the Committee.



#### **GROUNDS**

- 7.1 The home club (other than in the semi-finals and final) is responsible for correctly and clearly marking its pitch. In addition, it must make proper provision to ensure that (with the exception of the touch judges, fourth official, doctor or first aider/other suitably medically qualified person and one water carrier from each club) all spectators, replacements, coaches' replacements and others are kept at a reasonable distance from the field of play.
- 7.2 When a late decision (i.e. a decision made or to be made within three hours of the scheduled kick-off time) as to the fitness of a pitch for the playing of a match is necessary, it shall be made by the respective captains (or nominated representatives) of the clubs involved, but if the captains are not able to agree, an opinion as to the fitness of the pitch shall be made by the appointed Referee.

**Note:** The Referee's responsibility is limited to deciding whether or not the pitch is in his opinion playable. Any decision reached that a game should or should not commence is the decision of the Clubs concerned.

7.3 The home club must ensure full compliance with RFU Regulation 9 with particular reference to Regulation 9.3 - Pitch-Side First Aid and Immediate Care Provision for all matches, details for which can be found on the England Rugby website at www.englandrugby.com, under the Participation heading - Player Welfare - Rugby Safe links.

#### MATCH OFFICIALS

8.1 The Society shall appoint or arrange for the appointment of match officials for all matches. The home club shall be responsible for liaising with (i) the appointed match officials as to the match arrangements (ii) the Society at the earliest opportunity in relation to any proposed change in the match arrangements and (iii) with the appointed official(s) directly to ensure that such official(s) is/are aware of rearrangements and has/ have the appropriate directions to the venue of the match (or any change of venue).

#### CLASH OF COLOURS/IDENTIFICATION OF PLAYERS

- 9.1 In the event of clubs having similar or clashing colours, the away club shall be responsible for changing its colours subject to the satisfaction of the appointed referee.
- 9.2 The jerseys of teams competing in the Competitions shall be numbered in accordance with World Rugby requirements to ensure the correct identification of all players and replacements during a match.

#### KICK-OFFS AND DELAYED ARRIVALS

10.1 All scheduled matches shall start at the time notified by the home club to its opponent club not less than three days prior to the match, and shall be between 2pm and 3pm on weekends and public holidays and between 7pm and 8pm on weekdays.



An alternative kick-off time may be agreed by the Committee. A kick-off time may be specified by the Committee if upon appeal by the opponent club the Committee deems the time specified by the home club unreasonable. Any delay in kicking-off from the pre-determined time may be reported by the non-offending club to the Committee, which may impose such penalty as it sees fit.

#### **NOTIFICATION OF RESULTS**

- 11.1 The Secretary of the club qualifying for the next round is responsible for informing the Competitions Administrator of the result of a match within forty-eight hours of the conclusion of the match.
- 11.2 Match cards will be required for each team in each match with players' details being scrutinised against the relevant GMS/EMC database. Each match result card must specify the result of the game, including number of tries scored for each side and a list of the players and replacements involved and must be signed by a club official and the match Referee. Results will be processed onto GMS.

#### **FINANCE**

- 12.1 Semi-final and final matches only in the Competitions shall be "gate taking" matches and shall be "all pay" save for those attending who are under 16 years of age.

  The gross receipts from the semi-finals and final shall be delivered to the Competitions Administrator, who shall deduct proper expenses and the balance shall be divided as to one-third to each of the participating clubs and one-third to the County Union.
- 12.2 To encourage participation in either of the competitions there will be a winner's prize of £300 for the Cup and £150 for the Vase.

#### PROTESTS, DISPUTES AND TRANSCRESSIONS

- 13.1 Any complaint of an alleged breach of these Regulations must be made to the Competitions Organiser immediately by telephone, or as soon as possible, and written confirmation thereof be sent within forty-eight hours of the cause of the complaint in full. The Committee shall have absolute discretion (and using such procedures as in its absolute discretion it deems appropriate) to resolve any such complaint as it shall see fit and may decline a complaint validly made if it considers doing so to be in the interests of the Competitions generally or the game of Rugby Football. Subject only to the provisions of Regulation 13.2, the decision of the Committee shall be final and binding.
- 13.2 Where any party having an interest in the matter is aggrieved by any decision of the Committee taken pursuant to Regulation 13.1 above or otherwise in relation to the Competitions, it shall have the right to appeal that decision within forty-eight hours of the decision of the Committee being announced, giving full details of the grounds of such appeal and supplying all evidence upon which it wishes to rely.



- In submitting its application, the Complainant Club must lodge a fee of £100, which payment will be refunded if the appeal is upheld.
- 13.3 The Management Committee in dealing with any appeal may use such procedure as in its absolute discretion it may decide.

#### TERMS AND CONDITIONS OF PARTICIPATION

- 14.1 Each club in consideration of the monies received by it from the County Union or any funding from a sponsor(s) whether or not received direct from the sponsor(s) or any third party for participating in the Competitions agrees that by commencing its first match in the Competitions it has entered into a legally binding obligation with the County Union and separate obligations with each other club in the Competitions and with any sponsor(s) of the Competitions that it will fulfil its fixtures in the Competitions, comply with these Regulations and will indemnify any club which suffers loss due to failure to fulfil a fixture subject to the duty of the loss sustaining club to mitigate its losses so far as reasonably practicable.
- 14.2 Any club agreeing to play in the Competitions agrees that by entering or commencing its first match in the Competitions it has entered into a legally binding obligation with the County Union, any sponsor of the Competitions and as a separate covenant with each other Club in the Competitions, Referee, Touch Judge or Match Official involved in any match in the Competitions or cancellation or abandonment thereof that it will not hold liable or make any claim against such official, the Committee or the County Union:

  or any loss, charge, compensation or expense arising out of or in connection with any

kind of injury or illness suffered by any player, spectator or other person,

- for any damage to property of any kind,
- for any other loss, cost, charge, expense or damages be it financial or consequential loss of profit or additional expense incurred or otherwise and whether directly or consequential or in relation to the result of any match, arising out of or due to any decision or action that may be taken under the Laws of the Game these Regulations or any other rules or regulations published by the RFU or in respect of the normal procedures to hold, play, control or abandon a match.

# THE SOMERSET RFU JUNIOR CUP & VASE COMPETITION - REGULATIONS 2022-2023 SEASON

#### DEFINITIONS

Committee means the County Union's Competitions Sub-Committee

**Competitions Organiser** means the person to whom the Committee delegate the administration of a Competition

County Union means the Somerset County Rugby Football Union Limited

Home Clubs defined by Regulation 4.2 & 4.3

RFU means the Rugby Football Union

Society means the Somerset County Rugby Football Union Referee's Society Limited.

**Weather Conditions** shall be deemed to include but not be limited to bad or inadequate light as decided by the match Referee.

**World Rugby** means the world governing body of the game of which at the date of the adoption of these Rules is the International Rugby Board of which the Union is a member.

**World Rugby Regulations** means the Resolutions and Regulations relating to the game promulgated by World Rugby from time to time.

#### DESCRIPTION AND FORM

- 1.1 The Competition shall be called the Somerset RFU Junior Cup Competitions and will be open to Youth teams from each club in membership of the Somerset RFU plus any teams from other Counties at the discretion of the Organising Committee.
- 1.2 All matches shall be played under the World Rugby Laws and Regulations (including any variations, trials and other formats that may be adopted by the RFU), World Rugby Regulations and RFU Rules and Regulations, specifically Regulation 15, in so far as the same are not varied by or inconsistent with these Regulations. Where there is any such variation or inconsistency then these Regulations shall prevail.
- 1.3 All matches in each Competition shall be played on Sundays determined by the Committee, unless either team is a participant in the Somerset U18 league.
- 1.4 If either team is a participant in the Somerset U18 league then regardless of being either the home team or the away team, they will decide on which day of the week the match is played (apart from the final which will be a Sunday).



- 1.5 Clubs may mutually agree to play a match (other than the final) prior to any fixed date and on any other day of the week if it conforms with the RFU Age Grade Calendar and is confirmed as acceptable by the Competitions Administrator.
- 1.6 Any club refusing to play a match on the date determined by the Committee shall not be eligible to enter a Competition or to continue participation.
- 1.7 The draw will be made by the Committee and for the first-round matches shall be played on the ground of the club drawn first.
- 1.8 In each subsequent round (except for the final) the home team will be the team that had the greatest points difference from the previous round.
  - 1.8.1 The points difference cannot exceed 50 points.
  - 1.8.2 If the points difference is equal the home team for the subsequent round will be drawn by the committee.
  - 1.8.3 If a team progresses for any reason other than winning the previous round, then the home team for the subsequent round will be drawn by the committee.
- 1.9 The final shall be played on neutral grounds to be determined by the Committee.
- 1.10 A Home Club is responsible for the correct and clear marking of its pitch and must make proper provision to ensure (that except for touch judges, fourth official, Affiliated Medical Practitioner or other suitably medically qualified person and one water carrier from each team) all spectators, coaches, replacements and others are kept at a proper distance from the field of play.
- 1.11 The club must ensure full compliance with RFU Regulation 9 Player Safety. In particular each club entered must have completed the following:
  - \* Howden online risk assessment https://www.howdengroup.com/uk-en/england-rugby-insurance/risk-assessment-tool
  - \* Risk Assessment and GMS Player Welfare page completion report on GMS The required medical provision for each match must be at least 1 x Emergency First Aider per team.

Further details can be found on the England Rugby website at www.englandrugby.com under the Participation heading - Player Welfare - Rugby Safe links. www.keepyourbootson.co.uk has more in-depth detail if required.



#### ORGANISING COMMITTEE

- 2.1 The Competitions shall be organised and managed by the Competitions Administrator whose decisions, subject to a right of appeal to the Committee set out in Regulation 9 will be binding and final on any matter but specifically:
  - a) The interpretations of these Regulations.
  - b) Any dispute between competing Clubs.
  - c) Any matter not provided for in these Regulations.
- 2.2 The Committee shall have the power to delegate any of its duties, powers, or obligations under these Regulations to a Competition Administrator.
- 2.3 Decisions of the Committee or the Competitions Administrator shall be final and binding.

#### **ELIGIBILITY OF CLUBS & PLAYERS:**

- 3.1 All clubs in membership of the Constituent Body shall be eligible to enter a team in any Competition but must signify to the Competition Administrator their wish to do so no later than "The date specified on the entry form". The Club or amalgamated clubs should signify their team's name at registration, and this will remain for the season.
- 3.2 The Committee shall have the power to exclude any team from any Competition at any time.
- 3.3 Players shall be eligible to play in any Competition if they are under the relevant age at midnight on 31st August. Any dispensation given by Somerset RFU for Playing out of Age Grade must also be declared to the Committee. For anyone who is playing out of Age to be eligible for this competition they must have dispensation from Somerset RFU before the match.
- 3.4 Players must be properly affiliated to their Club on the RFU Game Management System (GMS)
- 3.5 Only players fully affiliated with the RFU Game Management System (GMS) prior to the closing date for entry in the year of the competition will be eligible, any team fielding a player with a GMS effective date after this date will be removed from the competition.
- 3.6 No later than 48 hours prior to the match being played each team shall issue a team sheet to the competition administrator for validation. The competition administrator shall issue a validated result sheet to both teams as soon as is practicable to the relevant teams. Once issued no changes can be made.



- 3.7 Prior to any match the result sheet supplied by the competitions administrator shall be mutually validated by the coach(es)/team manager(s) of each team against the teams RFU photo registration cards or RFU photo registration lists. Any picture must be no more than 1 season old and unjustifiable failure to produce such cards or list for inspection will lead to expulsion from the Competition.
  - Note: the home club should, when confirming kick-off times and other arrangements, remind the away team of the need to produce their players' registration lists on the day of the match.
- 3.8 Clubs shall not be represented by a player who has played for another club in this Competition.
- 3.9 The maximum match day squad size is twenty-three players.
- 3.10 For all contested Scrums only suitably trained and experienced front row Players can be used.
- 3.11 If on any occasion a front-row player requires to be replaced and his team cannot (for any reason, including injury, temporary blood injury, temporary exclusion following a yellow card, or permanent exclusion following a red card) provide a replacement, or another suitably trained and experienced player from the nominated squad, to enable the match to continue safely with contested scrums, the Referee, having made enquiry of and having confirmed this fact with the manager of the team (or such other person nominated by the Entrant as the person responsible for the team), the match will continue with uncontested scrums. The team concerned shall not be entitled to replace the player whose departure caused the uncontested scrums and the final result will stand. On return to the field of play of the front-row player who had been temporarily excluded or injured, the Match shall continue with contested scrums

#### MATCH OFFICIALS:

- 4.1 The home team is responsible for obtaining a society referee, should a suitable neutral referee not be available, then the home team with the agreement of the opposition may use a suitable alternative (who shall hold an RFU refereeing qualification). Each team will supply one touch judge.
- 4.2 The Committee shall appoint a referee plus two touch judges for the finals.



#### **DETERMINATION OF MATCH RESULTS:**

- 5.1 For matches other than the final, the tiebreakers in the instance of a draw will be: number of tries, number of conversions, first try scored and then first points scored. If the match finishes 0-0 then a coin toss will take place to determine who progresses to the next round.
- 5.2 Should a fifty-point differential occur at any time during a match, then the score must be recorded as the result and the referee may end the match.
- 5.3 If the scores in a final are level at the end of normal playing time and 5.1 above fails to produce a result then the Competition trophy shall be shared. Which club shall hold the trophy for the first six months and which the second six months shall be decided by the toss of a coin. The winner of the "coin toss" shall have the option to decide for which six-month period the trophy will be held.

#### NOTIFICATION OF MATCH RESULTS:

6.1 An electronic copy (email, photo, etc) of the validated result sheet, signed by both teams and the match official must be sent to the Competitions Administrator within 48 hours of the end of the match.

#### **CLASH OF COLOURS:**

- 7.1 In the event of clubs having similar or clashing colours the home club shall be responsible for changing its colours subject to the satisfaction of the match referee.
- 7.2 The shirts of teams shall be numbered in accordance with World Rugby requirements to ensure the correct identification of all players and replacements during a match.

#### KICK-OFFS AND DELAYED ARRIVALS:

8.1 Matches (except the finals) shall start at a time notified by the home club to their opponents (not less than 3 days prior to the date prescribed for the playing of the match) but it shall not be later than 2.30 pm unless the opponents agree otherwise. A kick-off time may be determined by the Committee if, upon appeal by an opponent club, the Committee deem the time specified by the home club to be unreasonable. Any delay in kicking-off from the agreed or pre-determined time may be reported by the non-offending club and the Committee may impose any sanction it sees fit, which may, for the avoidance of doubt, mean the expulsion from the Competition of the offending club.

#### DISPUTES:

9.1 Any matter in dispute between participating clubs shall be notified to the Competitions Administrator as soon as it becomes apparent or, if occurring during a match, within 24 hours of the end thereof.



Written confirmation of the details of the complaint or dispute must reach the Competitions Administrator 48 hours after the initial notification and shall set out fully the nature and cause of the complaint. The complaint should include the following areas in addition to any cause for citing a player during any passage of play not dealt with by the referee at the time which will be referred to the CB Disciplinary Committee Secretary.

- Breach of any requirement to comply with Regulation 9 Player Safety and First Aid Cover
- ii) Lack of an up-to-date Risk Assessment for the match arrangements.
- iii) Any Safeguarding issue and whether an appropriate Safeguarding Officer was present.
- iv) Whether alcohol misuse was observed by any under-age individuals.

With the exception of any Safeguarding issues which should be passed directly to the Playing Out Of Age Grade Committee (POOAG) the Committee shall have absolute discretion (and using such procedure as in its absolute discretion it deems appropriate) to resolve any such complaint as it shall think fit and may decide to accept a complaint validly made if it con siders doing so to be in the interests of the Competitions generally or the game of Rugby Football. Subject only to the provisions of Regulation 9.2 the decision of the Committee shall be binding and final.

- 9.2 Where any party having an interest in the matter is aggrieved by any decision of the Committee taken pursuant to Regulation 9.1 above or otherwise in relation to the Competitions it shall have the right to appeal that decision to the Management Committee of the Constituent Body by so notifying the competition administrator in writing (within 48 hours of the decision of the Committee being announced) giving full details of the grounds of such appeal and supplying all evidence upon which it wishes to rely. In submitting its application, the complainant Club must lodge a fee of £100, with the exception of any Safeguarding issues, which payment will be refunded in full if the appeal is upheld.
- 9.3 The Management Committee in dealing with any appeal may use such procedures as in its absolute discretion it may decide.



#### POSTPONED AND ABANDONED MATCHES:

- 10.1 If weather conditions (which includes bad light) prevent a match from being played or a match is abandoned because of such conditions with less than two thirds of the proper playing time having been played it shall be played or re-played before the date of the next round on a day and at a time agreed between the clubs or failing agreement as determined by the Committee. If there is no agreement within 48 hours of the match which was not played or was abandoned or if the date and time agreed is not accept able to the Committee, then the date and time of kick-off shall be determined by the Committee.
- 10.2 If ground or weather conditions prevent a match being played at the grounds of either Club, (or neutral venue) then the Committee will select the team to progress at random. In the event of this occurring the home or away team in the subsequent round will also be selected at random.
- 10.3 If a match is abandoned for any reason other than weather conditions then, irrespective of the number of minutes played the result of that match shall be determined by the Committee who may order the match to be replayed in which case the match will take place at a venue and a time determined by it.

#### REMINDERS:

11.1 Coaches and officials must comply to the RFU and SRFU Safeguarding Policies. Furthermore, any player regardless of their age at the time of the match must not consume alcohol and if this is found to have occurred then the team may forfeit their place in the competition.

### **DEFINITIONS:**

Committee means the County Union's Competitions Sub-Committee

**Competitions Organiser** means the person to whom the Committee delegate the administration of a Competition

County Union means the Somerset County Rugby Football Union Limited

**Home Clubs** means the first named club to be drawn in respect of a fixture or as otherwise determined by the Committee

RFU means the Rugby Football Union

Society means the Somerset County Rugby Football Union Referee's Society Limited.

**World Rugby** means the world governing body of the game, which at the date of the adoption of these Rules the Union is a member

**World Rugby Regulations** means the Resolutions and Regulations relating to the game promulgated by World Rugby from time to time

### 1 DESCRIPTION

1.1 The Competition shall be called the Somerset Under 18s League (League) and will be open to Youth Teams from each club in membership of the Somerset RFU plus any teams from other Counties at the discretion of the Organising Committee. All matches in the Competition shall be played under the of Laws of the Game of Rugby Union in effect and as published by World Rugby from time to time with the Under-19 Variations as applicable to the age group in question and these regulations set out below (Regulation(s) with which every Club when entering a team in the Competition agrees to comply).

### 2 ORGANISING COMMITTEE

- 2.1 The Competition will be organised and managed by the Competitions Administrator whose decisions, subject to a right of appeal to the Committee set out in Regulation 12 will be binding and final on any matter but specifically:
  - a) the interpretation of these Regulations.
  - b) any dispute between competing Clubs and
  - c) any matter not provided for in these Regulations.

2.2 The Competitions Administrator appointed by the Committee is to manage plan and organise the structure of the League fixtures, administer and compile results and provide a focal contact point for all issues and inquiries.
All contact information can be found: Committee (somersetrfu.co.uk)

### 3 FIXTURES

- 3.1 Each club must confirm its participation in the League for the following season to the Competitions Administrator by 31st July of the same year. Any application for participation after this date will be at the absolute discretion of the Committee.
- 3.2 The Competitions Administrator will notify the clubs entering the League match dates (fixture dates) for the season within two weeks of the closing date for participation. Fixture dates will be determined by the Committee according to the RFU Structured Season and having regard to such other matters as the Committee may in its absolute discretion decide.
- 3.3 Each club will play each other club in the Competition twice unless there is the need for a play-off. All teams will be placed into leagues by the Committee having regard to such other factors as the Committee may in its absolute discretion consider appropriate.
- 3.4 When more than one league is organised for a season then a play-off competition will be organised to determine the overall league winner.
- 3.5 The RFU's U18 variations to the Laws of the Game will apply to the playing of all fixtures save where these Regulations differ in which case these Regulations will apply.
- 3.6 A team must always comprise at least 10 players, for any fixture the two teams by mutual agreement lend / borrow players from the other team to ensure a fair and equivalent match.
- 3.7 For each fixture in the league one club will be designated by the Committee as the home club and one as the away club. The home club is responsible for making all match-day arrangements including the provision of the referee and a suitable safe playing field set out according to Law 1 of the World Rugby Laws of the Game. Each team should ensure it has its own suitable First Aider in line with RFU Regulation 9. With the agreement of the away club the home club may cede home status to the away club or play at a neutral venue. If the match is played at a neutral venue the designated home club is responsible for all the match-day arrangements. If the designated home club cedes home status to the away club that club becomes responsible for and agrees to undertake all the match-day arrangements.



- 3.8 All fixtures issued by the Competitions Administrator are to be played on the Sunday, however this can be changed if it is agreed with both the home and away teams. If the match date is changed from the original fixture date it is the responsibility of the home team to advise the Competitions Administrator of the revised date. The only date that cannot be changed is the play-off final.
- 3.9 Kick-off times will be by mutual agreement between the home and away teams. The Competitions Administrator will set the Kick-off time for the play-off final.
- 3.10 Where a change in fixture date is determined in accordance with Regulation 4.1 agreement from the other club cannot be withheld.
- 3.11 Without exception all League fixtures must be completed by the last date of the season in question as defined by the RFU. Any fixtures outstanding at this date will be void.
- 3.12 Where a team withdraws from the League part way through a season, all of its match results will be declared void and expunged from the League.

### 4 UN-PLAYED, POSTPONED OR ABANDONED MATCHES

- 4.1 If weather conditions or the state of the pitch prevent a match being played or a match is abandoned because of such conditions with more than 10 minutes playing time remaining, the match shall be played or replayed on the next available date.
- 4.2 The decision on weather conditions and/or pitch conditions making a match unplayable can only be made or confirmed in his absolute discretion on the day of the match by the match referee having consulted with both teams where practical and the respective groundsman where appropriate.
- 4.3 In the event of a League match not being played for any reason other than under 4.1 above or a circumstance agreed by the Committee, the club not in default will be awarded 4 League points and 1 Bonus point and the score deemed to be 28-0; 4 tries to nil.
- 4.4 If a club is unable to play a League match, it must notify its opponents and the appointed referee with a copy to the Competitions Administrator as soon as the facts are known and, in any event, no later than 48 hours preceding the match. If the fixture cannot be rescheduled by mutual agreement, then the club not in default will be awarded 4 League points and 1 Bonus point and the score deemed to be 28-0; 4 tries to nil.
- 4.5 If a match is rescheduled the home team must inform the Competitions Administrator as soon as practicable.



4.6 All games must be completed before the commencement of the Playoffs.

### 5 CLUB POSITIONS

- 5.1 The position of a club in the appropriate League of the Competition will be established according to the number of League points the club has been awarded. Clubs will be placed in ascending order with the highest number of League points at the top. League points will be awarded as follows:
  - 4 League points for a win.
  - 2 League points for a draw.
  - 1 bonus League point for a loss by 7 match points or less; and
  - 1 bonus League point for scoring 4 or more tries in the fixture.
- 5.2 If a match between sides reaches a point that the difference in score between the two sides exceeds 50 points then the match is considered finished and the score and try count is recorded as the result. If both teams wish to continue, they can but any further score is excluded from the league result.
- 5.3 In the case of equal number of League points accumulated, positions between clubs will be determined according to which has the highest match points difference. Match points difference is the difference between cumulative match points for and cumulative match points against.
- 5.4 If a tie remains after applying 5.3 then the club with the highest total match points scored will be placed highest in the League.
- 5.5 If a tie remains after applying 5.4 then the club with the highest tries scored will be placed highest in the League.

### **6 NOTIFICATION OF MATCH RESULT**

- 6.1 Each club should ensure all League results (score and number of tries scored) are sent to the Competitions Administrator within 24 hours game.
- 6.2 Failure to notify results may render the result void If the Competitions Administrator so decides.
- 6.3 The Competitions Administrator is responsible for the collation of all results and publication of the League tables and will publish the results within a maximum of 5 working days of receiving ALL results. Latest results and tables will be published on the Somerset RFU website.

# 7 PLAYERS

7.1 A club may only play or select as a replacement or substitute players who are registered with their Club under the RFU Youth Registration Regulations and who:



- i) are bona fide playing members of the club.
- are of the correct age at one minute to midnight on 31st August of the season in question as follows namely that they have attained 16th birthday but have not attained 18th birthday.
- iii) RFU regulation 15.3 (Playing Up) and 15.4 (Playing Down) are applicable as long as all relevant players are registered and approved by the Somerset Playing Out Of Age Grade Committee (POOAG).
- iv) have not played in any Somerset League fixture for any other RFU registered club in the Somerset League in the season in question unless sanctioned by the Committee at least 14 days before playing in any match.
- 7.3 A club will be deducted up to 5 League points by the Organising Committee on each occasion that it has been represented by an ineligible player or an ineligible player acts as a replacement or substitute.
- 7.4 Where a team has fewer than 15 players but at least 11 players then the match can proceed. Where a team is one player short the opposition team may play with a full team of 15 players. The match may also proceed and be played with the opposition reducing its team to one player more than the team that has 13 players or 12 players. The No.8 or both flankers will be missing respectively where the match is played 1 or 2 players short.

### 8 REPLACEMENTS AND SUBSTITUTES

- 8.1 In all matches in the League replacements and rolling substitutes are permitted in accordance with the RFU regulations relating to their use. A player who has been substituted may replace any player, whether or not that player has been injured. Players may be exchanged at any time during the match, when the ball is dead and with the knowledge of the referee.
- 8.2 The half game rule applies.

### 9 DURATION OF MATCHES

- 9.1 In accordance with RFU regulations the duration of each match will be 35 minutes each half.
- 9.2 Stoppage time will be played at the end of each half as determined by the referee.



### 10 REFEREES

- 10.1 The home club will be responsible for arranging the match referee who should preferably be a County Society referee. For all matches the referee should be at least RFU ELRA Level 2 qualified and should not be a coach of the age group at the club nor be conflicted through any other relationship with the team (e.g. father of a player).
- 10.2 Both clubs in a fixture will provide one touch judge each who will act under the referee's direction.
- 10.3 Where the only referee(s) available are linked to one or both age group teams then the match can still proceed with such a referee if both teams are in agreement. If there is a choice of referees in such situations, then the away team will make the selection.
- 10.4 If a player is yellow carded by the match referee, he will spend 7 minutes of actual playing time off the pitch without replacement and remain adjacent to and under the control of his coach.
- 10.5 If a player is red carded, he will immediately leave the pitch and proceed to the clubhouse. The player will then be banned from playing again until his case has been properly dealt with in accordance with Regulation 19 of the RFU regulations.

### 11 BEHAVIOUR OF NON PLAYERS

11.1 Each club in the Competition will be responsible for ensuring that all non-players at matches in the Competition respect the decisions of the referee, will not abuse any player or referee and will behave in accordance with core values of the RFU namely Teamwork, Respect, Enjoyment, Discipline and Sportsmanship Notwithstanding any action taken under RFU Regulation 19 or any action taken by a Club the Organising Committee may take such action against any Club or individual as it deems appropriate in relation to any complaint or report of behaviour in breach of this Regulation or one or more of the core Values referred to above. Such action may include but not be limited to referring the matter to a Club to be dealt with (with or without recommendations or directions), deducting League points or referring the matter to the County Disciplinary Committee.

### 12 DISPUTES

12.1 Any matter in dispute between participating clubs shall be notified to the Competitions Administrator as soon as it becomes apparent or, if occurring during a match, within 24 hours of the end thereof. Written confirmation of the details of the complaint or dispute must reach the Competitions Administrator within 48 hours after the initial notification and shall set out fully the nature and cause of the complaint.



The Complaint should include the following areas in addition to any cause for citing a player during any passage of play not dealt with by the referee at the time which will be referred to the CB Disciplinary Committee Secretary.

- Breach of requirement to comply with RFU Regulation 9 Player Safety and First Aid Cover.
- ii Lack of an up-to-date Risk Assessment for the match arrangements.
- Any Safeguarding issue and whether an appropriate Safeguarding Officer was present.
- iv) Whether alcohol misuse was observed by any under-age individuals.

With the exception of any Safeguarding issues which should be passed directly to the POOAG committee, the Committee shall have absolute discretion (and using such procedure as it in its absolute discretion it deems appropriate) to resolve any such complaint as it shall think fit and may decline to accept a complaint validly made if it considers doing so to be in the interests of the Competitions generally or the game of Rugby Football. Subject only to the provisions of Regulation 12.2, the decision of the Committee shall be final and binding on all parties.

- 12.2 Where any party having an interest in the matter is aggrieved by any decision of the Committee taken pursuant to Regulation 12.1 above or otherwise in relation to the Competitions, it shall have the right to appeal that decision to the Management Committee of the County Union by so notifying the Secretary of the County Union in writing (within 48 hours of the decision of the Committee being announced) giving full details of the grounds of such appeal and supplying all evidence upon which it wishes to rely. In submitting its application, the complainant Club must lodge a fee of £100, with the exception of any Safeguarding issues; which payment will be refunded in full if the appeal is upheld.
- 12.3 The Management Committee in dealing with any appeal may use such procedures as in its absolute discretion it may decide.

### SOUTH WEST LEAGUES 2023 - 2024 SEASON

Clubs playing in the South West Leagues of the English Clubs Championship are subject to the Laws of the Game and the Regulations laid down for the competition. In addition, Clubs are bound by the South West Administration Instructions, which lay down procedures relating to the method of submitting registrations, reporting results/postponements, sending in result cards and the appeal procedure. Full details of the RFU regulations are available at: englandrugby.com Clubs playing in the "deregulated leagues" have opted out of certain regulations and the modifications are shown below.

Modifications to the English Clubs Championships (ECC) Regulations relating to the playing of league rugby at Level 8 and below in the Tribute Somerset Counties 1, Counties 2 (N & S) and Counties 3 (N & S).

The regulations relating to the playing of league rugby in Somerset will be modified in so far as matches played at Level 8 (Counties 2) and below (together "the Modified Leagues") are concerned. The modified leagues are subject to all ECC Regulations in so far as these are not varied by or inconsistent with these Regulations. The modifications are:

- Second, third and lower teams of a Club may play in the modified leagues with the approval of and at the level agreed by the South West Regional Organising Committee (SWROC), who shall consider the advice of the Somerset County RFU Limited (SCRFU).
- A second, third or lower team may not be promoted above Level 7. In the event
  of such a team winning the Level 7 league or getting into a Play Off position, then the
  next highest placed eligible side in that league shall, subject to the agreement of
  SWROC in agreement with SCRFU, take its place.



- 3. At Levels 8 & 9 (Counties 2 & 3), all players must be registered with their club in accordance with the Player Registration Regulations, with the exception at Level 9 (Counties 3) TWO unregistered players may play under RFU Regulation 14.2.2 before having to be registered. At Level 9 (Counties 3) they may only play for one week but must be registered before they play again the next week or any subsequent week.
- 4. At Level 10 (Counties 4), teams may contain players who are not registered with that club. They should however be made up of bona fide club members; although if this is not possible then players may be borrowed from other clubs to make up the numbers and encourage participation in the game. However, such teams may not knowingly play players holding Effective Registration with another club at Level 8 (Counties 2) or above.
- Notwithstanding point 4 above, clubs at all levels are encouraged to continue to register their players.
- If a team at level 10 (Counties 4) and below justifiably cannot field a front row, then the
  match will proceed with uncontested scrums. No league points will be deducted
  providing the fixture is honoured. The result at the final whistle will stand.
- 7. Two teams from the same club may not play in the same league. Subject to this, and point 13, normal promotion and relegation rules will apply except that a team may decline promotion with the approval of SWROC; who in reaching their decision shall consider advice from SCRFU. Should a team decline promotion, then point 12 will apply. For the avoidance of doubt, the next highest placed side in that league has no automatic right to promotion in such circumstance.
- 8. Where the first or higher team of a club does not have a match (but does have a lower team league fixture) on an appointed day, then the club must field a genuine team(s) commensurate with the level of match(es) being played. That will include situations where a club fields a lower team but cancels a higher team's fixture on the same day. Clubs are reminded that such first team (or any other team in the Club) may also suffer penalty for non-compliance. The League Secretary may enquire into such circumstances and impose any sanction in accordance with Game Regulations.
- 9. In the interests of encouraging participation in the game at Level 10 (Counties 4) or below the captains may agree prior to a match to more than three replacements being used by the teams in any match. At Level 10 (Counties 4) teams with surplus players are encouraged to lend the opposition surplus players to make up even numbers per side. However, if agreement cannot be reached between the captains before the match, the number of replacements allowed will revert to RFU Regulation 6 Section 58 (b), which states that there shall not be more than three replacements allowed below Level 5.
- 10. At Level 10 and below, Electronic Match Cards must be completed including the names of participating players. Where a Guest player has played and their details have not been registered on the system, their name, date of birth and any club of which they are a member must be clearly indicated in the "comments box" on the Electronic Match Card (EMC). If the Guest player is unattached to a Club, this must also be stated on the EMC.



- 11. Where a team finishes in a promotion or relegation spot but cannot be promoted or relegated by virtue of these regulations (e.g. because a club team would gain promotion to the same league as another side in their club), then SWROC (having taken advice from the SCRFU) will make appropriate arrangements for promotion or relegation within the leagues affected. In the case of relegation causing two teams from the same club to be in the lowest league, then, if no other suitable arrangement is appropriate, this could include two sides from the same club being in the same league.
- 12. Where anomalies occur within the modified leagues that are not provided for within these regulations or that are contrary to the objectives of providing competitive, structured and enjoyable rugby to relevant teams of Somerset clubs, then SWROC (having taken advice from SCRFU) reserves the power to make appropriate arrangements to fulfil those objectives.
- 13. Providing it is otherwise possible under these regulations and SWROC agrees, then the winners of Counties 3 (North & South) shall be promoted to Counties 2 and the bottom two placed sides in that league relegated. The winners of Counties 4 (North & South) shall be similarly promoted to Counties 3 (North & South) and the bottom side in each of those leagues relegated. There will be no play off matches for the second placed sides in either of these leagues.
- 14. The League Secretaries of Somerset Counties 2, Counties 3 (North & South) and Counties 4 (North & South) shall be appointed from nominees submitted by SCRFU.

## SOMERSET COUNTY RUGBY FOOTBALL UNION LIMITED RULES

## I) NAME, OBJECTS & POWERS

## 1 NAME

The Society shall be called the "Somerset County Rugby Football Union Limited" (Constituent Body).

## 2 DEFINITIONS

Except where otherwise defined, the capitalised words and expressions used in these Rules and listed in the Schedule of Definitions set out in Rule 33 shall bear the meanings given to them therein

## 3 OBJECTS

The objects of the Constituent Body shall be:

- 3.1 To administer the Game in the County of Somerset together with that part of the City of Bristol situated south of the true course of the River Avon (as recognised prior to the reorganisation of Local Government in 1971) ("the County") on behalf of the Union.
- 3.2 To promote, encourage and extend the Game for men, women, boys and girls throughout the County including (but not limited to) the coaching thereof, its development in Schools and at all age levels and the recruitment, administration and training of referees.
- 3.3 To ensure that the Game is played in accordance with the Laws of the Game and is administered in accordance with World Rugby Regulations and the Rules of the Rugby Football Union.
- 3.4 To arrange and undertake representative and other matches as the Committee may decide.

## 4 POWERS OF THE CONSTITUENT BODY

To further its objects the Constituent Body shall have the power to do all such things as are incidental or conducive to the objects of the Constituent Body including (but not limited to) all or any of the following:

- 4.1 Either directly or indirectly to employ, invest and deal with the assets and funds of the Constituent Body for the objects of the Constituent Body in such manner as shall be considered by the Committee to be expedient, and to do all such other acts and things and carry on all such other activities (including (but not limited to) leasing, subleasing, releasing, renting, acquiring, altering, erecting, holding, selling, improving, developing, repairing, hiring, lending with or without security or otherwise dealing with real and personal property of any kind) as shall be considered by the Committee to be necessary or expedient for the purposes of the Constituent Body or the advancement of its interests.
- 4.2 To raise or borrow money for the purposes of or in connection with the activities of the Constituent Body or any of them as the Committee thinks fit in accordance with the following provisions:
  - 4.2.1 Any sum or sums raised or borrowed may be on mortgage, charge, bonds or debentures of all or any of the funds or property of the Constituent Body whether or not including any floating charge of the whole or part of the undertaking property and assets of the Constituent Body both present and future.
  - 4.2.2 At the time of any borrowing the sum of the amount then remaining undis charged of monies borrowed and of the amount of the proposed borrowing shall not exceed £100,000 or such sum as the Members in General Meeting may from time to time determine.
  - 4.2.3 The rate of interest payable at the time the terms of borrowing are agreed on any money borrowed shall not exceed the rate of interest which in the opinion of the Committee represents the market rate of interest for borrowings of similar amount and on similar terms prevailing at that time except that in the case of a mortgage loan the Committee may delegate the determination of the interest rate within specified limits to an Officer, Committee Member or Sub-Committee.
  - 4.2.4 The Committee may determine from time to time (subject to Rules 4.2.1, 4.2.2 and 4.2.3) the terms and conditions upon which money is raised or borrowed or security is issued and may vary such terms and conditions.
  - 4.2.5 No person lending money to the Constituent Body shall be concerned to see or enquire whether either of the limits imposed by Rule 4.2.2 or Rule 4.2.3 is exceeded at the time of the borrowing or issue and if either or both of such limits were to be exceeded no borrowing incurred in excess of such limits shall be invalid unless such person had received express notice to this effect at the time of borrowing.



- 4.3 To give any security or securities whether by way of mortgage or otherwise for the performance of any contracts or any debts, liabilities or obligations of the Constituent Body or any of its subsidiaries or other persons or corporations in whose business or undertaking the Constituent Body is interested, or to whom or in respect of whom the Constituent Body has given any personal covenant, guarantee or indemnity, whether directly or indirectly, and collaterally or further to secure any obligation of whatever nature of the Constituent Body by a trust deed or other assurance.
- 4.4 To accept and grant sponsorship and franchises and make such arrangements in connection therewith as the Committee shall think fit.
- 4.5 To apply for and hold any licences, consents, certificates, permissions and approvals that may be required for or in connection with the activities of the Constituent Body and (among other things) to provide catering and such other facilities as the Committee shall consider desirable
- 4.6 To invite, receive and make donations for or otherwise promote or assist in the development or continuance of facilities for, or the prestige of, the Game or any other sport or recreation.
- 4.7 To assist clubs in the development, coaching and playing of the Game and in the provision of playing facilities including (among other things) playing fields and sports accommodation.
- 4.8 To support (whether by direct subscription, the giving of guarantees or otherwise) any charitable, benevolent or educational fund, institution or organisation, or any event or purpose of a public or general nature, the support of which will or may in the opinion of the Committee directly or indirectly further the objects of the Constituent Body.
- 4.9 To promote, arrange and organise leagues, competitions and tournaments for and between clubs. To engage such officials and employees upon such terms and at such remuneration as the Committee may deem appropriate, and to dismiss or retire any of them as may be necessary.
- 4.10 To provide pensions, insurances and other benefits to employees or to ex-employees of the Constituent Body or the dependants and relatives of any such persons and to establish and maintain or concur in establishing and maintaining trusts, funds, schemes or other arrangements (whether contributory or non-contributory) with a view to providing such benefits including (but not limited to) retirement benefits and/or life assurance schemes.

- 4.11 To maintain bank accounts in credit or overdrawn on such terms as the Committee shall think fit including the giving of guarantees and indemnities in respect of direct debits and other money transmission or collection systems whether pursuant to Rule 15.5 or otherwise.
- 4.12 To pass such resolutions, regulations and instructions which shall be binding on all Members as are considered necessary for the better management, organisation, administration and regulation of the Constituent Body.
- 4.13 To settle, conduct, enforce or resist either in a court of law or by arbitration any suit, debt, liability or claim by or against the Constituent Body.

## II) MEMBERSHIP

## 5 MEMBERS

- 5.1 The Members of the Constituent Body shall be the corporate bodies and individual persons whose names are for the time being entered in the Register of Members and in the case of individual persons who are nominees of unincorporated bodies the name of the unincorporated body whose nominee the Member is shall be entered against the name of the Member concerned.
- 5.2 No person may be a member of the Committee, other than those members co-opted under Rule 11.2, unless they are a Member.
- 5.3 Subject to Rule 5.2, the admission of Members shall be under the control of the Committee, which shall from time to time determine the criteria and conditions applicable for the approval of membership, and in the absence of such determination it shall be a requirement for admission to the position of Member for the candidate to be a member of a club affiliated to Somerset Rugby Football Union Limited and to be nominated and seconded by persons who are Members.
- 5.4 The Committee shall have power to admit to membership of the Constituent Body:
  - 5.4.1 A Club which is incorporated.
  - 5.4.2 The Secretary (or subject to the approval of the Committee any other officer or official) as its nominee of a Club which is unincorporated.
  - 5.4.3Individual Members.
  - 5.4.4 Honorary Life Members.
- 5.5 Any association of persons of which the principal object is the playing of the Game and which desires to apply to be a Member or if unincorporated nominate a person to be a Member shall be proposed and seconded by two Members. Applications for membership may be submitted at any time.



- 5.6 Each Club which is in membership with the Constituent Body at the date these Rules take effect pursuant to Rule 26 shall be admitted to membership in accordance with Rule 5.4 and must immediately send a copy of its rules if incorporated or, if unincorporated, confirm the name and address of its secretary for entry in the Register of Members as its nominee, and thereafter every Club, whether incorporated or unincorporated, must immediately following a change of its secretary or other nominated officer notify the Secretary of the name and address of its new secretary or other nominated officer or official for the Register of Members to be amended accordingly.
- 5.7 A Member may withdraw from the Constituent Body at any time by giving to the Secretary written notice of the intention so to do provided that the Member shall remain liable for all monies then due and owing to the Constituent Body.
- 5.8 A Club shall be liable to suspension or termination of its membership or privileges as the Committee may determine if:
  - 5.8.1 It shall not have paid its annual subscription by 1st November each year.
  - 5.8.2 It shall cease to satisfy the criteria and conditions for membership as determined by the Committee under Rule 5.3.
  - 5.8.3 It does not conform to any reasonable directive by the Committee as to its standards of play, administration or general behaviour.
- 5.9 A Member shall be liable to termination or suspension of membership or to other appropriate punishment by the Constituent Body, acting by the Committee for any infringement of these Rules, any Regulation or any Rules or Regulations of the Union, the Laws of the Game or the World Rugby Regulations or any conduct prejudicial to the interests of the Constituent Body or the Game, and the Constituent Body, acting by the Committee, shall have power to discipline any Club whose nominee is a Member or any player, official, member or employee of a Club for any offence. The procedure for this exercise of this power shall be prescribed by the Committee and details thereof shall be kept by the Secretary and be available for inspection by the Members at all reasonable times.
- 5.10 A Member shall cease to be a Member:
  - 5.10.1 On resignation.
  - 5.10.2 In the case of a corporate Member on ceasing to be corporate.
  - 5.10.3 On termination of membership by the Committee in accordance with Rule 5.8 or 5.9.
  - 5.10.4 On replacement as the nominee of a Club.



5.11 For the avoidance of doubt, the vote of a Club (whether incorporated or unincorporated) at any meeting of the Constituent Body shall be cast by its secretary or nominated person. If such secretary or nominated person for the time being is also a Member of the Constituent Body in their own right, they may in addition cast a vote in their personal capacity.

## **6 SHARE CAPITAL**

- 6.1 The capital of the Constituent Body shall consist of shares of the value of £1 each.
- 6.2 Every Member shall hold one share and no more in the capital of the Constituent Body. No person who is not a Member shall be issued with a share.
- 6.3 Each Member of the Constituent Body at the date these Rules take effect pursuant to Rule 26 who or which is eligible to be a Member or to appoint its secretary as its nominee under Rule 5.6 shall be allotted one share in the name of the Member or the name of the Nominee as the case may be.
- 6.4 Any Member or nominee of a Club admitted to membership after the date on which these Rules take effect pursuant to Rule 26 shall be allotted one share on admission.
- 6.5 In the case of every Club, the share allotted to it or its nominee shall be paid up in full by applying £1 of the subscription next received from it after the date of admission to membership.
- 6.6 No share shall be held jointly, be withdrawable or subject to Rule 6.7 be transferable by any Member and no interest, dividend or bonus shall be payable on any share. Any Member transferring or attempting to transfer a share other than under the provisions of Rule 6.7 shall if the Committee so decides be deemed to have withdrawn from the Constituent Body as from the date of such transfer or attempted transfer.
- 6.7 Shares held by nominees of Clubs shall be transferable to succeeding nominees in such manner as the Committee may from time to time determine.
- 6.8 The share of a Member shall be forfeited to the Constituent Body when that Member for whatever reason ceases to be a Member and any amount then due to the Member in respect of such share shall thereupon become the property of the Constituent Body.
- 6.9 The Constituent Body shall not be required to issue a certificate to any Member in respect of the share allotted to that Member.



## **III) GENERAL MEETINGS**

## **7 GENERAL MEETINGS**

- 7.1 All General Meetings shall be held at such location within the geographical region of the Constituent Body as the Committee may determine and any such meeting other than an Annual General Meeting shall be called a Special General Meeting.
- 7.2 The Chairperson of all such meetings shall be the President of the Constituent Body or the Immediate Past President or President-Elect or a Member of the Committee appointed at the meeting concerned to take the Chair for that meeting.
- 7.3 Every Member shall be entitled to attend and vote at any General Meeting and in the case of a corporate Member its representative to attend and vote on its behalf at any General Meeting shall be appointed under the hands of two members of its committee and its secretary. The procedure for the casting of votes shall be determined by the Chairperson of the meeting.
- 7.4 Voting shall be by show of hands, unless the Chairperson of the meeting, in their absolute discretion, decides that it shall be by secret ballot, in which case they shall determine the procedure to be applied for this purpose.
- 7.5 The quorum at any General Meeting shall be 20 Members attending in person (this might ensure attendance).
- 7.6 If within thirty minutes after the time appointed for a General Meeting a quorum is not present, the Meeting, if convened on the requisition of Members, shall be dissolved, and in every other case it will stand adjourned to such other day and at such time and place, or be dissolved, as the Committee shall determine.
- 7.7 All resolutions shall be decided by a majority of votes recorded except where:
  - 7.7.1 these Rules provide for a special resolution which shall require a majority of at least two-thirds of the votes recorded or
  - 7.7.2 a resolution is put to an Annual General Meeting as contemplated by Rule 8.1.7.2, in which case the provisions of the Act as to voting shall apply.
- 7.8 A declaration by the Chairperson of a General Meeting to the effect that a particular resolution has been passed or not or passed by a particular majority or not shall (subject to the Act) be final and binding on all Members.
- 7.9 A General Meeting shall not be invalidated by reason only of any Member accidentally failing to receive a notice thereof or any accompanying document relating thereto.
- 7.10 The procedure for conduct of General Meetings shall be prescribed by the Committee and details thereof shall be kept by the Secretary and be available for inspection by Members at all reasonable times.

## 8 ANNUAL GENERAL MEETINGS

- 8.1 Not later than 31st August in every year a General Meeting shall be held (to be known as the Annual General Meeting) for the transaction of the following business:
  - 8.1.1 To consider and approve (with or without amendment) the minutes of the previous Annual General Meeting.
  - 8.1.2 To receive and approve a report from the Committee on the affairs of the Constituent Body since the previous Annual General Meeting.
  - 8.1.3 To elect the Officers for the ensuing year.
  - 8.1.4 To elect members of the Committee for the ensuing year.
  - 8.1.5 Where necessary in law or, where the Members require:
    - 8.1.5.1 To appoint the Auditors for the ensuing year or
    - 8.1.5 2 To consider a resolution disapplying the provisions of the Act relating to the obligation to appoint Auditor.
  - 8.1.6 To consider as a special resolution any addition or alteration to these rules duly proposed in accordance with Rule 8.6.
  - 8.1.7 To consider any other motion or business duly proposed in accordance with Rule 8.6
  - 8.1.8 To consider any other business of which due notice shall have been given.
  - 8.1.9 To hear any other relevant matter for the consideration of the Committee during the ensuing year, but on which no voting shall be allowed.
- 8.2 Not later than 30th November in each year a General Meeting shall be held (to be known as The Financial Annual General Meeting) for the transaction of the following business:
  - 8.2.1 To receive and adopt for the preceding financial year, financial statements which shall have been prepared in accordance with the minimum standard required by:
    - 8.2.1.1 The Co-Operative and Community Benefit Societies Act 2014, or Acts which subsequently replace this Act and
    - 8.2.1.2 The Financial Conduct Authority or other such Body with which the Constituent Body is registered.
- 8.3 Notice of every Annual General Meeting stating the date, time and venue of such Meeting shall be sent to all Members so as to be received not less than two clear weeks prior to the date of the Meeting with the agenda of the business to be considered thereat and with a copy of the Constituent Body's Financial Statement for the preceding financial year.



- 8.4 The election of the Officers shall be subject to the following provisions:
  - 8.4.1 Any Member shall have the right to make nominations, with the written consent of a candidate, for election to any one or more of the offices named in or created under the provisions of Rule 12.1. Such nominations must be sent in writing so as to reach the Secretary by 30th April. The Committee shall also have the right to make nominations for the election of Officers.
  - 8.4.2 The election of each Officer shall be decided by a majority of votes recorded.
  - 8.4.3 In the event of an equal number of votes being cast for two or more candi dates for any office, a further election for that office shall immediately be held between those candidates for whom the votes cast are equal in number. If there shall still be equality of votes, the members of the retiring Committee present at the time shall decide who shall from those candidates receiving an equal number of votes in the second election be the holder of the office concerned for the ensuing year.
- 8.5 The election of Committee Members shall be subject to the following provisions:
  - 8.5.1 The Constituent Body is divided into five Divisions covering the local government areas as follows:
    - Division A Unitary Authority of Bath & North East Somerset
    - Division B Unitary Authority of North Somerset
    - Division C The part of the City of Bristol situated south of the true
    - Division D The Districts of Sedgemoor, Taunton Deane and West Somerset.
    - Division E The Districts of Mendip and South Somerset
  - 8.5.2 Each Division is entitled to nominate two Divisional Representatives to serve on the Committee but where the number of Clubs in a Division exceeds twelve on 1st January for two consecutive years, that Division may nominate one additional Divisional Representative. When the number of Clubs allocated to a Division which is entitled to a third Divisional Representative falls below thirteen on 1st January for two consecutive years that Division shall cease to be entitled to a third Divisional Representative.

- 8.5.3 Clubs of each particular Division of the Constituent Body shall alone nominate their own Representatives for that Division prior to 30th April in each year when the period of office of a Representative expires in accordance with clause 8.5.5. Nominations shall be made in writing (signed by duly authorised officers or representatives of both the Club nominating and the Club seconding such nomination) on an official form issued by the Constituent Body for this purpose and shall be submitted to the Secretary of the Constituent Body at least seven days prior to the date above. If the number of nominations exceeds the number of vacancies for that Division, then a ballot will be held of the clubs in that Division. The ballot shall be conducted in writing with each Club in the division in question having one vote. The Secretary of the Constituent Body shall send to the Club Secretary of each Club in that Division a postal ballot form indicating clearly the Nominations that have been received from that Division. Each club shall return the ballot form to the Secretary within 7 days of the receipt of the ballot form by the Club indicating which Nominee it votes for. The Nominee(s) receiving the most votes shall be the Nominated Representative(s) for that Division and in the event of a tied vote the President for the time being of the Constituent Body shall cast a deciding vote, A Nominated Representative shall take office with effect from the next following Annual General Meeting of the Constituent Body. The Somerset County Rugby Football Union Referees Society Limited s shall also nominate prior to 30th April in each year one of its members to sit on the Committee.
- 8.5.4 A Representative nominated for a particular Division need not necessarily be resident in that Division.
- 8.5.5 Each Divisional Representative shall hold office for a period of three (3) years (DR Term) from the date of being elected. Should any Divisional Representative cease to hold office for any reason during the DR term, any replacement Divisional Representative shall only be elected at the next Annual General Meeting following the date of their cessation of office and shall, for the avoidance of doubt, serve for a period of three (3) years from the date of the Annual General Meeting at which they are elected.
- 8.6 Proposals for additions or alterations to the Rules or for any other motion to be submitted to an Annual General Meeting shall be subject to the following provisions:
  - 8.6.1 Any proposal shall be submitted in writing to the Secretary by 30th April duly proposed by one Member and seconded by another.
  - 8.6.2 Copies of all such proposals and copies of all proposals put forward by the Committee shall be sent to all Members with the notice of the Annual General Meeting.



- 8.6.3 Amendments to any proposal notified to Members shall be sent in writing so as to reach the Secretary duly proposed and seconded not less than twenty-four hours before the time for which the Annual General Meeting is convened
- 8.6.4 Amendments duly received in accordance with Rule 8.6.3 shall be added to the agenda by the Chairperson of the Annual General Meeting.

## 9 SPECIAL GENERAL MEETINGS

- 9.1 The Committee may convene at any time a Special General Meeting by giving to all Members two clear weeks' written notice thereof stating the date, time and venue thereof and the resolution or resolutions to be moved or other business to be transacted thereat
  - 9.1.1 Amendments to any resolution proposed by the Committee shall be submitted in writing to the Secretary duly proposed and seconded by Members in the same manner as is prescribed by Rule 8.6 for an Annual General Meeting.
  - 9.1.2 Amendments duly received in accordance with Rule 9.1.1 shall be added to the agenda by the Chairperson of the Special General Meeting.
- 9.2 The Committee shall also convene a Special General Meeting on receipt by the Secretary of a written requisition so to do, duly signed by not less than 20 Members. Each requisition must clearly state the specific resolution to be moved.
  - 9.2.1 Two clear weeks' notice of such a Meeting stating the date, time and venue thereof and the specific resolution to be moved thereat shall be sent to all Members by the Secretary within 14 days of the receipt of the requisition.
  - 9.2.2Amendments to such a resolution shall be submitted in writing to the Secretary duly proposed and seconded by Members in the same manner as is prescribed by Rule 8.6.3.
  - 9.2.3 Amendments duly received in accordance with Rule 9.2.2 shall be added to the agenda by the Chairperson of the Special General Meeting.

## 10 RULES

- 10.1 No new Rule shall be made, nor shall any Rule be amended or rescinded, except by a special resolution passed at an Annual General Meeting in accordance with Rule 8.5 or at a Special General Meeting convened by the Committee in accordance with Rule 9.1.
- 10.2 The Secretary shall register in accordance with the Act any new Rule or amendment to these Rules and no new Rule or amendment to the Rules shall be valid until so registered.



10.3 A copy of the Rules shall be delivered by the Secretary to any person on demand on payment of such sum (not exceeding ten pence) as may from time to time be determined by the Committee.

## **IV) OFFICERS AND COMMITTEE**

## 11 POWERS OF THE COMMITTEE

The affairs of the Constituent Body shall be administered by the Committee, which shall exercise all the powers of the Constituent Body expressed in Rule 4 and without limiting the generality thereof.

- 11.1 The Committee shall have power to appoint such Sub-Committees as are considered necessary to deal with the affairs of the Constituent Body.
  - 11.1.1 The Committee shall determine the composition, powers and terms of reference of each Sub-Committee.
  - 11.1.2 The Chairperson of any Sub-Committee shall be a Committee member and shall have a second or casting vote, and the quorum necessary for the transaction of business by a Sub-Committee shall be one-third of its appointed members or as the Committee may determine.
  - 11.1.3 A Sub-Committee may exercise the power of co-option subject to the provisions of Rule 11.2.
- 11.2 The Committee shall have power to co-opt additional members to serve on it provided that the number of such co-opted members shall not exceed 33 percent of the number of members elected to hold office on the Committee (the Officers and the Representative(s) for the purposes of this computation being deemed to be elected members) and to approve the co-option of additional members to serve on any Sub-Committee, in both cases for either general or special service and with or without voting rights. A co-opted Committee member must be a Member and may be co-opted for such period as the Committee may determine not exceeding 3 years. On the expiry of the co-opted Committee member's period of office, they may be co-opted again for a further period of 3 years provided that no person may be co-opted for more than 3 consecutive periods of years.
- 11.3 The Committee shall not exercise its powers in any way or for any purpose inconsistent with the objects of the Constituent Body.
- 11.4 The procedure for the conduct of meetings of the Committee shall be prescribed by the Committee and details thereof shall be kept by the Secretary and be available for inspection by Members at all reasonable times.



- 11.5 The proceedings of meetings of the Committee and any Sub-Committee shall be private and confidential and no member of the Committee or any Sub-Committee shall be entitled to disclose the details of any discussions that take place or decisions made by the Committee or any Sub-Committee provided always that nothing shall prevent any member of the Committee or any Sub-Committee from disclosing to the Union or any relevant authority any matter discussed or decided upon in a meeting of a Committee or a Sub-Committee that they, acting in good faith, reasonably believe to be a breach of these Rules, a criminal offence or a matter which by reason of the potential detriment that the matter might cause to the standing or reputation of the Constituent Body, the Union, the relevant authority or the Game is something that ought to be disclosed to the Union or relevant authority.
- 11.6 The Committee may if it sees fit and acting by a vote of no less than three-quarters of its members discipline, suspend or remove from office or the Committee any Officer or member of the Committee or Sub-Committee who in the reasonable opinion of the Committee acting in good faith fails to comply with his or her obligations under these Rules or otherwise acts in a manner to the detriment of the Constituent Body or which is incompatible with his or her continued membership of the Committee.
- 11.7 Any person so disciplined or removed has the right of appeal to a Sub-Committee of the Committee consisting of the President for the time being (or if the person in question is the President the Hon. Secretary) and not less than two other members of the Committee and in the event they are unsuccessful at that appeal to require the Committee to convene a meeting of the Members of the Constituent Body to decide whether they should be disciplined or removed from office. The Committee shall decide on the procedure to be applied at such meeting.
- 11.8 References in these Rules to any acts or activities or opinion (including, without limitation, decisions, directions, requests, exercises of discretion and the giving of consent) of the Committee shall mean such acts or activities or opinions as shall have been sanctioned or effected or (as the case may be) expressed by (a) a resolution of the Committee or (b) a resolution of the relevant Sub-Committee where the power to act or authority being exercised has been delegated by the Committee to a Sub-Committee or (c) the relevant Officer where that power or authority has been delegated by the Committee to an Officer.

## 12 OFFICERS

- 12.1 The Officers of the Constituent Body shall be a President, a Secretary, an Honorary Treasurer and such other Officers as the Constituent Body may in General Meeting from time to time determine.
- 12.2 The Officers of the Constituent Body shall be elected at each Annual General Meeting in accordance with Rule 8.4.
- 12.3 Each Officer on election at an Annual General Meeting shall hold office from the end of that Meeting until the end of the next Annual General Meeting but shall be eligible for re-election from year to year.
- 12.4 If any such offices shall fall vacant between one Annual General Meeting and the next, such vacancy shall be filled by the Committee for the period of the vacancy.

## 13 COMMITTEE

- 13.1 The Committee shall consist of:
  - 13.1.1 The Officers.
  - 13.1.2 Fourteen Divisional Representatives (or such other number not exceeding twenty as may be determined from time to time by the Constituent Body in General Meeting) duly elected in accordance with Rule 8.4. The Divisional Representatives shall hold office for the DR Term. Should any replacement Divisional Representative cease to hold office for any reason during the DR Term, any replacement Divisional Representative shall only be elected at the next Annual General Meeting following the cessation of office and shall, for the avoidance of doubt, serve a period of three (3) years from the date of the Annual General Meeting at which he was elected. The CB Representative(s), who shall hold office from the end of the Union Annual General Meeting next following his election until the end of the following Union Annual General Meeting.
  - 13.1.3 The Constituent Body RFU Council Member(s), who shall hold office from the end of the Rugby Football Union next following their election until the end of the following Rugby Football Union Annual General Meeting.
- 13.2 The Committee shall each year elect their own Chairperson for the ensuing year to hold office from the date of the Annual General Meeting until the date of the following year's Meeting. They may hold any other office in the Constituent Body at the same time and shall be eligible for re-election from year to year.



- 13.3 The quorum at any meeting of the Committee shall be seven (or such other number as may be determined from time to time by the Constituent Body in General Meeting) and the Member elected to take the Chair shall be entitled to exercise a second or casting vote.
- 13.4 If a vacancy shall occur for an elected Member of the Committee between one Annual General Meeting and the next, such vacancy shall be filled by the Committee.
- 13.5 If a Member of the Committee shall commit an offence under Rule 5.9 or shall be adjudged bankrupt or if a court order is made appointing a receiver to administer such Member's property, such Member shall thereupon cease to be a Member of the Committee
- 13.6 Committee Members shall receive no remuneration for serving on the Committee other than the payment of authorised expenses for carrying out their duties.

## **V FINANCE**

## 14 CONSTITUENT BODY FINANCE

- 14.1 The Constituent Body's income shall be obtained annually from the subscriptions of Members, from investments and securities, from gate monies and ticket receipts from matches arranged by the Constituent Body, from sponsorship and from any other available source.
- 14.2 The profits of the Constituent Body shall be applied only in furthering the objects of the Constituent Body.
- 14.3 The Constituent Body shall not have power to receive money on deposit from Members or others.
- 14.4 A Financial Statement of the Constituent Body's affairs shall be made up to 30 June in each year (or such other date as may be determined from time to time by the Constituent Body in General Meeting) and shall be signed by the Honorary Treasurer, the Secretary and one Member of the Committee and a printed copy of the signed Financial Statement shall be sent to each Member with the notice calling an Annual General Meeting. An audit where necessary in law or, where the membership require, shall be carried out by a registered auditor or, where the conditions applicable for appointing lay auditors apply, by 2 or more lay auditors, together with the Auditors' report thereon and shall be sent to each Member with the notice calling an Annual General Meeting.

14.5 The Constituent Body may participate in a direct debiting scheme as an originator for the purpose of collecting subscriptions for any category of membership and/or any other amounts due to the Constituent Body. In furtherance of such a scheme the Constituent Body may enter into an indemnity required by the bank upon whom direct debits are to be originated and such indemnity may be executed on behalf of the Constituent Body by the Secretary or as otherwise determined pursuant to these Rules.

## 15 MATCH TICKETS

- 15.1 Tickets for matches arranged by the Constituent Body shall be under the control of the Committee and shall be sold at prices fixed by the Committee (without any provision for repurchase by the Constituent Body) or as the Committee may direct, and the Committee shall allocate such tickets on an equitable basis.
- 15.2 The Committee shall have power to issue such season and other tickets, on such terms, with such privileges and to such persons as it may from time to time determine.

## 16 AUDITORS

- 16.1 The provisions of the Act relating to the appointment, powers, rights, remuneration, responsibilities and duties of the Auditors shall be complied with.
- 16.2 The Auditors where appointed shall be entitled to attend any General Meeting and to receive all notices of and other communications relating thereto which any Member is entitled to receive, and to be heard at any General Meeting on any part of the business which concerns them as auditors

## 17 FINANCIAL OBLIGATIONS OF CLUBS

- 17.1 Each Club shall by 1st October in each year pay to the Constituent Body such annual subscription and such other amounts as the Committee may from time to time determine.
- 17.2 On or before 31st December each year a properly prepared Financial Statement for the previous season shall be sent by each Club for examination by the Committee. Such financial statement shall be audited or inspected in accordance with the Rules of the Union



## VI STATUTORY PROCEDURES

## 18 REGISTERED OFFICE

- 18.1 The registered office of the Constituent Body shall be at 20, Fairlands Way, Cheddar, Somerset BS27 3NN or at such other location in England as the Committee may from time to time otherwise determine.
- 18.2 Notice of any change in the situation of the registered office shall be given by the Secretary to the Registrar within fourteen days after the change.

## 19 USE OF NAME OF THE CONSTITUENT BODY

- 19.1 The name shall be kept painted or affixed in a conspicuous position and in letters which are easily legible on the outside of every office or place in which the activities of the Constituent Body are carried on.
- 19.2 The name shall be stated in legible characters in all business letters of the Constituent Body, in all notices, advertisements and other official publications of the Constituent Body, in all bills of exchange, promissory notes, endorsements, cheques and orders for money or goods purporting to be signed by or on behalf of the Constituent Body and in all bills, invoices, receipts and letters of credit of the Constituent Body.
- 19.3 Save with the authority of the Committee, the name of the Constituent Body shall not at any time be used by any Member in any document or advertisement issued or published by, or on behalf of or with the authority of that Member in such a way as to indicate or imply that such document or advertisement was issued or published by or on behalf of the Constituent Body or the Committee.

## 20 SEAL

The Constituent Body shall have its name engraved in legible characters on a seal which shall be kept in the custody of the Secretary and shall be used only under the authority of the Committee, which may determine who shall countersign any instrument to which the seal is affixed and, unless otherwise so determined, it shall be countersigned by any two of the Officers.

## 21 REGISTER OF MEMBERS

- 21.1 The Constituent Body shall keep at its registered office a Register of Members and Officers in which the Secretary shall enter the following particulars:
  - 21.1.1 The name and address of each Member, and, where a Member is a nominee, the name of the Club making the nomination shall be noted against the name of the Member.
  - 21.1.2 A statement of the share held by each Member and the amount paid therefor.



- 21.1.3 A statement of other property, if any, in the Constituent Body held by each Member whether in loans or otherwise.
- 21.1.4The date on which each Member was entered in the Register as a Member and the date on which a Member ceased to be a Member.
- 21.1.5 The names and addresses of the Officers of the Constituent Body with the offices held by them respectively and the date on which they assumed and left office
- 21.2 The Register of Members and Officers shall be so constructed that it is possible to open to inspection the particulars entered pursuant to Rules 21.1.1. 21.1.4, and 21.1.5 without also opening to inspection the other particulars entered in the Register.

## 22 INSPECTION OF BOOKS

All Members and persons having an interest in the funds of the Constituent Body shall be allowed to inspect their own accounts and the particulars entered in the Register of Members and Officers other than those entered under Rules 21.1.2 and 21.1.3 at all reasonable hours at the registered office of the Constituent Body subject to such regulations as to the time and manner of such inspection as may be made from time to time by a resolution passed at a General Meeting.

## 23 ANNUAL RETURN

- 23.1 Every year not later than the date provided by the Act or where the return is made up to the date allowed by the Registrar not later than seven months after such date the Secretary shall send to the Registrar the annual return in the form prescribed by the Registrar relating to the affairs of the Constituent Body for the period required by the Act to be included in the return together with a copy of the Financial Statement of the Constituent Body with the Report of the Auditors where applicable thereon for the period included in the return and a copy of each balance sheet made during that period and the Report of the Auditors where applicable on that balance sheet.
- 23.2 A copy of the latest annual return shall be supplied free of charge on demand to every Member or other person interested in the funds of the Constituent Body.

## 24 PUBLICATION OF ACCOUNTS

The Constituent Body shall keep a copy of the last balance sheet for the time being together with the Report made by the Auditors, where applicable, thereon always hung up in a conspicuous place at its registered office.



## 25 REGISTRATION

These Rules shall take effect on and from the date of their registration pursuant to and in accordance with the provisions of Section 2 of the Industrial and Provident Societies Act 1965.

## 26 DISSOLUTION

In the event of it becoming necessary for the Members to discontinue the activities of the Constituent Body and to dissolve the Constituent Body under the provisions of the Act, its funds and property shall be appropriated or divided amongst the Members in such manner as the Committee consider to be fair and reasonable

## **VII GENERAL**

## 27 CONTINUITY

For the avoidance of doubt, every Member of the Constituent Body who at the date these Rules take effect pursuant to Rule 26 holds office or position in any capacity in the Constituent Body (including the position of Vice-Presidents and/or patrons) shall continue to hold the same office or position following registration. Such Members shall have the same seniority, dates of appointment, dates of retirement and the like after registration as before registration, subject only to such changes as are necessary by virtue of these Rules. The Trustees under the former Rules of the Constituent Body shall, until they have fully discharged their duties, remain as Trustees upon those of the former Rules which relate to Trustees, varied only insofar as these Rules necessarily require.

## 28 INDEMNITY

Each Officer (including under the former Rules of the Constituent Body the Trustees) and employee from time to time of the Constituent Body and each person who was or is from time to time a Member of the Committee or any Sub-Committee shall (to the extent that such person is not entitled to recover under any policy of insurance) be entitled to be indemnified out of any and all funds available to the Constituent Body which may lawfully be so applied, against all costs, liens, charges, expenses and liabilities whatsoever incurred by such person in the execution and discharge of duties undertaken on behalf of the Constituent Body or in relation thereto, or incurred in good faith in the purported discharge of such duties, including any liability incurred in initiating, prosecuting or defending any proceedings, civil or criminal, which relate to anything done or omitted as an Officer or or employee or as a Member of the Committee or any Sub-Committee as the case may be provided that no person who is found guilty of a criminal offence or fraud shall be entitled to an indemnity in respect of their costs, charges, expenses or liabilities relating to any legal proceedings resulting in such conviction or any fine or order for restitution that may result therefrom.



## 29 NOTICES

Any notice or other communication or document sent by first class post to a Member, Officer or Member of the Committee shall be treated as having been given twenty-four hours after the time when it was posted.

## 30 ARBITRATION

Every dispute of the type specified in Section 60 of the Industrial and Provident Societies Act 1965 or any amendment, modification or re- enactment thereof (not being one in respect of which the decision falls to be made in some other way under these Rules) shall be referred to the arbitration of a single arbitrator (pursuant to the Arbitration Act for the time being in force) to be appointed in default of agreement between the parties to the dispute by the President (or failing whom one of the other office holders) for the time being of the Union.

## 31 INTERPRETATION

Subject to the provisions of the Act, any difference of opinion as to the interpretation of these Rules or on any matter not provided for therein shall be decided by the Chairperson of a General Meeting at such Meeting or by the Committee in every other circumstance, and every such decision shall be recorded in the minutes and shall be accepted as the true meaning until thereafter otherwise interpreted on due notice at a subsequent General Meeting.

## 32 SCHEDULE OF DEFINITIONS

"Auditors" means the auditors of the Constituent Body for the time

being.

**"RFU Council Member"** means the representative(s) elected to represent the

accordance with the Rules of the Union for the time being

registered with the Registrar.

"Club" means a club admitted into membership of the

Constituent Body in accordance with the Rules of the

Constituent Body.

"Constituent Body" means Somerset County Rugby Football Union Limited.



**"Committee"** means the committee designated in Rule 13 and

"Committee Member" or "Member of the Committee" means a member of the Committee for the time being and

shall include a person co-opted under Rule 11.2.

**"Financial Statement"** means a Balance Sheet together with a Statement of

Accounts showing Income and Expenditure.

**"Game"** means the game of Rugby Union Football.

**"General Meeting"** means a general meeting of Members.

**"Honorary Life Members"** means persons, in recognition of outstanding service to the Constituent Body, nominated by the Committee and

elected by the Members in General Meeting.

**"Secretary"** means the Secretary of the Constituent Body for the time

being.

**"Individual Members"** means members of Clubs who are elected to membership

of the Constituent Body by the Committee, having first been proposed and seconded by two existing Individual

Members

**"Laws of the Game"** means the laws promulgated by the World Rugby from

time to time according to which the Game is played

throughout the world.

**"Member"** means a member of the Constituent Body.

"Officers" means the officers designated in Rule 12.

"Registrar" means the Chief Registrar and Assistant Registrars for

England in the Central Office of the Registry of

Friendly Societies.

"Regulation" means a resolution, regulation or instruction made in

accordance with Rule 412

"Rules" means the Rules of the Constituent Body for the time

being registered with the Registrar.

**"Union"** means the Rugby Football Union



"World Rugby"

means the world Governing Body of the Game, which at the date of the adoption of these Rules is the International Rugby Board of which the Union is a member.

"World Rugby Regulations"

means the Resolutions and Regulations relating to the Game promulgated by World Rugby from time to time.





## SOMERSET COUNTY RUGBY FOOTBALL UNION LIMITED REGULATIONS

## 1. SUBSCRIPTIONS AND MATCH TICKETS:

The rates of subscription to the Constituent Body shall be decided by the Committee and any alteration shall be confirmed by the members of the Constituent Body at an Annual General Meeting. Membership should be current from 1st September in any one year to 31st August in the next year. The appropriate membership subscription shall be paid by 30th September in the current year or the member will be liable to be struck off the membership register and the member's voting rights will be lost.

Individual Members shall be entitled to:

- (a) Free admission to any Somerset club ground (and a stand ticket if available) for any home County friendly fixture.
- (b) Apply to purchase stand tickets at any home County Championship fixture. Prior consideration will be given to applications for the first two such tickets applied for, the first of which shall be supplied free of charge. All members will be notified of the closing date for such ticket applications.
- (c) Apply for international tickets and for tickets against touring sides in which Somerset are involved as one of the host counties.

## 2. THE PRESIDENCY:

Subject to re-election at the Annual General Meeting, the President, who must be a member of the Constituent Body, will normally serve a two-year term of office. During the President's first year of office, the retiring president shall remain a co-opted member of the Committee, if not an elected member of the Committee, for one year only. At the end of the President's first year of office, the Committee will nominate a President-Elect to succeed the President at the end of his two-year term. This nomination shall be approved by the members at the Annual General Meeting. Any nominee for President must have served a minimum of five years on the Committee. The President-Elect shall serve on the Committee as a co-opted member if not an elected member of the Committee.

## 3. PATRONS:

Each year at the Annual General Meeting, Patrons of the Constituent Body shall be elected from past and present members of the Constituent Body in recognition of their service to the Constituent Body. Nominations for Patrons must be in the hands of the Secretary not later than 30th April in each year.



## 5. REPRESENTATIVES OF MEMBER CLUBS:

The Secretary of each affiliated club shall, for various purposes, be considered as the club's representative in connection with the Constituent Body, although it is not necessary that he or she shall be one of the club's delegates at General Meetings. Notices of all matters in which clubs are concerned shall be deemed to be served on a club if communicated to the club's Secretary at the address which was last supplied to the Secretary of the Constituent Body. All changes in Secretaries and any changes in addresses must be advised to the Secretary of the Constituent Body as soon as possible.

## 6. QUALIFICATIONS FOR PLAYERS:

A player selected to play for the County need not necessarily be a member of the Constituent Body provided they comply with the current RFU Regulations with regard to County Championship player qualifications.

## 7. COLOURS:

The colours of the Constituent Body shall be Black, White and Crimson. All players participating in County matches shall wear the County jersey (normally black, white and crimson hoops with white collar) and black shorts. A player who plays in their first County Championship match shall be awarded a County tie. On the fifth occasion a player plays in a County Championship match or plays in four matches and is selected for a fifth match that is cancelled, they shall be awarded a County blazer badge. When a player has played in twenty County Championship or other matches recognised by the Committee, they shall be awarded a County cap.





## 8. CAPTAIN:

The Senior Playing Committee shall appoint from time to time the Captain of the Senior County XV and may, at its discretion, request their assistance for the purpose of selecting the Senior County Squad.

## 9. COACH:

The Committee shall have the power from time to time to appoint a County Coach and to determine the Coach's terms and conditions of employment including any remuneration if appropriate.

## 10. PLAYERS INSURANCE:

The Committee shall insure the Constituent Body teams' players under the RFU Death & Total Disability Scheme and at its discretion effect loss of earnings and other cover with the South Western Division Rugby Football Mutual Benefit Fund or any other appropriate organisation.

## 11. EXPENSES:

Committee members and players shall be entitled to reclaim all legitimate out-of-pocket expenses on application to the Honorary Treasurer. All such payments are made at the discretion of the Admin and Finance Sub-Committee.

## 12. COMPETITIONS:

County Cup competitions at all levels shall be administered by a Competitions Sub-Committee, which shall be responsible for drafting rules for those competitions and any subsequent amendments to those rules, all of which shall be subject to final approval by the Committee.

## 13. AUDITORS:

The Constituent Body's auditors, if appointed, shall be Registered Auditors.

## 14. ALTERATIONS TO REGULATIONS:

No regulation may be altered or rescinded or any new regulation included without the consent of two-thirds of the Members present at an Annual General Meeting or Special General Meeting. Notice of any changes to the Regulations must be given in writing to the Secretary of the Constituent Body together with the names of the proposer and seconder in the case of an Annual General Meeting by 30th April prior to the meeting and in the case of a Special General Meeting at least one month before the date of the meeting.



## 15. DIFFERENCES OF OPINION AS TO THESE REGULATIONS:

In the case of any difference of opinion as to the meaning of these Regulations, such meaning shall be decided by the Committee or, if it occurs at a General Meeting, by the Chairperson of the meeting. Any such decision shall be recorded in the appropriate minutes and shall be accepted as the true meaning of the Regulation unless otherwise interpreted at a General Meeting, after due notice has been given.

## 16. MATTERS NOT PROVIDED FOR IN THESE REGULATIONS:

Any matter not provided for in the Rules or these Regulations shall be discussed and settled by the Committee and the members shall be bound thereby until the date of the next Annual General Meeting of the Constituent Body when any new ruling of the Committee, provided that due notice of the same has been given (under Rule 8.5) to the Secretary of the Constituent Body, shall be brought before the meeting for ratification or otherwise.
