- 2. The mare shall be healthy and in sound breeding condition and free from infection or disease and all necessary veterinary examinations and treatments will be carried out in order for the mare to conceive and maintain her pregnancy.
- 3. All paperwork must be completed and all fees paid and cleared before the shipping of semen.
- 4. Frozen Semen in Australia:
  - a. Stallion Owner will release the dose(s) after payment clears.
  - b. Gene Movers will despatch within Australia at Mare owners expense.
  - c. One breeding dose of 8 straws (0.5ml each totaling 1.5 billion sperm) will be released per fee. If more than one foal results, additional fee(s) will be required.
