1. REPORTS [Enhancement]

This new report #4104 provides a summary of real estate bills for a year range, as of a date 1, by parcel type, and bill category.

#4104 Real Estate Bills-As of a Date-By Parcel Type

The report provides 2 subtotals for type within each year; subtotals for each year and provides a grand total for all years. To run the report, go to:




Figure 1 Report 4104 "Run as" ⊙ Excel®




Figure 2 Report 4104 "Run as" ⊙Print ⊙Preview ⊙ PDF®

Do not use spaces between the email addresses.




Figure 3 Enter multiple email addresses, separated by a comma, with no spaces between the addresses
