1 New SSL Compliant Email Client “ADMBLAT”

ADMINS is replacing the current email client “BLAT” with a more modern email client “ADMBLAT” to send out AUC system messages, e.g., Approval Emails, Notices that the Software Update is Complete, etc. **If you do not wish to use the GMAIL account, we can accommodate sites that wish to use their current setup.**

Currently most sites are using **port 25** for access to the email server, however, to use the **secure port 587**, updates to the current email server to allow access from the IP address of the AUC server via port 587 will need to be setup.

1.1 Information Technology Staff

ADMBLAT routes email traffic through a secure GMAIL account using **SSL** for direct service so that an email server or a direct connection to the current email server is no longer required. The new Client, called “ADMBLAT”, is SSL compliant and will be installed this week. Please whitelist the account: auc.do.not.reply@gmail.com.

1.2 AUC Users

Users of the AUC software will not see a difference in **sending** emails from the AUC software. There will be a slight difference in the “From” line in the header display of the email being **received**.

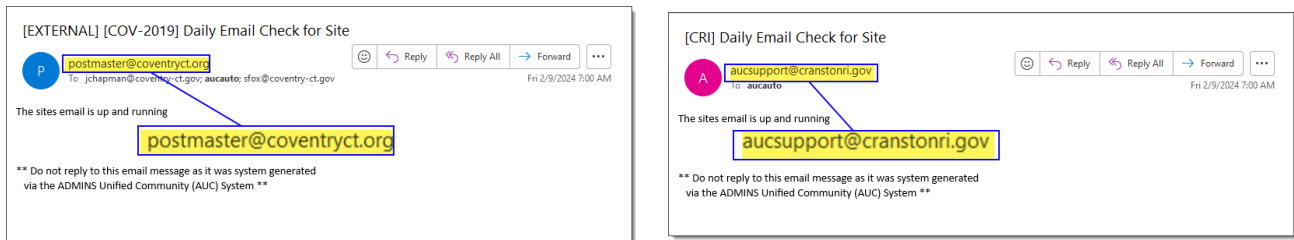


Figure 1 Before System Generated emails looked like this

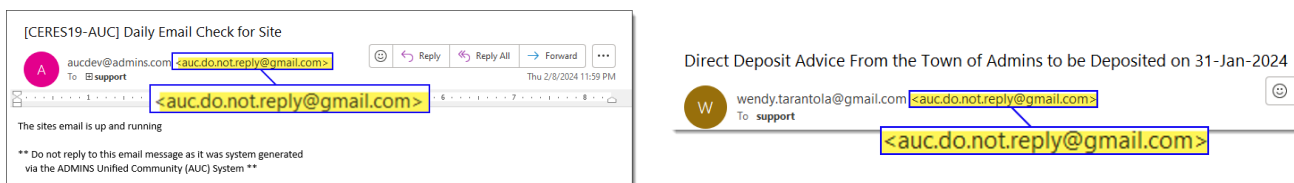


Figure 2 After System Generated emails include the auc.do.not.reply@gmail.com as part of the “From” in the header

1.3 Direct Deposit Emails

Tell the recipients of Direct Deposit emails that they should add the email address “auc.do.not.reply@gmail.com” to the list of safe senders in their email client.

1.4 Approval & Notification Emails

The new email will show auc.do.not.reply@gmail.com in the “From” line in the header of the email to remind recipients that it is a system generated message. If your site has been set up with a generic “From” email address, e.g., “support@customer.com” or if the user’s email address is used as the “From” address when sending email, the emails will



still show that as the “From” address, along with the auc.do.not.reply@gmail.com to remind them not to reply directly to the email.
