# **DISCLAIMING A TAX TAKING**

A tax title is a lien placed on property to enforce the collection of property taxes. Run the disclaim taking process if the Tax Title is invalid. MA General Law (always check the state website to ensure that the most current information is used):

General Law - Part I, Title IX, Chapter 60, Section 84 (malegislature.gov):

# Section 84: Reassessment or collection of taxes where title invalid; disclaimer by municipality of title

Section 84. If the collector has reasonable cause to believe that a tax title, held by a town under a sale or taking for non-payment of a tax, is invalid by reason of any error, omission or informality in the assessment, sale or taking, he may disclaim and release such title by an instrument under his hand and seal, duly recorded in the registry of deeds. If the invalidity of a tax title so disclaimed and released or of a tax title released under section eighty-two or eighty-three was caused by an error, omission or informality in the assessment, the collector shall, upon the recording of such disclaimer and release or after obtaining from the holder of the deed a release of his interest or after causing a copy of the notice to be filed and recorded as provided in section eighty-three, forthwith notify the board by which the tax or assessment was laid, which shall forthwith reassess it as provided in section seventy-seven of chapter fifty-nine. If such invalidity was caused by an error, omission or informality in the proceedings of the collector, he shall, after the recording of such disclaimer and release, or after obtaining such release or after filing or recording such copy, forthwith collect the unpaid tax or assessment in conformity to law.

The intent when disclaiming is to remove the taking, reverse the accounting, and make the regular real estate bill available for collection.

#### Table 1 Column descriptions for the Disclaimer Account Detail report

Column Label	Description
Bill Number	The bill number for the original Real Estate tax. The disclaim process will restore the charges to the bill number originally charged.
Location & Owner	The location address of the parcel being disclaimed; The owner of the parcel being disclaimed
Qtr	The Quarter the charges were committed & billed
Category	The number and description of the category
Charge	The original charge at the time of taking
Abt_Exm	Any abatements or exemptions applied to the original charge
Pay_Adj_Ref	Any payments, adjustments, and refunds applied to the original charge
Balance	The balance to be restored to the real estate bill
*** Total*** # Bills:	The # of bills being disclaimed (usually one)
Selection Legend	Shows the Parcel # being disclaimed

### **1.2 Edit the Disclaimer Workfile**

#### Edit Disclaimer Workfile

The **[Edit Disclaimer Workfile]** button will display the **Edit Disclaimer Workfile** screen. If multiple years are listed here, select just the one to be diclaimed. Click on the **[1 Detail]** button to view details for the selected year. These screens are for viewing only; no data may be changed.

#### Table 2 Describes the screen components of the Edit Disclaimer Workfile screen

Column Header	How used
Select All	Use the [Select All] button to select all the years listed to be disclaimed.
Deselect All	Use the [Deselect All] button clear the checkbox on every year
Ø	Check this box to select this year to be disclaimed.
Year	The tax year for the taking being disclaimed – there can be multiple years listed; select the year to be disclaimed
TY	The type will be 70, the Tax Title Bill Type
[2 Bill Number]	The bill number for each tax year is listed – the column header is a clickable button to allow sorting and finding a bill
[3 Parcel]	The category number and description (Tax, Tax Interest, Demand, Utility Liens)
Owner	The name of the owner of the parcel
Cert Amount	The amount to be disclaimed
Menu	The Menu button will return the display to the step menu

### **1.3** Post Tax Title Disclaimed Accounts

Post Tax Title Disclaimed Accounts

The last step is to post the **Tax Title Disclaimed** accounts. The

**Transaction Date** and **Date of Taking** are required; both must be entered on the prompt. The date of taking defines for the system which amounts are to be disclaimed, so it must match the date of the original taking.

In the example, the **date of taking is February 15, 2021**. An error is discovered prior to that, and the **disclaim** transaction is done **on January 19, 2021**.

Only the dollar amounts that were originally booked to Accounts Receivable (that are marked in the bill category table to post to A/R) will be included in the GL posting. All charges as of the date entered will be reversed in the Collections module. See the Bill Category table and RC–450 Original Tax Taking document in the Help Reference Library.

### 1.4 Update Billing Records

Posting the disclaim removes transactions in the Tax Title bill and brings the Tax Title balance for the selected year to zero. It also restores transactions to the regular real estate bill, adding the charges back to it and making it available for collections.
