




Figure 1 Prompt requires a Tax Title Code

ADMINS added the option to include the redemption fee as a *****note** to the statement so that the amount required to fully pay off this account is listed.

Adding the fee here does not add it to the parcel record. If the parcel already has a redemption fee applied for that bill year – it will not add it again.

Figure 5 New option for printing a redemption fee on the statement

The Certificate of Redemption fee for the highest bill year taken for that parcel will be added to the form if a Certificate of Redemption fee does not already exist for that parcel. When added to the statement, it will include a *** suffix to alert users that this fee has not been applied to the parcel but added only to the statement.


