## ITINERARY

### DAY ONE

Departing early this morning, you will travel north to Boston, MA. Rest stops and a 1 hour lunch stop (at your own expense will be made enroute. Late this afternoon, you will check into the Encore Boston Harbor Hotel. The **Encore Boston Harbor Hotel** is a luxury resort and casino located just north of downtown Boston in Everett, MA along the Mystic River. The hotel features a spa, salon, fitness center, retail shops and a variety of dining venues from fine dining to casual. The casino features 1800+ slot machines and over 185 table games. Dinner is on your own here this evening. Each guest will receive a slot-play-credit for the slot machines and meals vouchers valid for breakfast and dinner. Dinner is on your own at one of the many Encore restaurants this evening.

### DAY TWO

Following breakfast and check-out, you'll hop aboard the motorcoach and head for New Hampshire. Mid-morning you'll arrive at the **CONWAY SCENIC RAILWAY** in North Conway, NH for boarding your train. A local guide will meet you here and accompany you on the rail journey. A boxed lunch will be served aboard the train.

On the **CONWAY SCENIC RAILWAY TRAIN**, you'll travel on what was once the Maine Central Railroad's famed Mountain Division line, on tracks that were laid in the 1870s. Enjoy some of the most dramatic natural scenery in the East as you travel through spectacular Crawford Notch – past sheer bluffs, steep ravines, cascading brooks and streams, panoramic mountain vistas, across Frankenstein Trestle and Willey Brook Bridge en route to Crawford Station.

As you travel through this rugged terrain, you can begin to appreciate what a remarkable engineering achievement constructing this railroad was almost 140 years ago. Live commentary onboard includes history and folklore of the railroad and area, as well as points of interest.

Arriving at Crawford Station in Carroll, NH you will disembark the train and board your waiting motorcoach. You will continue touring through the White Mountains, viewing the best of New Hampshire's fall foliage where photo opportunities and scenic vistas abound.

This afternoon, enjoy a ride on the **CANNON MOUNTAIN AERIAL TRAMWAY** to the top of Cannon Mountain. You'll see spectacular rugged mountain scenery with a short loop trail around the summit showing off the towering peaks of the Franconia and Kinsman mountain ranges, with views of Maine, New Hampshire, Vermont and Canada.

Following your ride on the Cannon Mountain Aerial Tramway it's a short ride to Lincoln, NJ and your hotel for the next two nights, the **MOUNTAIN CLUB ON LOON RESORT**. Dinner is included this evening at the hotel.

### DAY THREE

Following breakfast at the hotel, say hello to your local guide you will take you on a full day of sightseeing. Your first stop this morning will be **LAKE WINNIPESAUKE** (one of the largest lakes enclosed in one state), for a scenic cruise aboard the 230 foot **M/S MOUNT WASHINGTON**. Your journey on the ship brings you to the port of Wolfeboro, The Oldest Summer Resort in America. Arriving in Wolfeboro, you'll have free time this afternoon for lunch (at your own expense) and shopping in this delightful lakeside town.

After lunch you will visit the **WRIGHT MUSEUM** - a museum about the World War II years with both war exhibits such as aircraft and tanks, and exhibits from everyday life. Unique to traditional World War II museums, the 14,000+ items in the collection are representative of both the home front and the battlefield.

Departing Wolfeboro late afternoon, you will travel to North Woodstock, NH to the **CAFÉ LAFAYETTE DINNER TRAIN**. Escape the ordinary and relive the romance of dining on the rails while riding in a

beautifully restored Pullman dining car. Enjoy five courses of freshly prepared fine food served in the Grand European Manner, with magnificent mountain vistas and lush New England forests just outside your window. Following the dinner train, the motorcoach will return you to your hotel.

#### **DAY FOUR**

After breakfast at the hotel and check out, you will depart and travel through Vermont to the Berkshire Mountains. Along the way, you'll make a stop at the **VERMONT COUNTRY STORE**. "Today, The Vermont Country Store is owned by Lyman Orton and sons Cabot, Gardner, and Eliot, 7th & 8th generation Vermonters and 4th & 5th generation storekeepers. They adhere to the old-fashioned values set forth by founder, Vrest Orton, and take pride in being Purveyors of the Practical and Hard-to-Find. In today's global economy, merchants at the Vermont Country Store search throughout the nation and abroad to find goods that fill the needs of American and international customers alike. Speaking for the Orton family, Eliot says, "We still go to great lengths to find products that aren't sold anywhere else."

After your visit to the Vermont Country Store, you'll travel to Bennington, VT for an included lunch at the **PUBLYK HOUSE**. The Publyk House has been a destination restaurant and Bennington favorite for more than 45 years, serving traditional New England fare in a warm and inviting ambiance.

This afternoon, you'll visit the **STERLING AND FRANCINE CLARK ART INSTITUTE**. Nestled in the Berkshires of western Massachusetts, it is well known for its extraordinary collection of Impressionist and Renaissance paintings as well as works by popular American artists such as Frederic Remington and Winslow Homer. The museum houses a collection of more than 30 paintings by Renoir. Other exhibits include a sculpture collection, exceptional examples of English silver, porcelain, early photographs, many prints and drawings, along with various decorative arts. The museum is famous for its art presentation and its idyllic setting.

Departing the Clark Art Institute, you will continue to travel through the Berkshire Mountains to your local hotel and check in. Dinner is included this evening at a local restaurant. Following dinner, you will return to the hotel.

#### **DAY FIVE**

Following breakfast and checkout, you will visit the **NORMAN ROCKWELL MUSEUM** in Stockbridge, MA. See many of the **illustrator's** works in the original **oil paintings** at your own pace. Be surprised and delighted at the magnificence of Rockwell's large scale original paintings and discover the highly relatable world of American Illustration – the art that tells our stories. There's always something new to enjoy with ten galleries of ever-changing special exhibitions, engaging programs, a scenic 36- acre campus, and more.

After your visit to the museum, you will have free time for lunch (at your own expense) and exploring in downtown Stockbridge, a picture postcard town where Norman Rockwell lived and worked. There are a variety of small restaurants to choose from in this quaint town. You may wish to take time to visit the **RED LION INN** and see the antique furniture and their famous "teapot collection" featuring hundreds of teapots from all over the world! Following lunch, you will depart for home, making the customary rest and meal stops en route.

## GENERAL LIMITATIONS AND EXCLUSIONS

Unless otherwise shown below, these exclusions apply to the Insured, the Insured's Traveling Companion, or Family Member scheduled and booked to travel with the Insured.

### **The following exclusion applies to the Trip Cancellation and Trip Interruption and Medical Expense:**

We will not pay for any loss or expense caused due to, arising or resulting from a Pre-Existing Medical Condition, as defined in the plan.

### **The following exclusions apply to the Medical Expense benefits.**

We will not pay for any loss or expense caused due to, arising or resulting from:

1. routine physical examinations or routine dental care;
2. traveling for the purpose or intent of securing medical treatment or advice;
3. Alcohol or substance abuse or treatment for the same;
4. Normal pregnancy (except Complications of Pregnancy) or childbirth, or elective abortion;
5. a Mental, Nervous or Psychological Condition or Disorder unless Hospitalized or Partially Hospitalized while the plan is in effect;
6. the Insured's participation in Adventure or Extreme Activities, riding or driving in races, or participation in speed or endurance competition or events, except as a spectator;
7. the Insured's participation in an organized athletic or sporting competition, contest, or stunt under contract in exchange for an agreed-upon salary or compensation. This does not include athletes participating in exchange for a scholarship or tuition.

The plan also contains exclusions specific to Baggage & Personal Effects and Baggage Delay.

### **In addition to any applicable benefit-specific exclusion, the following general exclusions apply to all losses and all benefits.**

We will not pay for any loss or expense caused due to, arising or resulting from:

1. suicide, attempted suicide or any intentionally self-inflicted injury of the Insured, a Traveling Companion, Family Member, or Business Partner booked and scheduled to travel with the Insured, while sane or insane;
2. being under the influence of drugs or narcotics, unless administered upon the advice of a Physician as prescribed;
3. activities, losses, or claims involving or resulting from possession, production, processing, sale, or use of marijuana, illegal drugs, alcohol or substances are excluded from coverage;
4. war or act of war, including invasion, acts of foreign enemies, hostilities between nations (whether declared or undeclared), or civil war;
5. the commission of or attempt to commit a felony or being engaged in an illegal occupation by the Insured, a Traveling Companion, Family Member, or Business Partner;
6. directly or indirectly, the actual, alleged or threatened use, discharge, dispersal, seepage, migration, escape, release or exposure to any hazardous biological, chemical, nuclear radioactive weapon, device, material, gas, matter or contamination;
7. piloting or learning to pilot or acting as a member of the crew of any aircraft.

### **Pre-Existing Medical Condition Exclusion Waiver**

The Pre-Existing Condition Exclusion will be waived if the protection plan is purchased within 14 days of the date the initial trip payment/deposit is received, and you are medically able and not disabled from travel at the time you pay for the plan, based on assessment of a physician.
