# ITINERARY

**Day One** – Welcome to New Orleans! Your private motorcoach will pick you up at the New Orleans International Airport and transfer you to the Wyndham Hotel French Quarter for check-in. The hotel is just a short stroll away from the historic French Market District and just steps away from numerous restaurants and Bourbon Street. This evening, enjoy the beauty and romance of the New Orleans skyline aboard a dinner jazz cruise on the authentic Steamboat NATCHEZ. Boarding in the French Quarter, you will head downriver past the historic Riverfront while The Dukes of Dixieland perform those happy brassy tunes for which New Orleans is so well known.

**Day Two** – Enjoy a full buffet breakfast this morning at the hotel before embarking on a day of sightseeing. Say hello to your local guide who will take you on a driving tour of the city. The tour will take you past some of the most iconic sights in the Big Easy, including the elegant homes of the Garden District, the Superdome and the iconic above ground cemeteries. Following your driving tour, you will visit the French Market District for shopping and lunch (at your own expense). Similar to some European markets, this historically charming open air market features shopping, dining, music and local tradition that is uniquely New Orleans. From Café du Monde near Jackson Square to the flea market at the end of Esplanade Avenue, the French Market includes five blocks of local produce,

specialty art, handmade crafts and more.

Later this afternoon you will visit the National World War II Museum. From the beaches of Normandy to the sands of Iwo Jima, The National WWII Museum's exhibits are a blend of personal accounts, artifacts, documents, photographs and original film footage. The stories of dozens of amphibious landings and the thousands of men and women who made Allied victory in World War II possible are told through three floors of exhibit space. The rest of the afternoon and evening is at leisure for you to enjoy as you wish. Every street in the French Quarter has something to offer from classic restaurants and music venues to boutique shopping. Dinner is at your own expense this evening.

**Day Three** – After breakfast at the hotel and check-out, you will depart New Orleans and travel to Lafayette, LA, in the heart of Cajun and Creole country. Upon arrival, you will take a tour of the Atchafalaya Swamp aboard a sightseeing boat that will take you into the interior of one of America's greatest river swamps. Native Cajun tour guides will explain from personal experience what it is like to live on a houseboat or survive off the swamp – while pointing out the abundant plants of the area and getting you up close and personal with the wildlife! Following the

tour, enjoy lunch at Pat's Fisherman's Wharf, a local favorite known for its tradition of great Louisiana seafood and home style cooking since 1948.

This afternoon you'll explore the area by land with a local guide who will take you on a driving tour and show you the history and highlights of Lafayette including St. John Cathedral, the first church in the Lafayette Parish. You will also visit the St. John Oak, the third oldest member of the Live Oak Society, an organization dedicated to the preservation and appreciation of mature live oak trees in the United States. You will also have time to tour the Cemetery and Cathedral Museum which

commemorates the persons and events that contributed to the history of St. John Cathedral Parish which spans 185 years. Time permitting you may also visit the Alexandre Mouton House, built in the early 1800's and later home to Louisiana's 12<sup>th</sup> governor, Alexandre Mouton. It is now restored to its 1850's grandeur and serves as a museum of period furnishings, historical and cultural memorabilia and Mardi Gras costumes.



Following your tour of Lafayette, you will check into your hotel for the next two nights, the Drury Inn Lafayette. After a chance to relax and freshen up, enjoy a dinner tonight at Prejean's Restaurant. Award-winning Cajun cuisine and live Cajun music make Prejean's Restaurant a one-of-a-kind dining experience.

**Day Four** – Breakfast is included this morning at the hotel. Following breakfast, say hello to your local guide who will start your day of sightseeing with a tour of St. Martinville. The tour will include a visit to Historic Evangeline Oak, a walk on the Boardwalk along Bayou Teche, St. Martin de Tours Catholic Church and Evangeline Statue. The guide will tell you of the legend of Evangeline, immortalized in the poem of the same name by Henry Wadsworth Longfellow.



From St. Martinville, you will travel to Avery Island, home of the only Tabasco Factory in the world. Here, you'll tour the visitor center and the pepper sauce factory. Did you know that Tabasco is aged in white oak barrels just like bourbon? You'll view a short film on TABASCO® history and take a guided tour of the bottling and packaging operations. You'll also have time to browse the wide array of products and souvenirs for sale in the TABASCO® Country Store.

Next you will visit the 250-acre Avery Island Jungle Gardens & Bird Sanctuary. The gardens feature a variety of azaleas, camellias and bamboo. You might even spy some alligators, deer and raccoons that live in the hills and marshes around the gardens. The Bird Sanctuary is home to thousands of snowy egrets who nest on the island each spring on specially-built, pier-like structures in a pond nicknamed "Bird City."

This afternoon features a tour of Rip Van Winkle Gardens. This twenty five-acre semi-tropical paradise features a year-round explosion of color where irises, magnolias, hibiscus, camellias, azaleas, thousands of springtime bulbs and a breathtaking array of annuals paint a landscape across the Southern sky.

As you walk through the Gardens, you will see many unusual plants and historic sites. The Jean Lafitte tree is one of them. Three buried treasure chests were found there in 1928. The treasure is believed to have been buried by the pirate Jean Lafitte. Also on site is the Joseph Jefferson Mansion, which was built in the early 1870's. The mansion is filled with period antique furniture and paintings. Returning to Lafayette, you will have dinner this evening at Randol's, famous for their seafood and Cajun specialties as well as the live zydeco bands and dance floor.

Insurance benefits are not payable for any loss due to, arising or resulting from: 1. suicide, attempted suicide or any intentionally self-inflicted injury of You, a Traveling Companion, Family Member or Business Partner booked to travel with You, while sane or insane; 2. an act of declared or undeclared war; 3. participating in maneuvers or training exercises of an armed service, except while participating in weekend or summer training for the reserve forces of the United States, including the National Guard; 4. riding or driving in races, or speed or endurance competitions or events; 5. mountaineering (engaging in the sport of scaling mountains generally requiring the use of picks, ropes, or other special equipment); 6. participating as a member of a team in an organized sporting competition; 7. participating in bodily contact sports, skydiving or parachuting, hang gliding or bungee cord jumping; 8. piloting or learning to pilot or acting as a member of the crew of any aircraft; 9. being Intoxicated, or under the influence of any controlled substance unless as administered or prescribed by a Legally Qualified Physician; 10. the commission of or attempt to commit a felony or being engaged in an illegal occupation; 11. normal childbirth or pregnancy (except Complications of Pregnancy) or voluntarily induced abortion; 12. dental treatment (except as coverage is otherwise specifically provided); 13. amounts which exceed the Maximum Benefit Amount for each coverage as shown in the Schedule of Benefits; 14. due to a Pre-Existing Condition, as defined in the Policy.
