

Borough of Elmer Minutes**May 13, 2020**

CALL TO ORDER: A Regular Meeting of the Borough Council convened in the Borough Hall and by conference call at 7:30 p.m. with Mayor Joseph Stemberger presiding.

FLAG SALUTE AND INVOCATION: Mayor Stemberger dispensed with the invocation and the flag salute and noted that adequate notice of the meeting was provided on May 7, 2020 pursuant to the Open Public Meetings Act.

ROLL CALL: Council President Lewis Schneider (phone), Council Members Lynda Davis (phone), Bruce Foster (phone), Cynthia Nolan (phone), Steven Schalick, James Zee (phone) and Mayor Joseph Stemberger answered to the roll call. Also present were Solicitor Brian Duffield (phone), Chief Financial Officer Cynthia Strang, and Clerk Sarah Walker.

APPROVAL OF MINUTES: Motion Foster second Davis to approve the minutes from the Regular Council Meeting held on April 8, 2020 and the Special Meeting held on May 4, 2020 and to dispense with the reading of the minutes.

PUBLIC SESSION: Motion Davis second Nolan to open the public portion of the meeting. All were in favor and the motion carried.

Cindy Strang, representing the Presbyterian Church, asked the intent of the Borough Council regarding the fees associated with the Landlord Registration. Council members discussed whether the Landlord Registration fee should be imposed when the registration is amended for a change in tenancy or only annually. Council consensus was that the fee is annual and amended registrations should not be charged a fee. Solicitor Duffield will prepare an ordinance to clarify the intent for next month's meeting.

RESOLUTION FOR THE SELF-EXAMINATION OF THE 2020 BUDGET**

Number 45-20

WHEREAS, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit

municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and

WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997; and

WHEREAS, pursuant to N.J.A.C. 5:30-7.2 through 7.5, the Borough of Elmer has been declared eligible to participate in the program by the Division of Local government Services, and the Chief Financial Officer has determined that the local government meets the necessary conditions to participate in the program for the 2020 budget year.

NOW THEREFORE BE IT RESOLVED by the governing body of the Borough of Elmer that in accordance with N.J.A.C. 5:30-7.6a & 7.6b and based upon the Chief Financial Officer's certification, the governing body has found the budget has met the following requirements:

1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:
 - a. Payment of interest and debt redemption charges
 - b. Deferred charges and statutory expenditures
 - c. Cash deficit of preceding year
 - d. Reserve for uncollected taxes
 - e. Other reserves and non-disbursement items
 - f. Any inclusions of amounts required for school purposes.
2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at N.J.S.A. 40A:4-45.3 et seq., are fully met (complies with CAP law).
3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
4. That pursuant to the Local Budget Law:
 - a. All estimates of revenue are reasonable, accurate and correctly stated,
 - b. Items of appropriation are properly set forth
 - c. In itemization, form, arrangement and content, the budget will permit the exercise of the comptroller function within the municipality.
5. The budget and associated amendments have been introduced and publicly advertised in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.
6. That all other applicable statutory requirements have been fulfilled.

BE IT FURTHER RESOLVED that a copy of this resolution will be forwarded to the Director of the Division of Local Government Services upon adoption.

**BOROUGH OF ELMER COUNTY OF SALEM RESOLUTION TO AUTHORIZE
THE MAILING OF 2020 THIRD QUARTER ESTIMATED TAX BILLS**

WHEREAS, all the annual budgets needed for **2020** total tax rate for the Borough of Elmer have not been finally set; and

WHEREAS, the governing body of the Borough of Elmer has therefore determined that the Tax Collector will be unable to complete the mailing and delivery of municipal tax bills by **June 30, 2020**; and

WHEREAS, N.J.S.A. 54:4-66.3 provides the authority and procedures by which an estimated and reconciled tax bill can be set and mailed by a municipality in such case made, by June 30th of the said year.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Elmer as follows:

1. The Tax Collector in consultation with the Chief Finance Officer (CFO) of the Borough of Elmer shall compute an estimated annual tax levy range for the County and each taxing district whose tax levy has not yet been certified by the County Board of Taxation, which as of this date such levies have not been so certified.
2. The range may be within the lower and upper amounts calculated by multiplying the levy of the County and each such taxing district for the previous calendar year by 0.95 and 1.05.
3. The Borough CFO has prepared, delivered, and recommends to the governing body a Certification of the previous calendar fiscal year's annual tax levy with a multiplier of 1.05 to determine an estimated annual tax levy for the County and each such taxing district for the current year.

4. The governing body hereby authorizes the CFO, working in conjunction with the Tax Collector, by **June 30, 2020** to prepare and deliver estimated annual tax levy bills for the County and each such taxing district computed by utilizing the multiplier of 1.05 of the previous calendar fiscal year annual tax levy, and thereafter, to be administered in accordance with the procedures and standards as established by N.J.S.A 54: 4-66.3.

WHEREAS, Mayor and Council of the Borough of Elmer determined that the resurfacing of State Street Section 3 was necessary; and

WHEREAS, consistent with the New Jersey Public Contracts Law, N.J.S.A. 40A:11-23, the Borough Clerk caused an advertisement for solicitation of bids for the resurfacing of State Street Section 3; and

WHEREAS, pursuant to Resolution Number 99-19 the Mayor and Council of the Borough of Elmer on December 11, 2019 approved and awarded the low bid submitted by Arawak Paving Company; and

WHEREAS, the Borough's Engineer via correspondence dated May 8, 2020, attached hereto, has recommended Payment #1 in the sum of \$108,502.62 (total earned amount \$110,716.96 less 2% retainage \$2,214.34); and

WHEREAS, based upon the Engineer's submission and recommendation, it is in the best interest of the residents of the Borough of Elmer that Payment #1 be approved by Mayor and Council.

1. **NJDOT Grant:** Council President Schneider discussed the next round of NJ Department of Transportation (NJDOT) grant applications due July 1 and recommended switching from road projects to new sidewalk installations. Council members were in favor of alternating between new sidewalks and streets projects for the NJDOT grants.
