Legacy Church – EVENT CONSENT AND RELEASE OF LIABILITY

1. RELEASE OF LIABILITY

I understand that the opportunity to attend an event at Legacy Church, (here after referred to as Legacy) is a privilege. In consideration for that privilege, I am signing this Release of Liability form on behalf of myself and/or my minor child(ren).

I understand that my child(ren) may participate in any number of physical activities some of which include, but are not limited to, recreational activities and games. I understand that there are certain risks of physical injury or illness associated with these activities. I understand that, while recommended precautions will be taken by staff, my child(ren) could be exposed to one or more communicable illnesses. In addition, I understand that there may be other risks associated with these activities of which I may not be presently aware.

By signing this Release, I expressly assume these risks for myself and/or my child(ren), whether such risks are known or unknown to me at this time. I release Legacy, including its affiliated chapters and their officers, directors, volunteers, employees, contractors and agents, from any claim that I or my children may have now or in the future against them for any physical and personal injury, illness or death due to participation in Legacy activities. This release of liability shall cover (without limitation) all claims for negligence and breach of fiduciary duty asserted by myself and/or my child(ren) or any person made on their behalf.

2. AUTHORIZATION FOR MEDICAL TREATMENT FOR MINORS

In case of emergency, I understand that efforts will be made to contact me; however, if I cannot be reached, I hereby give Legacy, and its representatives, permission to act on my behalf seeking emergency medical treatment for my child(ren). I release Legacy, its representatives, and all medical providers from liability in acting in this regard and rendering such medical treatment. I will be fully responsible for all such medical expenses.

I represent that I am the parent/guardian of the child named below, who is under 18 years of age. In consideration for allowing my child(ren) to participate in Legacy activities, I hereby consent to the foregoing on behalf of my child(ren) and agree that this release shall be binding upon me, my child(ren), our heirs, legal representatives and assigns.

I hereby agree to defend, indemnify and hold Legacy, their directors, volunteers, employees, contractors and agents, harmless from any liability asserted by my child(ren) subsequent to his/her reaching majority, including reasonable attorney's fees and costs. I also warrant that my child(ren) is physically fit and able to participate in all Legacy activities.

3. AUDIO/VIDEO RELEASE

Representatives from Legacy Church may wish to photograph, video, and/or interview individuals who are attending. In order to release and use photos, audio/video footage and/or comments from you and/or your minor child(ren/ward(s), we ask for your written permission.

I give my consent for Legacy Church to use photos, videos, or audio of the registrant. I understand that video, images or voice recordings may be used in various media, including but not limited to, videos, newsletters, and on the church website. This consent is continuing in nature and will remain in effect unless later revoked in written form.
