Mr. Shawver:

I have outlined Chantal's case plan tasks below. Also, Chantal was provided the attached UA Color Code letter back in October and November, and I have offered numerous times to resend it, to which she has declined. I had a very lengthy text correspondence with Chantal back in March (March 5th) and I provided those text messages to the Court with our April Court Report – outlining specifically the color code/UA process. I also sent a lengthy email (attached) to her previous attorney in November 2017 to relay to her as well, as at that time she was refusing to have contact with KVC at all. I also had email correspondence with Chantal on June 11th regarding the requirements of her Mental Health intake. KVC is willing to help set up the parenting evaluation, and I offered to set up the mental health intake as well – but she declined. We really are here to help her get these things accomplished, she has just refused to work with us. As for the UA's – her color is Black, and is typically called one time per week. Sometimes more than that. It is set up randomly and she is to call into the office daily to see if her color is called. So potentially, she could have a visit scheduled within 2 weeks if she were to drop the next two times her color is called.

- 1.1 Chantal will maintain stable, clean and safe housing. Documentation will be provided to KVC upon request. (utility, lease)
- 1.2 Chantal will sign all releases as requested by KVC.
- 1.3 Chantal will complete a mental health intake.

- 1.4 Chantal will follow recommendation of mental health.
- 1.5 Chantal will complete an anger management assessment.
- 1.6 Chantal will follow the recommendation of the anger management assessment.
- 1.7 Chantal will be placed on the KVC color code system.
- 1.8 Chantal will provide two clean ua's for visitation occur.
- 1.9 Chantal will complete a parenting evaluation.
- 1.10 Chantal will follow recommendations of parenting evaluation.

Mr. Shawver,

I am aware that you have been trying to arrange visitation between Chantal and Synthia. However, we still do not have documentation that Chantal has done everything requested. It's my understanding you sent a couple of UA's to Heather Quinn that Chantal completed, and while I'm happy that she did those, she did not submit the UA's on her color code day. I believe Heather responded with information regarding how our color code system works. The UA's must be random, submitted on the assigned day, and she must have at least 2 consecutively before visitation will be arranged. I know you are newer to this case, but it has been pending for about 10 months and Chantal has not complied with anything, or at least has not provided any documentation to KVC to show proof of compliance. Reintegration home before school starts is not very likely at this point as we haven't even been able to set up visits due to non-compliance with the Court ordered UA's.
