## Overview

## Information We Collect

### Information You Provide

### Information We Collect Automatically

- Device information (model, operating system, unique identifiers)

- Log data (IP address, access times, error reports)
- Location data (when you enable location services)

### AI Processing Data

- Input data you provide for AI analysis
- AI-generated insights and recommendations
- Usage patterns to improve AI performance

## How We Use Information

We use collected information to:

- Process AI analysis and generate insights

- Improve and personalize the Service
- Ensure security and prevent fraud
- Comply with legal obligations

## Information Sharing
