

# Early Sandy Hook

#### Once a completely forested minimountain, pushing cool, green glades into Sechelt Inlet


1962 - Capilano Highlands promotes a free bus trip from Vancouver to promote sales of its lots for a few dollars each.

First lote sold on Coracle Drive waterfront and west end of Sandy Hook road.

"Utilities"-fireplaces; wood stores; gas lamps; shallow well system; miserable dirt and gravel roads, almost impassable after rain.

1967 - area below Sandy Hook Road completely clearcut by Diock Bros.; beautiful escendgrowth forest gone; now an ugly wasteland, "much to everyone's diagust," says local ploneer.

Highlights back then — welcome escape from city to land of minimal taxes; plentiful fish; beautiful vistes, leafy canopy, sandy beaches — life in harmony with nature.



### District and Neighbours United

For 20 years the Sandy Hook Community Association (SCHA) has worked to improve our rural, forested neighbourhood.

Now, the SHCA is working to save the Sechelt Heritage Forest. This 55-acre tract stands as the only natural buffer between Sandy Hook and heavy residential development slated for adjacent areas.


The Forest is owned by the Province of British Columbia, but lies within the boundaries of the District of Sechelt.

Over 100 Sandy Hook families signed a petition to present to the Ministry of Forests and the District of Sechelt Council.

in June, 1993, the Sechelt Council voted unanimously in favour of our proposal and forwarded a request to the Ministry of Forests for transfer of the Forest to the District.

SHCA has given its commitment to the District of Sechelt to maintain the simple trail through the forest.

SHCA has included the Sechelt Heritage Forest project in Sandy Hook's submission to the Official Community Plan. Our plan also addresses other issues related to preserving the environment, while allowing for future development.




#### The Secrets of the Forest

Our small forest guards many secrets. We brought in experts in the natural sciences and asked them to tell us what they found. They confirmed what we suspected: we are living beside a treasure trove - a forest that supports rare mosses, a variety of ferns, ancient trees (one over 8 feet in diameter), a pond fed by a trickling stream. It's a fragile ecosystem that shelters birds, bear, deer and even cougar.





# Mountain Bikes in the Forest: The Board of Directors' Position

During the discussion of our recreation needs which followed the June annual general meeting of the Sandy Hook Community Association, the question of whether mountain bikes should be permitted in the Sechelt Heritage Forest was considered. It was eventually agreed that the SHCA board of directors would consider the opinions which had been expressed at that meeting and would invite, through our newsletter, those Sandy Hook Association members who were not there to express their views also.

The board discussed the mountain bike question at some length at its August 22 meeting. It concluded that:

- The leadership that saved the Sechelt Heritage Forest from being clearcut, and persuaded the Ministry of Forests to designate it as a passive recreation forest, founded their arguments on the unique ecology of the forest — its rich, diversified fern species, samples of old growth trees, the shelter it provides for wildlife —and they gave assurances that these characteristics would be preserved. We feel obliged to honour that commitment.
- Because the trails in the forest, built by volunteers, were intended for walking and were not designed to accommodate multiple uses, their use by mountain bikers could substantially damage the forest's sensitive ecosystem.

- Rapid mountain bikes, speeding on trails without any warning device, would present a substantial hazard to slower pedestrians, children and pets; they would create anxiety and discourage those with the fewest recreational opportunities.
- 4. A relatively few mountain bikers could disproportionately disturb the quiet and serenity which the substantially greater number of walkers come to the forest to enjoy. (This consideration will become even more important when the areas adjoining Sandy Hook complete their planned development, and many new residents join us in wanting to refresh their spirits in the only bit of wilderness on the east side of Porpoise Bay.)
- There are many excellent nearby locations <u>outside</u> our small Sechelt Heritage Forest where mountain bikers can enjoy their sport.

#### Re: Trails in the Sechelt Heritage Forest

Thank you for informing us, through Gertrude Pacific, about the need for a formal communication regarding our plans for trails in the Sechelt Heritage Forest.

Enclosed please find a map showing the progress to date, and the proposed new trails.

Last year we hired Michel Frenette for one day to flag new trails for us. In the future, we plan to extend the existing trail east to eventually join up with Inlet Road. Members of the Sandy Hook Community Association will provide the volunteer labour and tools.

Also, we plan a new entrance to the forest from Forest Road, the only legal access to the forest from the Sandy Hook side. We asked the District of Sechelt for monetary assistance to build a wooden stairway down into the forest. We made a formal presentation to the District, with Board members Jim Ettinger, Michael Davidson, Gertrude Pacific and me, showing maps and a stairway plan to the Councillors and Mayor. (The stairway design was taken from your ministry's published information on trailbuilding.) Council approved our request and have given us a check for over \$300 for materials. Again, our community members intend to provide the tools and labour.

We hope these plans prove acceptable to the Ministry of Forests. The Sandy Hook Community Association Board of Directors would be delighted to take note of any suggestions you might have to improve our plans. If you feel there is a need to visit in person, we would be happy to show you the Sechelt Heritage Forest (although our work to date is so careful and uninvasive that you would not notice much difference) and to take any advice you might offer.

Please accept this letter as a request for approval. If any further information would be required, we would be pleased to forward it to you.

Thank you for your continuing interest in our efforts to protect the Forest.
