Highlights from RM Meeting

43.2020 UNGER/STEPHENSON

MOTION: That the new bylaw for the Hamlet should contain the "No person in the Hamlet of Neuanlage may have more than 12 chickens, they must be contained in a 24 hour containment at least 20 feet from neighbours property line. The chickens must be hens and no roosters"

The second proposed bylaw should allow for one shipping container in a way that is fair to those property owners who have been forced to comply with all regulations when constructing permanent storage structures, and secondly, to ensure all Provincial Legislation and SAMA assessment regulations are adhered to. With the stipulation that they are no more than 40 feet in length, there are aesthetically pleasing in appearance, on a foundation or cement pad, at the rear of the property permitted as they will be assessed and taxable.
