



BYLAW 5.2021

RURAL MUNICIPALITY OF ROSTHERN NO. 403 ZONING BYLAW AMENDMENT

A BYLAW OF THE R.M. OF ROSTHERN NO. 403 IN THE PROVINCE OF SASKATCHEWAN TO AMEND BYLAW NO. 5.2008 KNOWN AS THE ZONING BYLAW.

The Council of the R.M. of Rosthern No. 403 in the Province of Saskatchewan in open meeting hereby enacts as follows:

1. That Section 1.5 1 of Schedule C: Country Residential 1 District (RA1) be replaced with the following:

1. Within the RA1 Zoning District, the equivalent of 0.5 animal units shall be permitted per acre within the East ½ of Section 23-40-04 W3M. No keeping of livestock shall be permitted within the West ½ of Section 24-40-04 W3M. That for the sake of this Zoning District RA1 animal units and location will exempt chickens which is addressed in Section 1.5 3 of this RA1 Zoning District.

2. That Section 1.5 2 of Schedule C: Country Residential 1 District (RA1) be replaced with the following:

2. Animals shall not be pastured within 15 m (50 ft.) of any dwelling or well not owned by the owner of the animals, and no buildings or structures intended to house these animals shall be located within 30 m (100 ft.) of a dwelling or property line. That for the sake of this Zoning District RA1 animal units will exempt chickens which is addressed in Section 1.5 3 of this Zoning District RA1.

3. That the following be inserted in Schedule C: Country Residential 1 District (RA1) immediately following 1.5 2:

3. Within this District (RA1) hens will only be permitted. No Person shall have more than twelve (12) hens at one location within this Zoning District (RA1). That the hens must be contained in a Twenty Four (24) hour containment at least Twenty (20) feet from any owned dwelling or structure and Twenty (20) feet from the property line.

4. That the following be inserted in Schedule C: Country Residential 1 District (RA1) immediately following 1.1 7:

1.1 8. Storage Structure

5. That the following be inserted in Section 3.42 immediately following 3.42 (d):

e) Within the Country Residential 1 District (RA1) all above conditions apply and in addition the Storage Structure be placed on a permanent foundation as an accessory building and use. That they be no more than Forty (40) feet in length.

Coming Into Force

6. This Bylaw shall come into force on the date of final approval by the Minister.
