Tech Info Cards

ProTech Cards identify and verify the techs working on-site. Each card includes the tech's name, photo, and key details, ensuring proper identification and compliance.

Why They Matter:

• Verify the right person is on-site, build client trust, and protect against disputes.

They are Required:

 Every tech must have an active card before starting service, and updates are required for staff changes.

How to Get Them:

 digitally and can be printed if needed.

Step 1: Visit Our Invoice Portal


- All vendors must submit invoices through www.proalert.ai/invoice.
- Invoices can only be submitted after the month of service is complete.

Step 2: Invoice On Time Every Time

- To ensure on-time payment, invoices must be received no later than the 10th of the following month.
- Late submissions may result in delayed payments.

Step 3: Get Paid

 Following this process helps us confirm services, maintain accurate records, and pay you promptly.



ProRFP Payment You've got options:

Net 60 - No cost

The standard payment schedule for most vendors, offering a reliable two-installment cycle without additional cost.

Net 45 - 5% fee

An accelerated option for vendors who want earlier access to funds, with a one-time 5% fee deducted per invoice.

Sole Proprietor - No cost

For very small, non-incorporated vendors (1–2 people) who qualify for ProRFP's fastest, twice-monthly payout schedule.





- Select "Business" account type (no subscription fee).
- Verify your bank with BILL's test deposit.



Step 2: Get Your Payment Network ID (PNI)
