## Stud Dog Contract

This is a breeding agreement between Allison Bagley (Puddledock Pups) (stud owner) and \_\_\_\_\_ (bitch owner) for the breeding of "\_\_\_\_\_" (stud dog) to \_\_\_\_\_ (bitch).

Allison Bagley (stud dog owner) enters into this contract to enable the bitch's owner to produce healthy puppies in both temperament and type, which will be good representatives of (breed). With this in mind, the following sections are included in this stud contract:

### Section A—The Bitch

1. The bitch should be in good physical condition.
2. The bitch should have a good temperament.
3. The bitch is a Kennel Club registered dog, the bitch owner must provide the Stud dog owner with a copy of the bitch's three (minimum) generation pedigree, a copy of the bitch's Kennel Club registration and all health certificates/DNA tests.
4. The bitch owner warrants that the bitch has not been bred to any other male dog from the start of her heat cycle, and that utmost care will be taken to ensure that she is not bred to any other male dog during this heat cycle.
5. The bitch owner shall provide any special instructions, medication and food, if necessary, for the wellbeing and care of the bitch, should the bitch stay with stud dog owner.

### Section B—Charges

1. The stud deposit of \$ 750.00(half cost of stud fee) cash to be paid, and two copies of this agreement signed (one for stud owner, one for bitch owner) immediately prior to the first mating. The stud deposit is non-refundable.
2. Two or more live puppies constitute to a litter.

3. If the bitch fails to whelp (give birth) to at least two live puppies, a free stud service will be provided to the original bitch at a time agreeable to both parties, as long as the bitch owner notifies stud dog owner within fourteen days after the scheduled whelping that no puppies were whelped. In the event that the bitch changes ownership, there is no obligation on the part of the stud dog owner to provide a repeat service.
4. If after a third, free mating, the original bitch again fails to whelp, the stud dog owner will offer the services of the stud dog again, only after the bitch has undergone examination by an independent veterinarian and declared fertile. Servicing to the bitch will then occur for up to 1 year after the initial mating date at each bitch season until a litter is produced (definition above) or one year passes.
5. The bitch may remain at stud owner's residence for three nights free of charge. Any extra days stay will be charged at \$20 per night, with all fees to be paid prior to taking the bitch home.
6. The stud fee shall not be refunded, in whole or in part, for any reason, except as specifically provided for within this contract.
7. It is specifically agreed that (stud owner) is not required to sign the application for kennel club registration of a resulting litter until such time as all expenses and stud fees are paid in full.
8. **The stud fee for (stud dog) is \$1500. This sum includes that of the deposit paid prior to mating.**
9. The stud owner reserves the right to have the pick of the litter in lieu of stud fee. But the deposit WILL BE RETURNED to the bitch's owner.

### **Section C—Puppy Placement**

1. Every effort must be made to place puppies in sound and secure homes, and no puppies shall be released to their new owners before the age of eight weeks post whelping.
2. No puppies from this mating are to be knowingly offered for sale to or through any pet shop, animal wholesaler, broker or via auction or as part of prize or raffle.
3. All puppies will be sold with a written contract, which states that the bitch owner and stud owner agrees to assume responsibility for any resultant pups for their lifetime, and agrees to accept any puppy that is returned, to be kept or else resold to a suitable home.
4. All puppies MUST be registered with the kennel club, whether they are sold on to new owners or kept by the bitch's owner or is to be used in lieu of payment to the stud dog owner.
5. All puppies from this stud are to be sold on LIMITED registrations unless prior written approval from stud owner (Allison Bagley) is included in this contract.

### **Section D—Other Terms**

1. All veterinary charges will be the responsibility of the registered owner of the bitch.
2. The owner of the bitch hereby releases from responsibility (stud owner) from any and all liabilities and /or damages to the said bitch whilst she is being mated, or within her care.
3. A copy of stud dogs pedigree, health clearances and registration will be given to bitch owner upon signing this contract.

Any further conditions or agreements will be noted and initialled and dated by both parties in the space below:

This contract contains the entire agreement of both parties, and shall be construed and enforced in accordance with the law.
