HMEE SWIMMING POOL REGULATIONS

- 1. Pool hours: Dawn to Dusk.
- 2. Use pool at your own risk at all times.
- 3. Everyone must take a shower before entering.
 - 4. Do not swallow the pool water.
- 5. No under 16 years old may enter the pool without an adult present.
 - 6. No glass or breakable containers allowed.
 - 7. No inflatable rafts, no floating chairs or balls.
 - 8. No running, no diving, no jumping, or doing flips.
 - 9. No animals allowed.
 - 10. No food or drink on the pool wet deck or in the pool itself.
 - 11. Any person having longer than collar length hair must be tied.
 - 12. Toddlers must wear waterproof swim diapers.
 - 13. Please roll down umbrella and place chairs after use.
 - 14. Do not place any personal objects on the pool fence.
