# 常见问题

## 取得绿卡后多久 登陆一次?

绿卡持有人离开美国不得超过6个月。如果每次快到6个月的时候返回美国，这样做虽然符合美国移民监的要求，但是如果长期如此美国海关人员有理由怀疑您没有长期居住意向而要求您放弃绿卡。因此对于不能居住美国的申请人来说，最好能证明有长期居住美国的打算，比如，美国购房、美国驾照、申请美国信用卡、子女美国读书、按期报税、购买保险等，一旦海关盘问，出示这些证据将会避免被刁难。

## 超过6个月没登陆 会被取消绿卡吗?

如果您在持有美国绿卡期间，超过1年不打算返回美国，那么可以提前申请回美证，有效期为2年，在有效期内返回美国就可以避免绿卡被取消的风险;回美证到期后可以回美国申请延期，如果您在过去5年内，超过4年都居住在美国以外的国家，您再次申请回美证延期时，批准有效期为1年。
