# Reasons to Join TOSHA

Our HOA is solely dependent on voluntary dues funding and volunteer labor. This means that TOSHA can only be effective if it enjoys the full confidence and support of all residents.

TOSHA, a non-profit corporation, provides a means for furthering the interest of all Top of Skyway residents. Its objectives include:

- Promoting the health, safety & welfare of all residents
- Preserving & protecting subdivision quality, value, desirability & attractiveness through enforcement of covenants
- Protecting residents' homes, property & wildlife through education & wildfire mitigation programs
- Enhancing neighborhood communication with social activities & opportunities

Some benefits of joining TOSHA include voting in Board elections and on TOSHA-related matters, serving as a Board member and/or Architectural Control Committee (ACC) member, free admission to the annual summer picnic, receiving a copy of the neighborhood directory and a voice in promoting the safety and well-being of all residents. And finally, through our email database, being able to notify residents of critical occurrences such as criminal activity, fire in the area, wild animals sightings, etc.

If you expect your neighborhood to remain the haven it was when you purchased your home, a commitment is expected from all 249 property owners. In 2019, only 99 residents joined TOSHA. The Board/ACC is tasked with upholding the bylaws and enforcing the covenants and needs a commitment from all homeowners. Without a controlling body, homeowners will be left to ignore the covenants and do what they may with their property. When there has not been an active Board/ACC, homeowners have made changes to their property that were in violation of their covenants.

#### Reminders from the ACC

As a friendly reminder, all Top of Skyway residents are required to seek ACC approval prior to beginning any major exterior residential modifications (application approval form attached). Adherence is a legal requirement and applies to all residents, regardless of membership status or individual desire. Approval is required, but is not limited to:

- New home construction or home addition
- · Major landscaping remodeling or implementation
- · New or remodeled decks, patios, walkways, driveways or fencing
- Changes to existing roofing materials, exterior paint color, stonework, gutters
- Solar panels

### Bear Management & Resistant Trash Ordinance

Colorado Springs City Council adopted two ordinances to help manage wild bears in neighborhoods west of I-25. This includes Top of Skyway. As of March 1, 2020, the ordinances require residents and businesses within the bear management area to secure their trash within a functioning bear-resistant waste container or within a secured structure at all times. To accomplish this:

- Secure trash in a garage, shed or other secure structure. Trash bins should only be outside of the secure structure on trash collection days from 5:00am to 7:00pm. The majority of homes will already meet this requirement with standard practices.
- For those who cannot store their trash in a secured structure, they will need to obtain a bear-resistant trash bin. Certified bear-resistant waste containers can be provided by your trash collection company, or you can purchase your own certified trash bin.

Recycle bins are exempt from this requirement.

#### **Enforcement and fines**

Complaints of bear activity in a neighborhood due to unsecured trash will be investigated, and should a violation be substantiated, a written notice, order and assessment of administrative fee(s) to the owner or agent of the owner and occupant shall be issued. Citations will be in writing and personally served whenever feasible to the owner, agent of the owner and/or occupant of the premises. The Neighborhood Services Division seeks compliance through education and will endeavor to help remedy the situation before issuing fines for noncompliance.

The cost of citations are as follows:

- First violation \$100
- Second violation \$250
- Third and subsequent violation \$500

#### **Garbage Kills Bears**

It may sound dramatic, but it's true. A bear that is food-conditioned will always come back for a handout...and if it happens to be a residential neighborhood or commercial area, that's a problem for both bears and humans. For residents in bear country, putting trash out only on the morning of pick-up cuts the chances of a bear visit from 70% to 2%.



## New Water-Wise Rules from Colorado Springs Utilities

CSU adopted permanent water-wise rules for landscape watering to support the smart use of water in our community. City Council approved the new ordinance at the December 19, 2019 meeting and the ordinance is now in effect.

Key changes impacting customers include:

- I. Watering with sprinklers is limited to any three days of your choice per week.
  - From May 1 to October 15, sprinklers can be operated before 10 AM and after 6 PM. Sprinklers can be operated at any time of day before May 1 and after October 15.
  - Water allocation plans are available for customers who need more watering

- schedule flexibility. More information will be available April 1.
- Drip irrigation, watering cans and hose watering with a shut-off nozzle are allowed at any time.
- Establishment permits are required for customers who need to temporarily water more than three days a week to establish new landscapes.
- 3. Broken or leaking sprinkler systems are required to be fixed within 10 days.
- 4. Water runoff from irrigation flowing across the ground, street or sidewalk is prohibited.
