NAACP Oconee Branch Executive Board Hosts Information Sharing Meeting with South Carolina Legislators

On Tuesday, May 13, 2025, the NAACP Oconee Branch hosted an information-sharing meeting featuring South Carolina Senator Thomas C. Alexander (SC 1st Senate District) and South Carolina Representative Adam L. Duncan (SC House District 2). The meeting, held as part of the branch's ongoing efforts to foster dialogue and collaboration between elected officials and the local community, provided a platform for discussing key issues affecting residents in the area.

The discussion focused on a range of important topics, including education reform, healthcare access, economic development, and social justice initiatives. Committee members had the opportunity to ask questions and voice their concerns directly to the legislators, creating an open forum for constructive dialogue.

Senator Thomas Alexander emphasized the importance of maintaining active communication with constituents, stating, "Engaging with community organizations like the NAACP is vital to addressing the challenges we face and ensuring that every voice is heard." Similarly, Representative Adam Duncan highlighted the value of such meetings in shaping policy decisions that reflect the needs of the community.

The meeting was well attended by NAACP Board members, committee chairpersons, and a limited number of residents who expressed their gratitude for the opportunity to engage directly with their representatives. The NAACP Oconee Branch President (George Anderson) reiterated our commitment to continuing such initiatives to strengthen the relationship between policymakers and the people they serve. The following are high points of the topics discussed.

Opposition to the elimination of Diversity, Equity, and Inclusion (DE&I) efforts reflects the organization's commitment to fostering environments where all individuals, regardless of race or background, can thrive. DE&I initiatives are vital in addressing systemic barriers and promoting fairness across institutions, including workplaces and educational settings. Also emphasized were the real reasons behind the initial implementation of DE&I and the need to ensure that something is in place to ensure that those original objectives are achieved.

The question was posed, if not DE&I, then what will take its place?

The attempt to dissolve the Department of Education by the federal government has sparked calls for comprehensive education reform. The NAACP underscores that dismantling this critical institution would jeopardize equitable access to education, disproportionately impacting underserved communities. Advocacy for preserving and strengthening federal oversight of education remains paramount in ensuring that future generations have access to quality learning opportunities. Concerns were expressed that without replacement funding for the federal monies lost, it would be hard to maintain the current educational standards.

Economic justice remains a cornerstone of the NAACP's mission, and discussions around the need to support and pass minimum wage laws highlight the importance of financial empowerment. Increasing the minimum wage would alleviate poverty, reduce economic disparities, and provide a livable income for millions of workers, many of whom are from marginalized backgrounds.

Finally, the detrimental effects of citizens losing healthcare coverage due to resistance to Medicaid expansion are a pressing concern. The NAACP emphasizes that access to healthcare is a fundamental right, and the failure to expand Medicaid exacerbates health inequities,

leaving vulnerable communities without essential services. Advocacy for healthcare reforms that prioritize inclusivity, and accessibility continues to be a focal point in the organization's strategy for advancing social justice.

These discussions collectively represent the NAACP's broader vision for an equitable society, where systemic inequalities are dismantled and opportunities are accessible to all.

As the discussions concluded, both legislators pledged to take the insights gathered back to the state capital and work collaboratively toward solutions that benefit all South Carolinians. The Oconee Branch NAACP expressed optimism about the outcomes of the meeting and encouraged residents to remain active participants in the democratic process.
