

LOANER CAR AGREEMENT

- 1. I acknowledge that I am the only authorized driver of the vehicle while it is under my possession and will not lend and/or rent the vehicle to any other driver.
- 2. I acknowledge that the vehicle and all it's accessories (jack, spare tire, mats, etc.) are the property of West Edmonton Mall Toyota, and that I received the vehicle in undamaged condition except as noted below.
- 3. I agree to return the vehicle to West Edmonton Mall Toyota with all accessories on or before the specified time and date, in the same condition as received.
- 4. I agree to replace all fuel used while the vehicle is in my possession. If the vehicle is not returned with the same amount of fuel an automatic refill will be billed to supplied credit card. Initial _____
- 5. I accept responsibility for all traffic violations incurred, moving or parking, while the vehicle is in my possession.
- 6. I agree to pay any fines incurred and authorize West Edmonton Mall Toyota Toyota to charge the credit card information provided below for said fines and late charges if applicable.
- 7. I understand that the vehicle is not to be driven outside the city without prior consent of West Edmonton Mall Toyota.
- 8. I accept responsibility for all damages and for West Edmonton Mall Toyota's \$50,000 deductible in the event my own insurance company will not cover said damages and deductible. Any damages to the vehicle (including windshield rock chips, door dents and paint scratches) is the responsibility of the driver. Initial _____
- 9. I understand that I have to pay \$39.95 per day plus a mileage charge if the vehicle is not returned on the due date, and that the car will be reported to the police as stolen.
- 10. All accidents must be reported to the police and West Edmonton Mall Toyota immediately and an accident report completed and submitted to West Edmonton Mall Toyota.
- 11. All authorized drivers must be 25 years or older and licensed; the renter is responsible for all damages suffered by West Edmonton Mall Toyota if the vehicle is used by a driver not authorized or if the vehicle is unavailable for rental due to damage or loss which is wholly or partially the responsibility of the renter.
- 12. I understand that the vehicle is non-smoking and animals are not permitted unless previously authorized. Should the vehicle require cleaning due to violation of this term or from excess wear and tear, I authorize West Edmonton Mall Toyota to charge my credit card for the cost of the cleaning service.
