### **Subject Control & Use of Force for COPS**

This course is designed to help keep Cops safer! This is NOT a “Train the trainer” class; Instead, the class will provide essential and valuable training directly to the Officers who will be using the skills. This course is specifically composed for Law Enforcement Officers, to equip them with the skills, knowledge and confidence needed to deal with resistive and combative subjects. It is critical for Officers to be able to physically control a resistant subject and use force reasonably in the course of police work. Controlling subjects quickly is a fundamental and necessary ability in L.E., which enables officers to be safer and use less overall force. This class will teach students takedowns using a blend of subject control concepts and principles along with realistic and effective techniques. The training will equip officers with tools and know-how which will drastically improve their ability to control resistant/combative subjects, keeping officers safer and reducing liability.

#### **COURSE INCLUDES:**

- Review of Case Law related to Use of Force.
- Concept and Principle Based Learning Methods.
- Instruction in Law Enforcement Techniques designed to effectively control resisting subjects.
- Review of Michigan Laws related to Subjects Resisting Police Officers.
- This course is taught by subject matter experts, including:
  - Law Enforcement Officer qualified as an expert witness in Use of Force and Verbal De-escalation, with courtroom experience testifying in Michigan.
  - Law Enforcement Officers who are certified use of force instructors who teach subject control, use of force and defensive tactics within their own agencies.
  - Instructors who work as Professional Coaches and Teachers in the private sector providing students with high-level Brazilian Jiu Jitsu training.
