

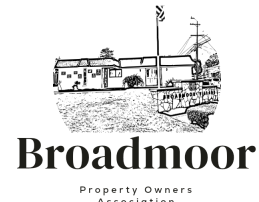

 - d. Coming up on the calendar - Pasta Dinner 4-8pm August 16th
 - i. Setup will be Friday the 15th and Midday Saturday if necessary
 - e. Monument repair
 - i. We need a mason or cement company to repair our monument
 - 1. We are having a difficult time finding a company or individual to come out and give us a quote
 - ii. There are concerns that a repair would be a temporary fix
 - 1. If the monument becomes too dangerous we may need to remove it
 - iii. If any community members have contacts that could come and take a look at the monument we would really appreciate it
 - f. Maintenance – landscape & building
 - i. Stove repairs underway. The front right burner has been disconnected temporarily for safety. The parts to repair the burner have come in and will be repaired soon.
 - ii. A tree on the property is interfering with the internet lines outside. We will request the regular gardener trim the tree for an additional fee.
 - iii. San Mateo County put some bags (possible bug traps) on the property. These will be left in place.
- 5. Police Chief Report (7:25)
 - a. There was one incident of kids jumping between roofs on 87th and Maddux. One police report was made about the incident. Request from Chief Connolly to report these incidents to the Broadmoor Police Department, not on Nextdoor.
 - b. An elderly community member had some jewelry stolen. The ruse involved putting a necklace on the victim while removing the victim's valuable jewelry.
 - i. Please report any similar incidents of crime.
 - c. Last month a raid was executed on Heather and Sweetwood. The Raid was executed by Stanislaus and Alameda County narcotics investigators. The target of the raid was involved in marijuana cultivation.
- 6. Town of Colma – ADU meeting (7:30)
 - a. ADU - Additional/accessory dwelling units
 - i. This can include converting a garage, adding an addition, and freestanding buildings

- ii. Additional units will increase property taxes, the assessment will be evaluated based on standard costs (independent of the cost to the homeowner)
- b. The Town of Colma gave a presentation on how to go about permitting and the construction of ADUs and guidance around them
- c. They also shared lots of tenants rights information in many languages for those interested in renting out ADUs
